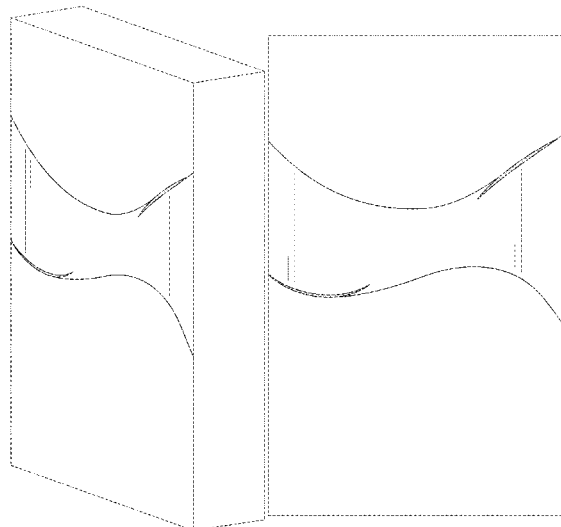
The ornamental design for an absorbent article package, as shown and described.

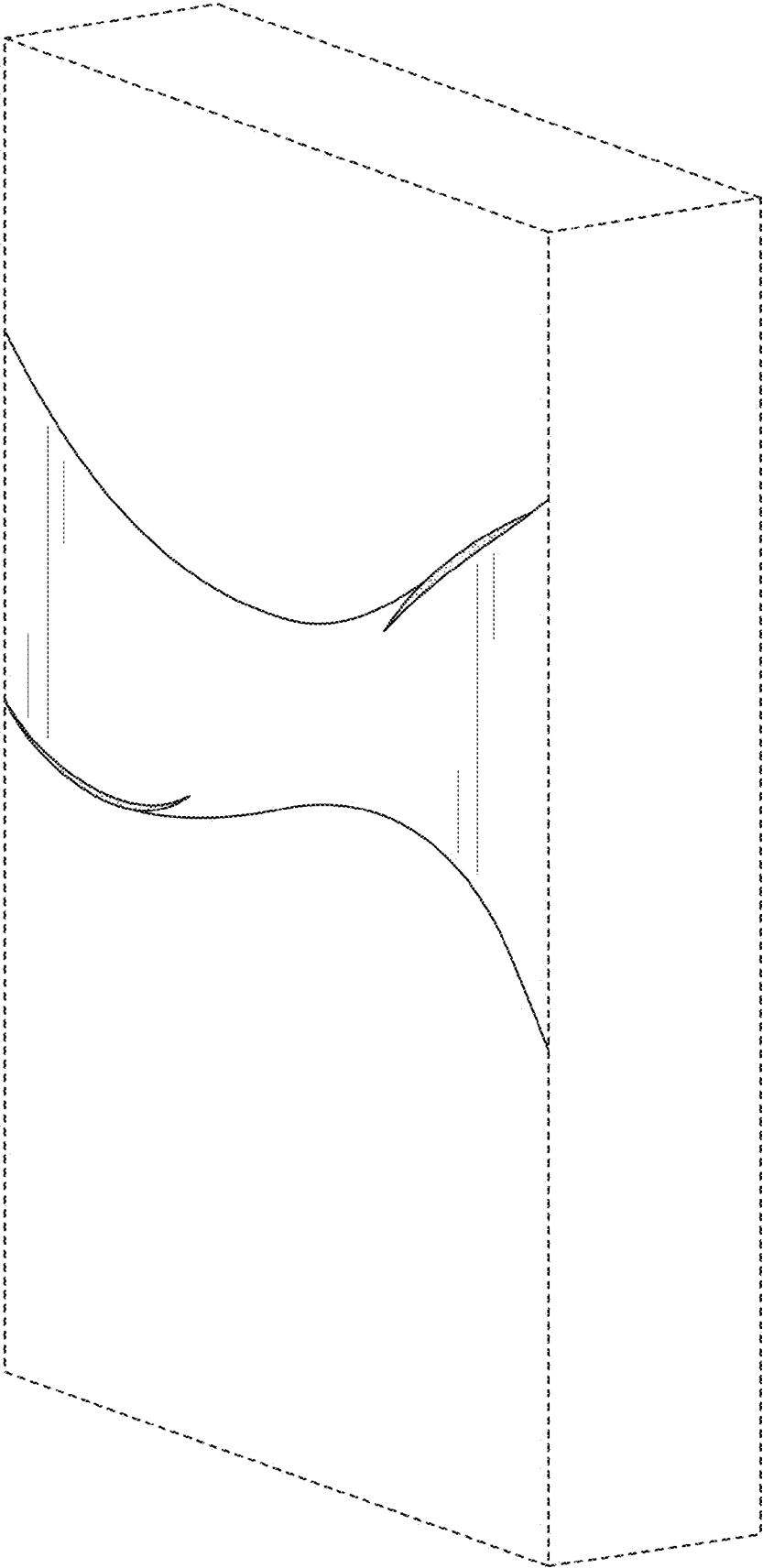

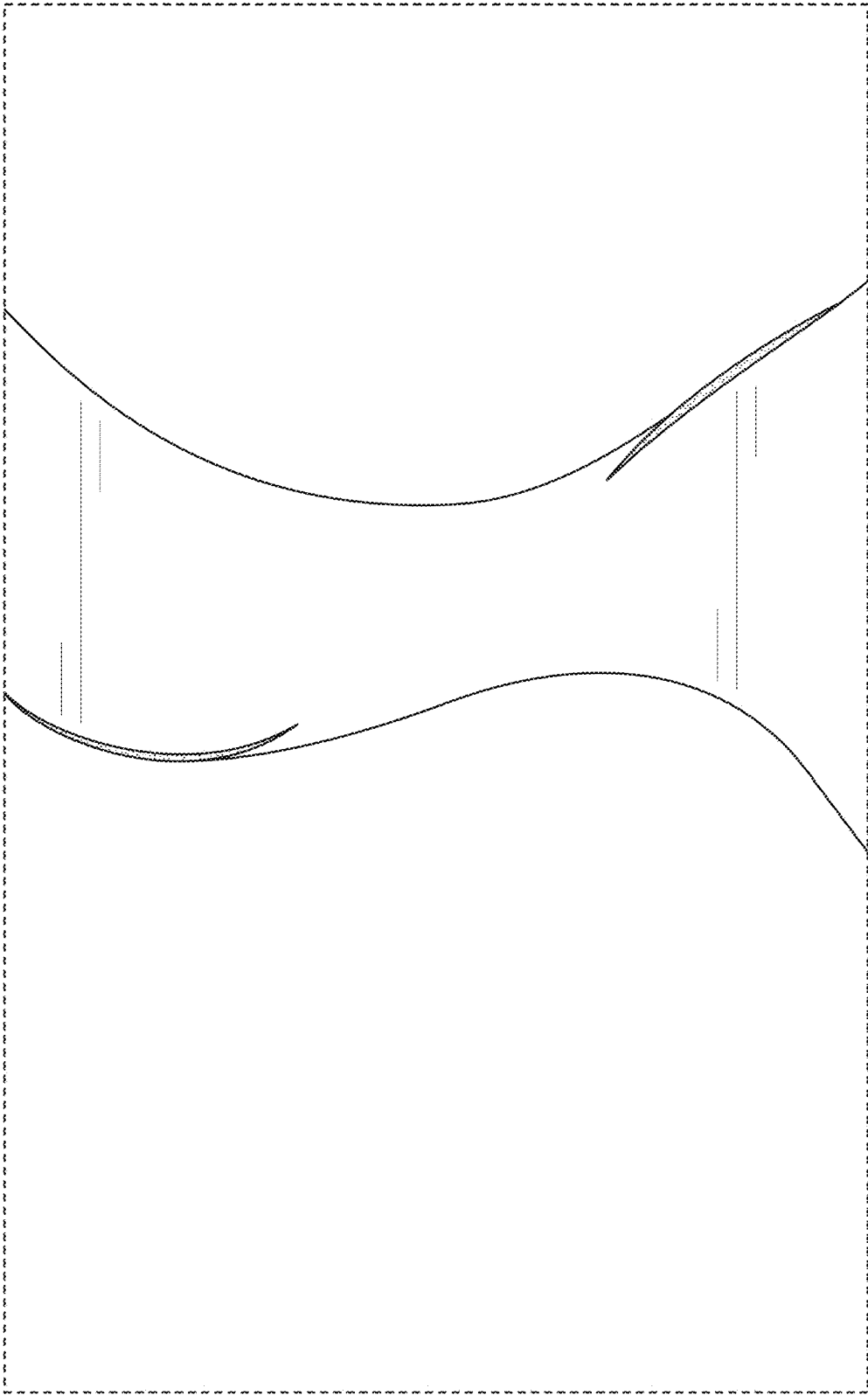

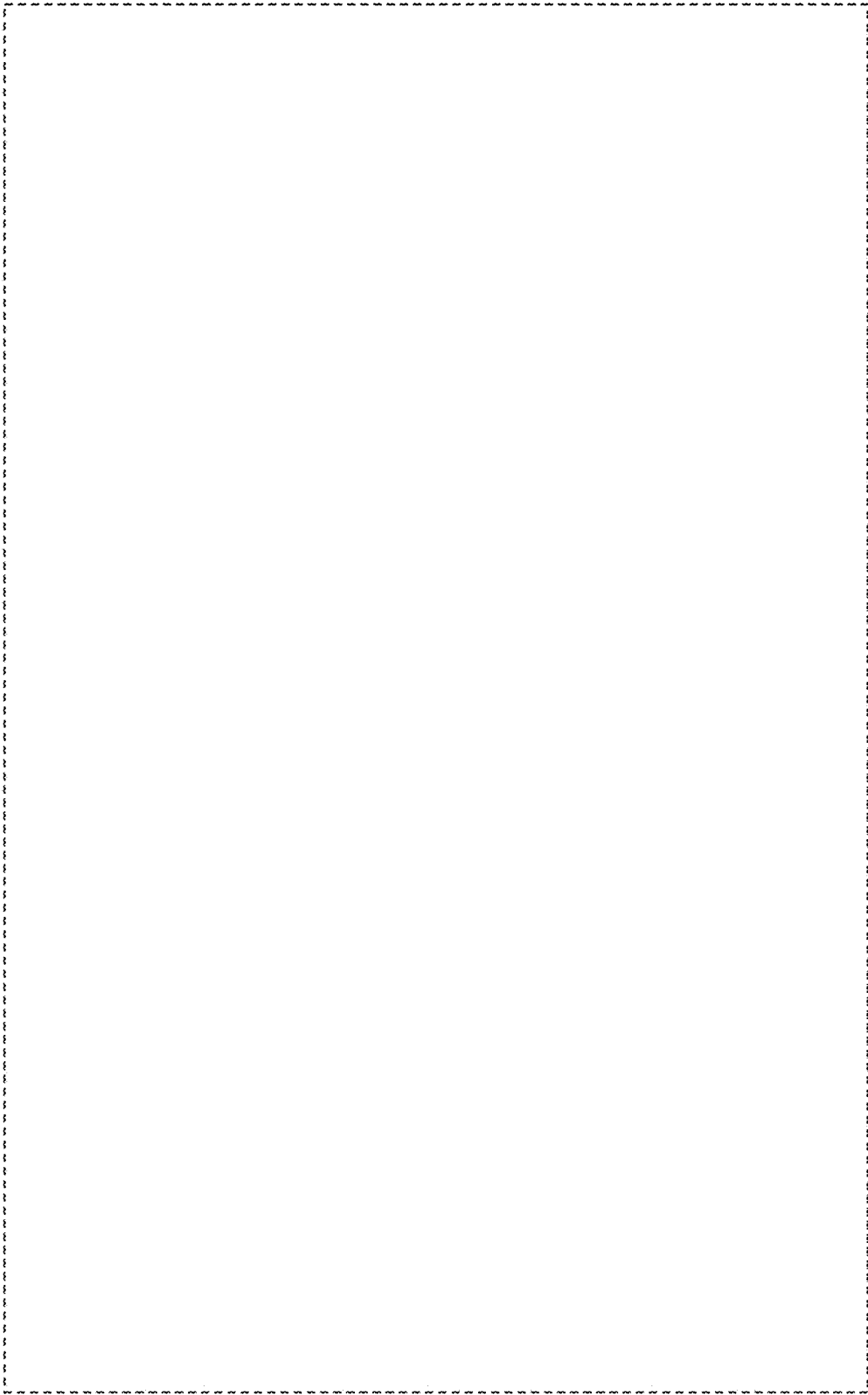

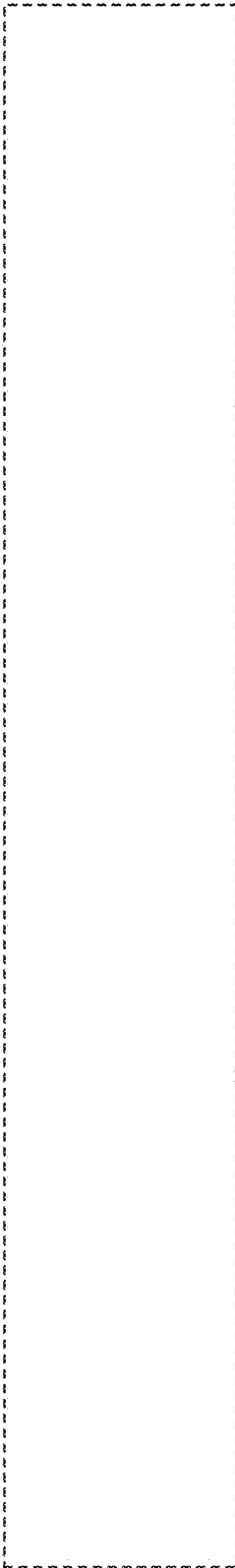
