FIG. 4 is a bottom plan view of the pendant;

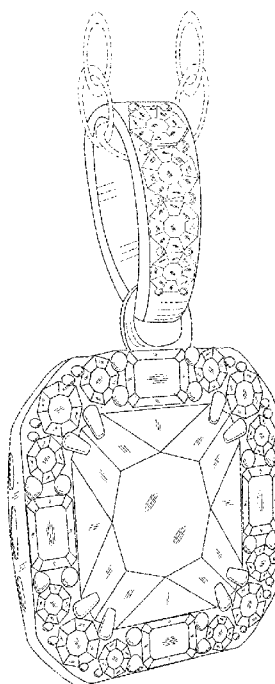
FIG. 5 is a top plan view of the pendant;

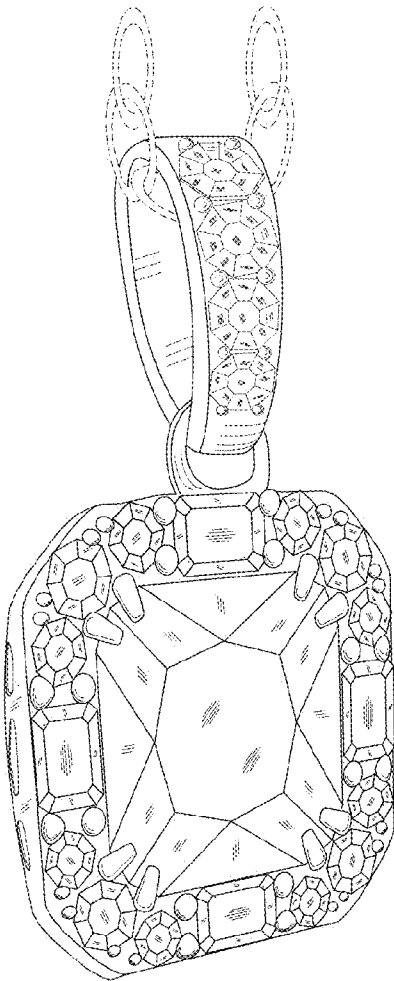

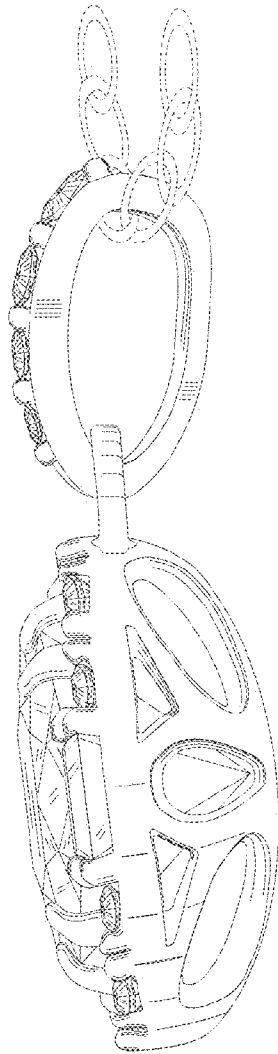

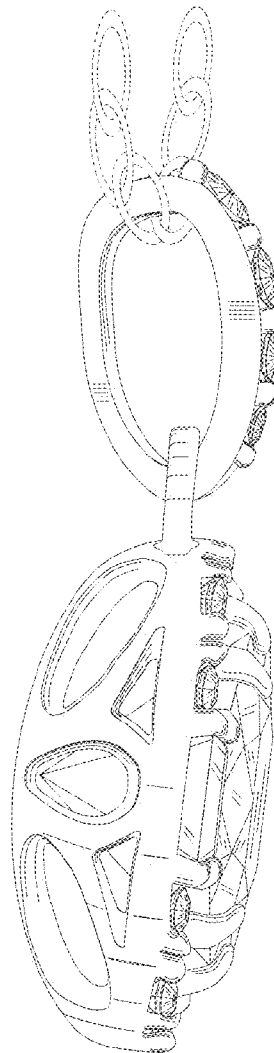

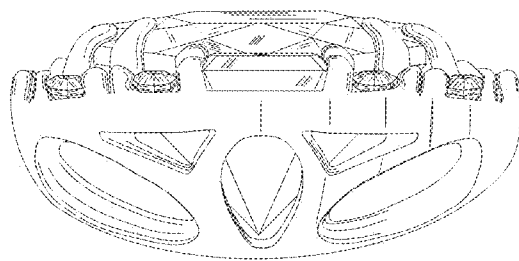

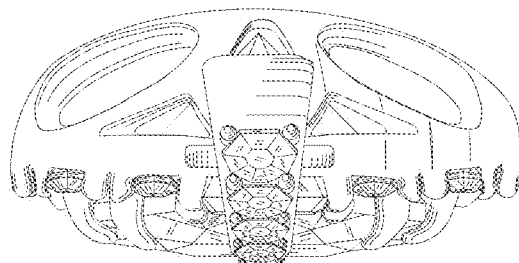

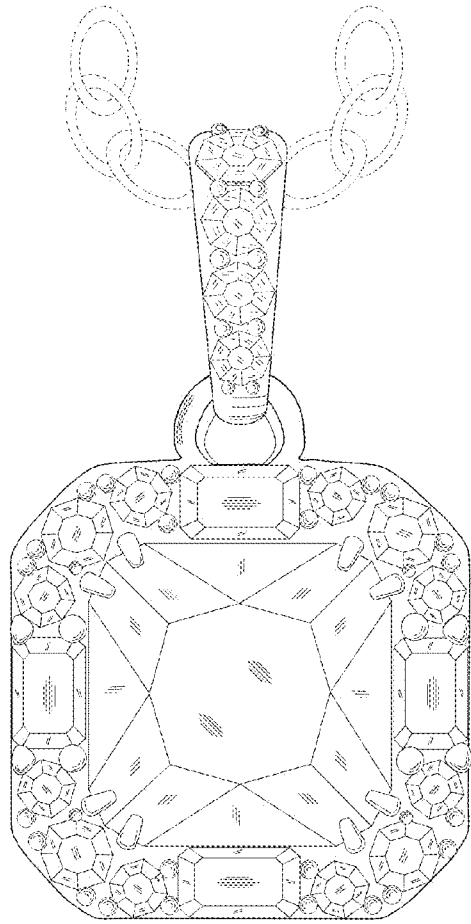

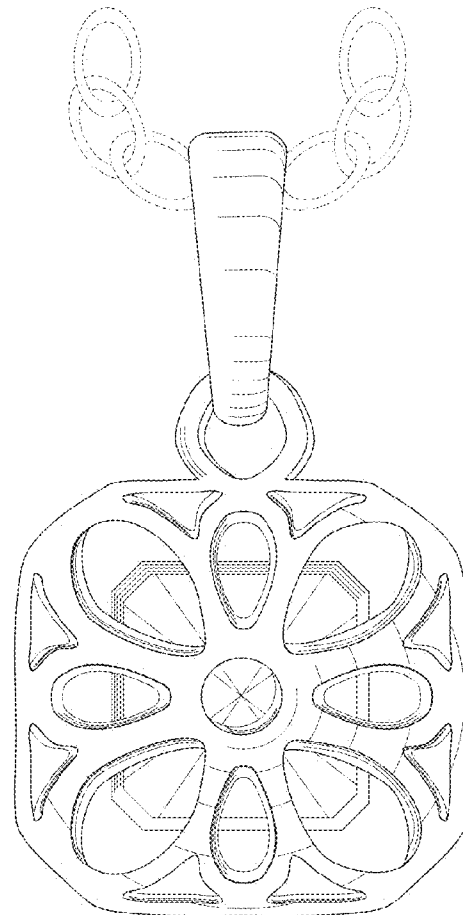
