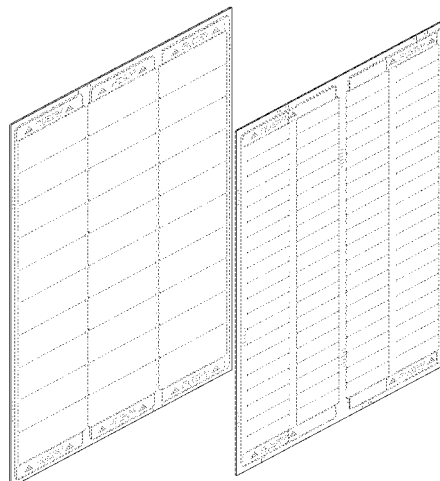
(57) **CLAIM**

The ornamental design for a label sheet assembly with raised tactile features, as shown and described.

The broken lines in the figures are included for the purpose of illustrating portions of a label sheet assembly with raised tactile features and form no part of the claimed design. The plurality of dots in six triangle shaped patterns along the header portion and a plurality of dots in six triangle shaped patterns along the footer of the label sheet are part of the claimed design. The text shown in dotted lines between the dotted triangles form no part of the claimed design.

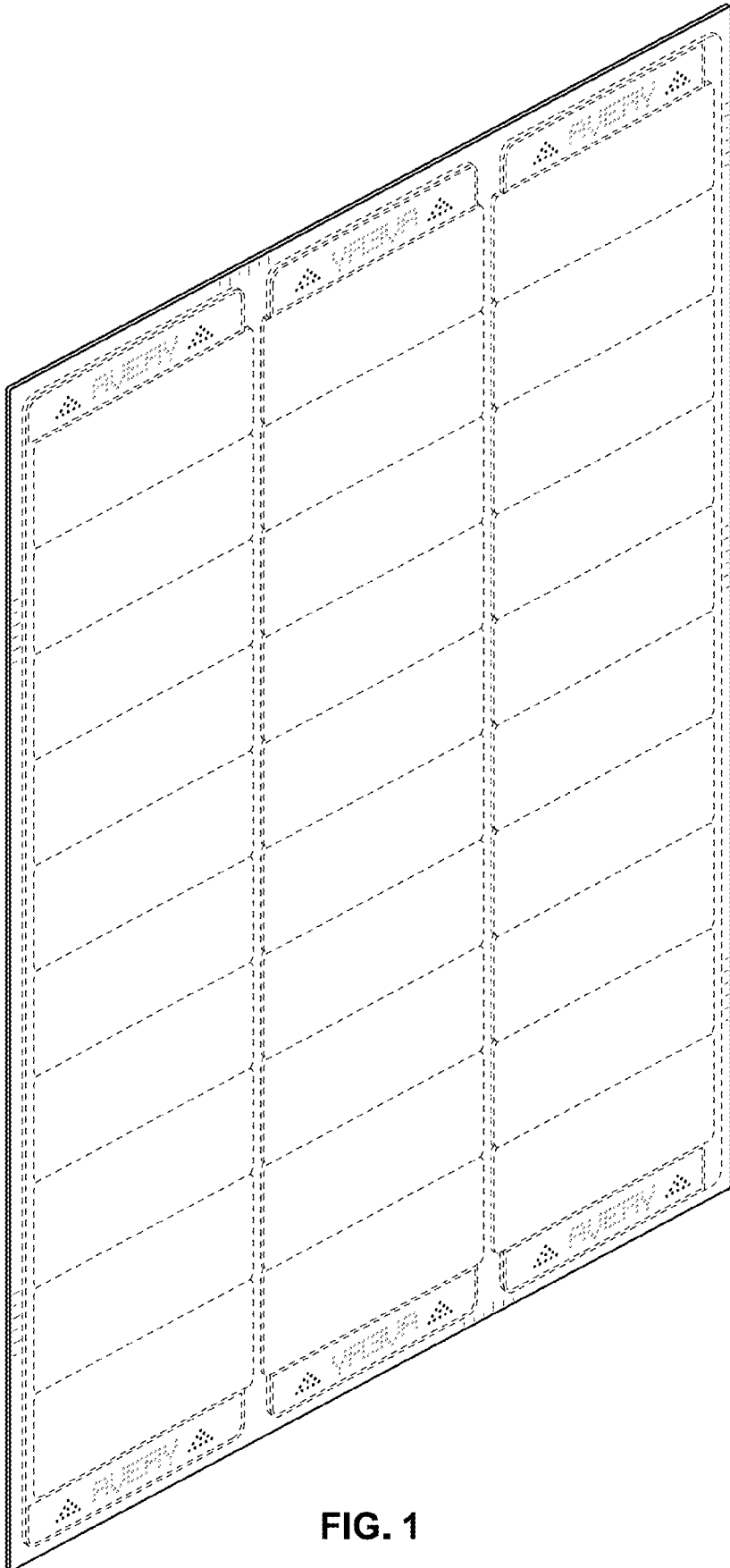

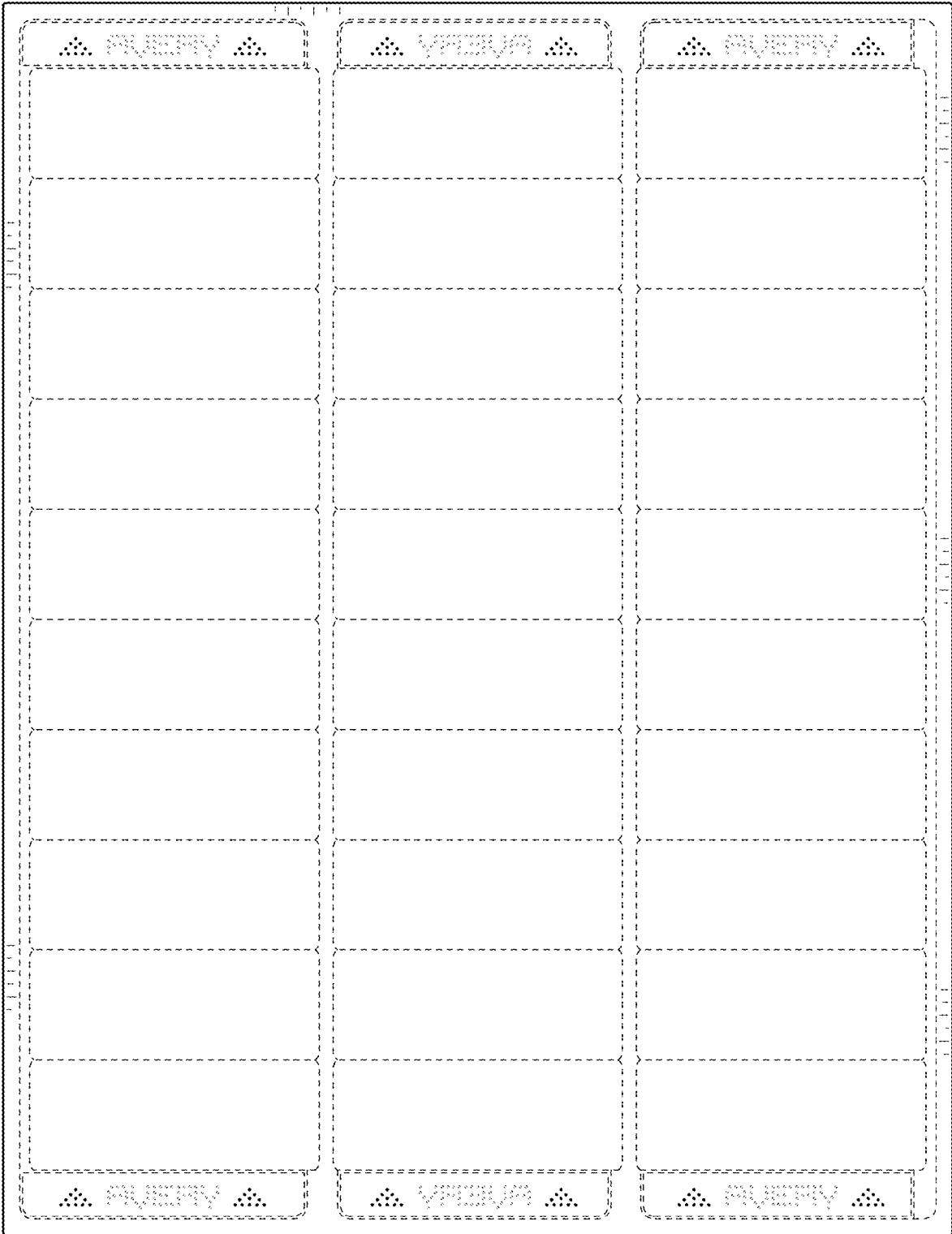

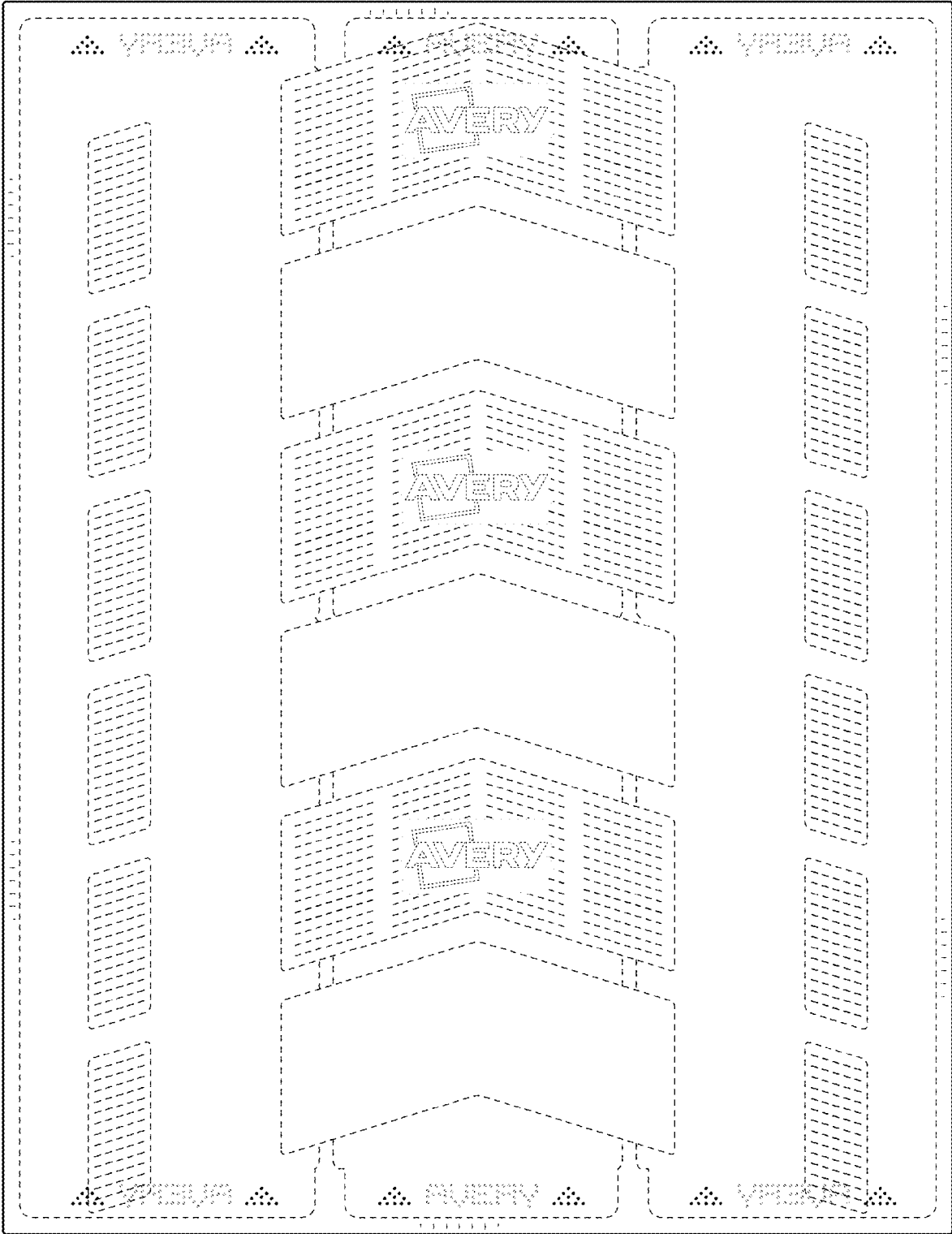

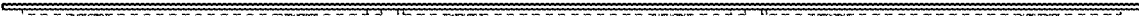

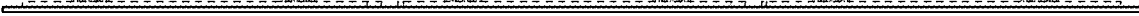

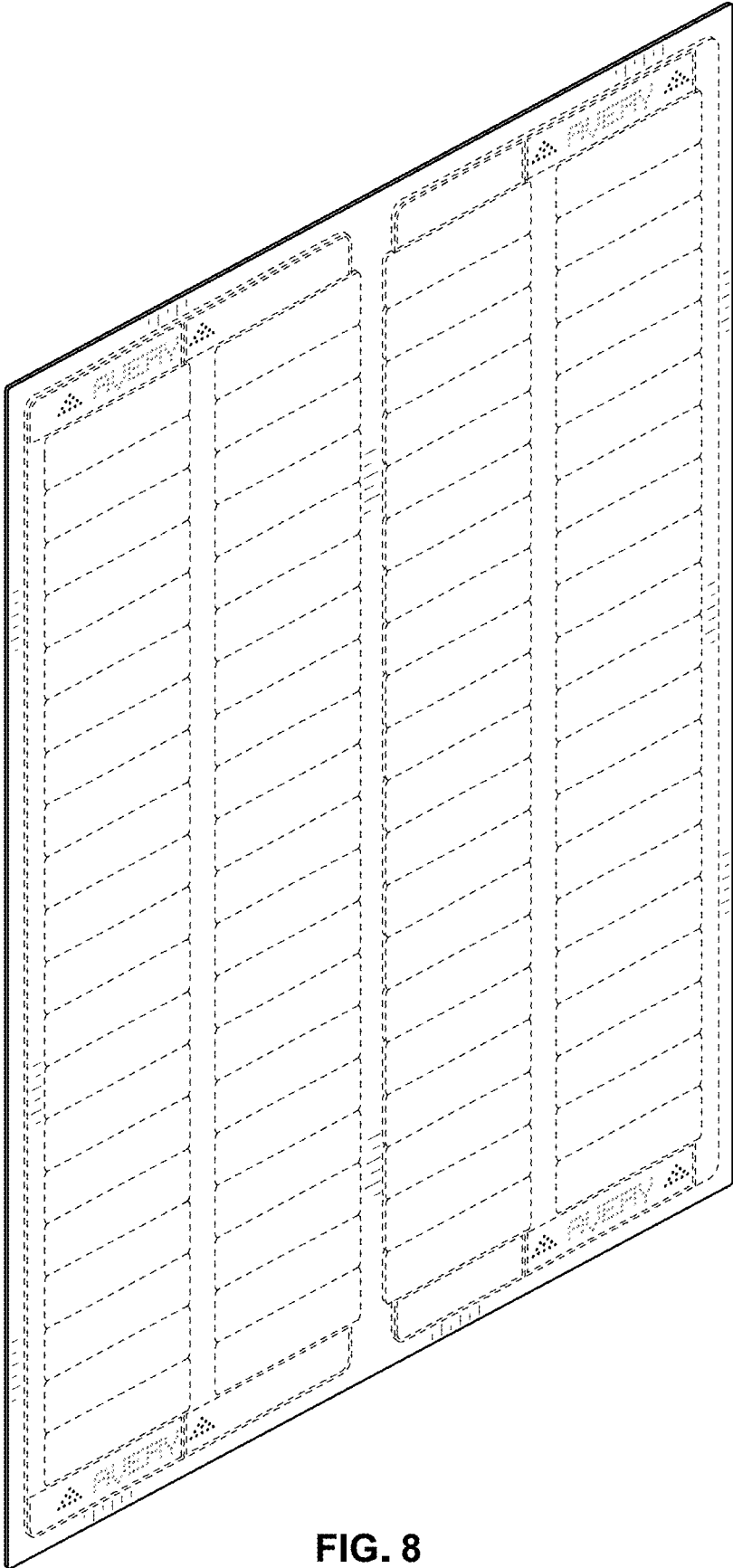

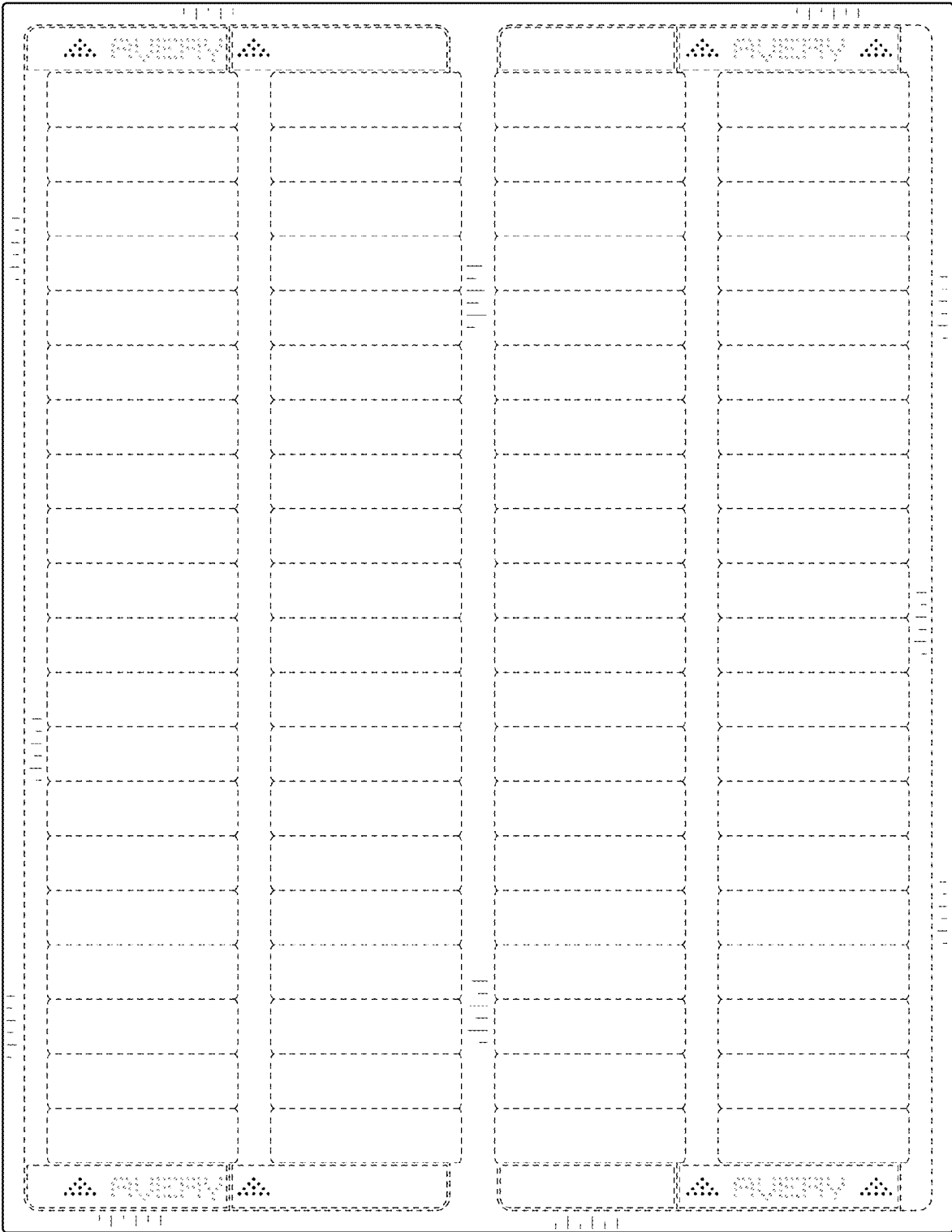

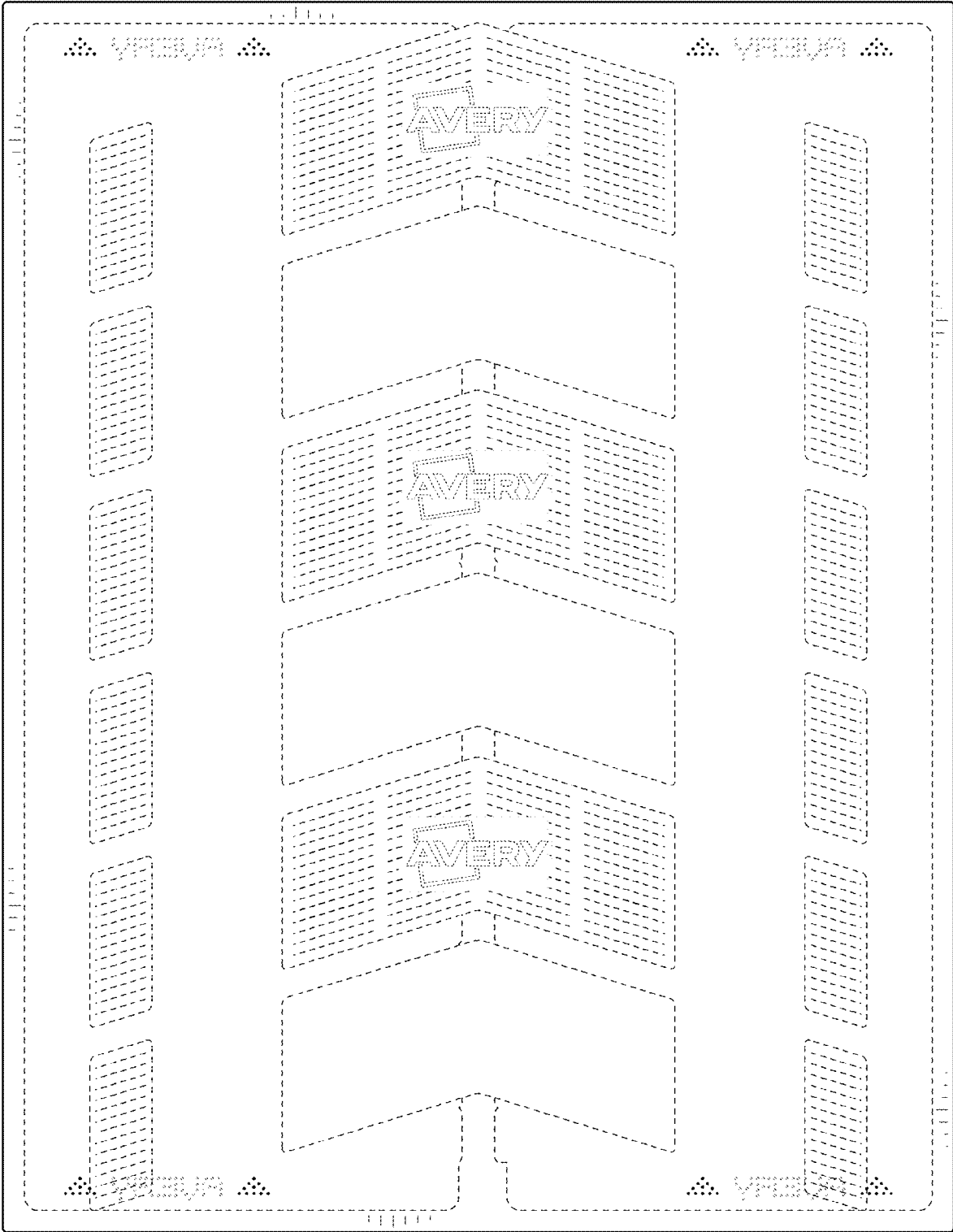

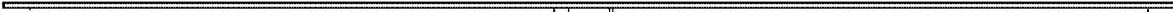

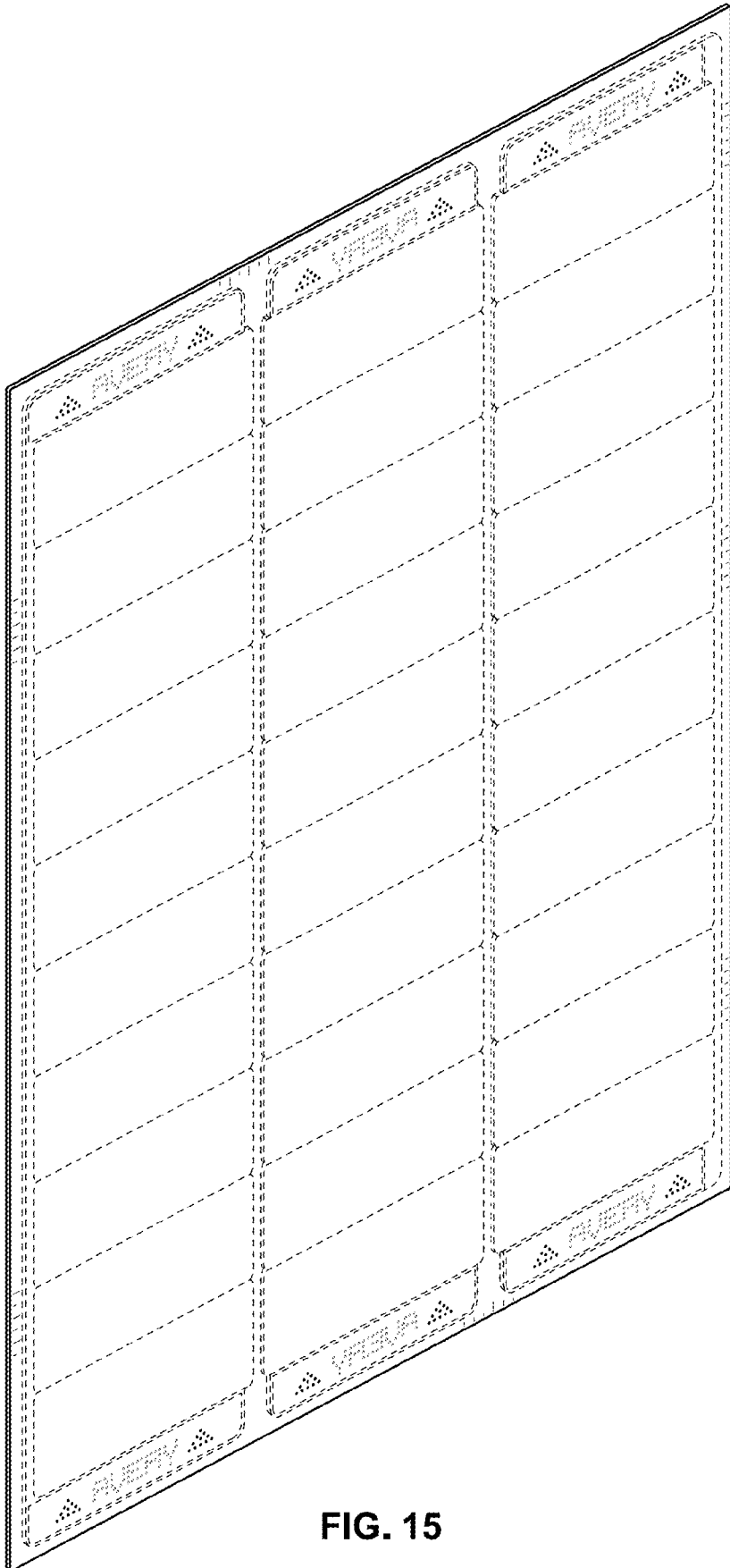

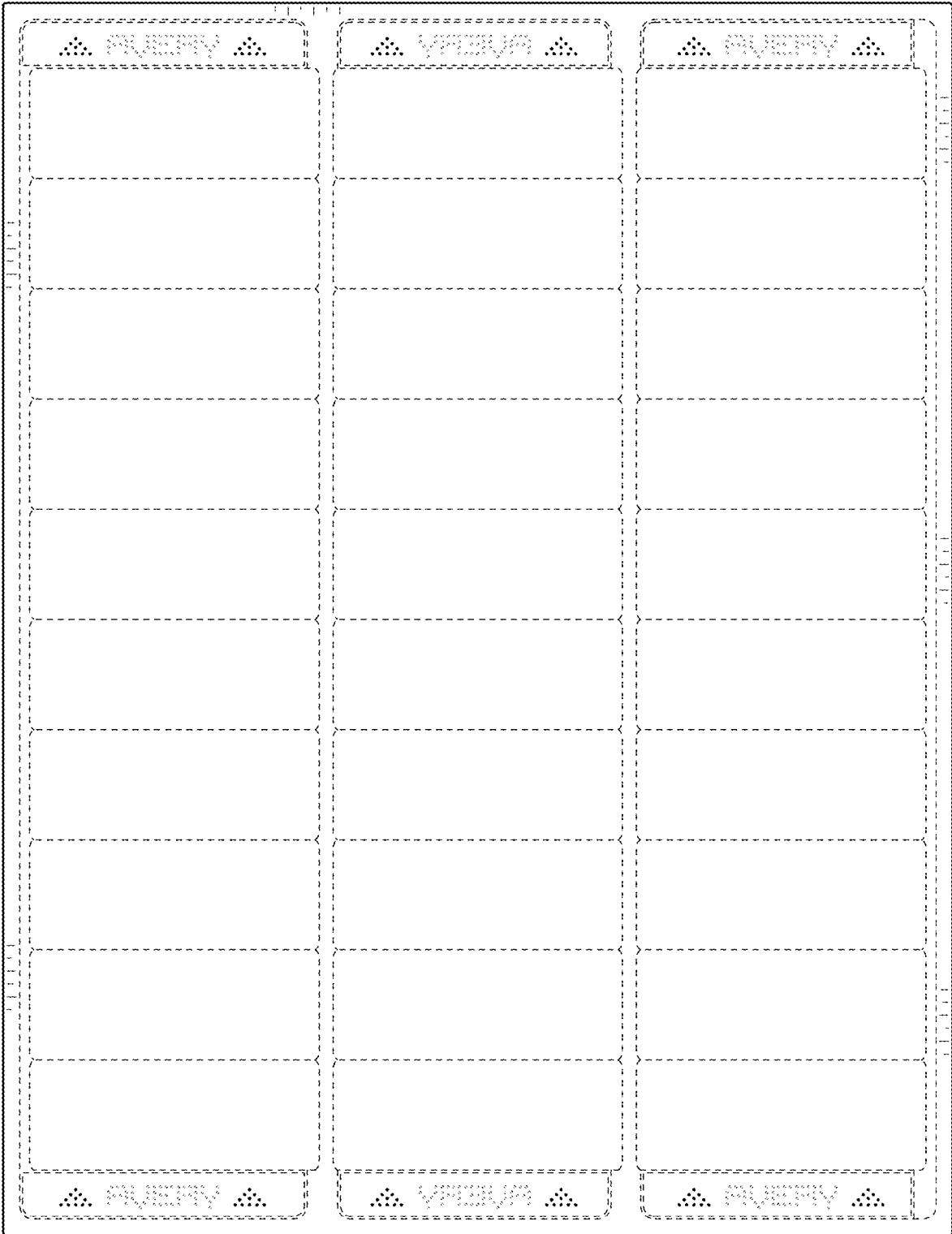

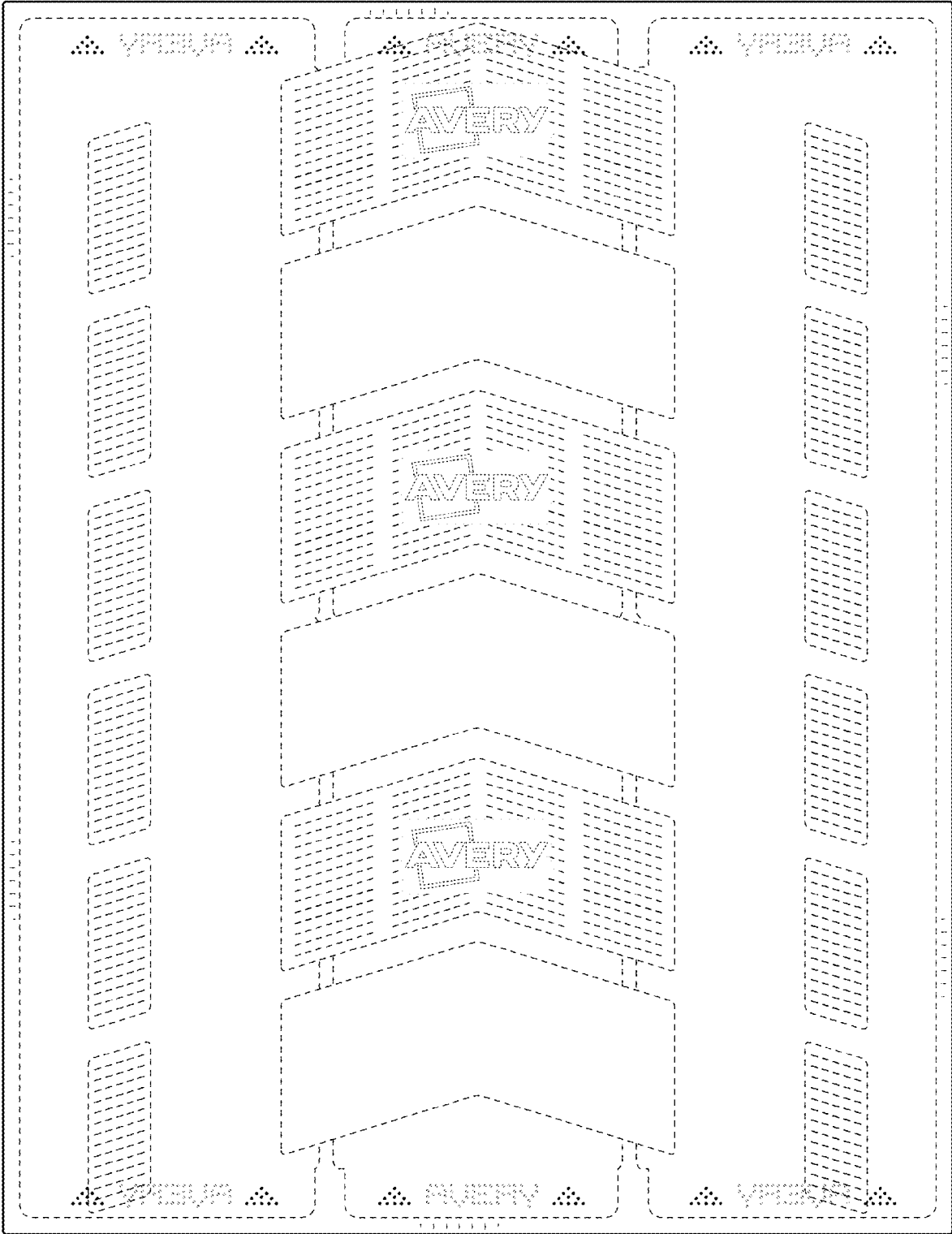

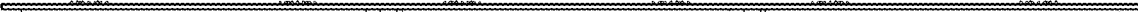

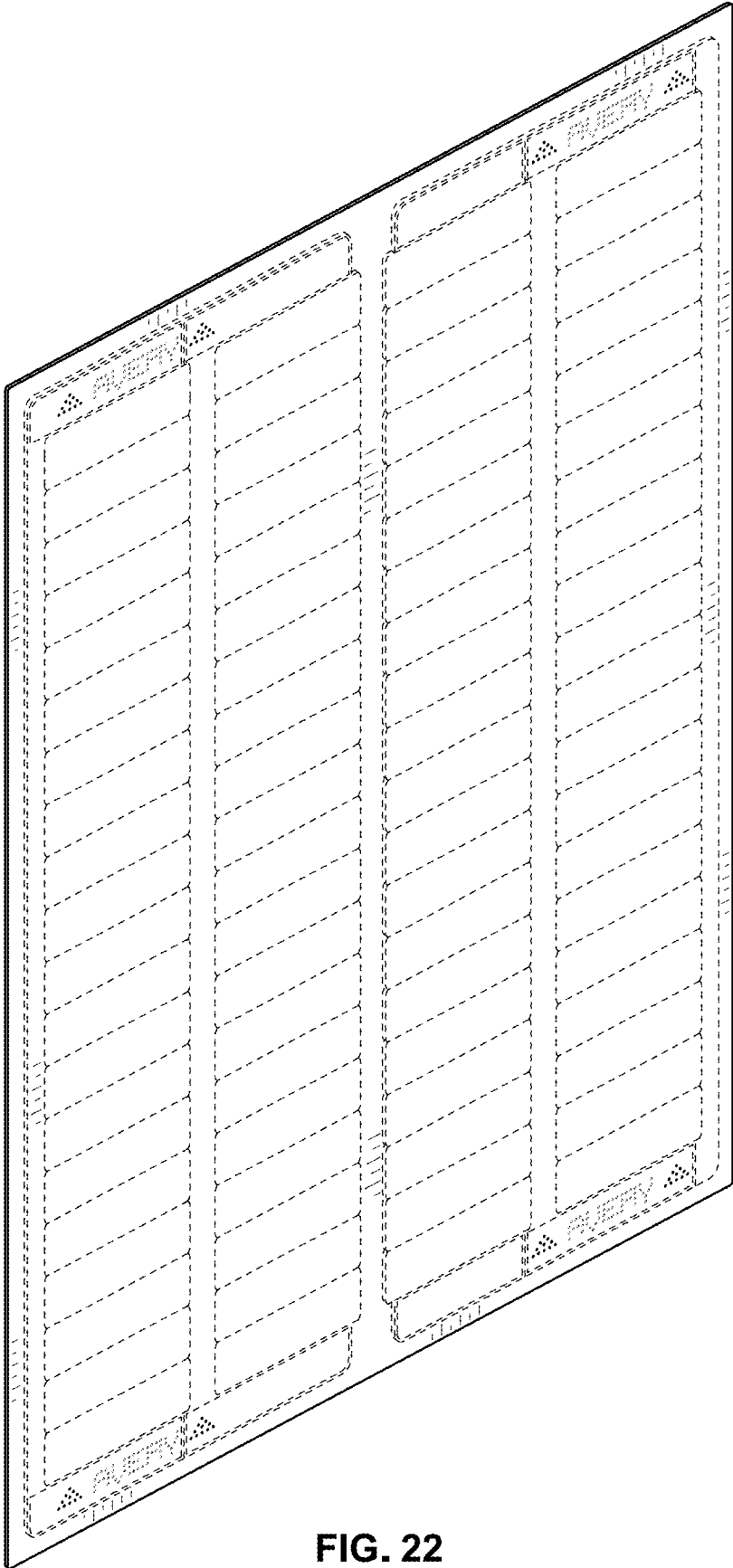

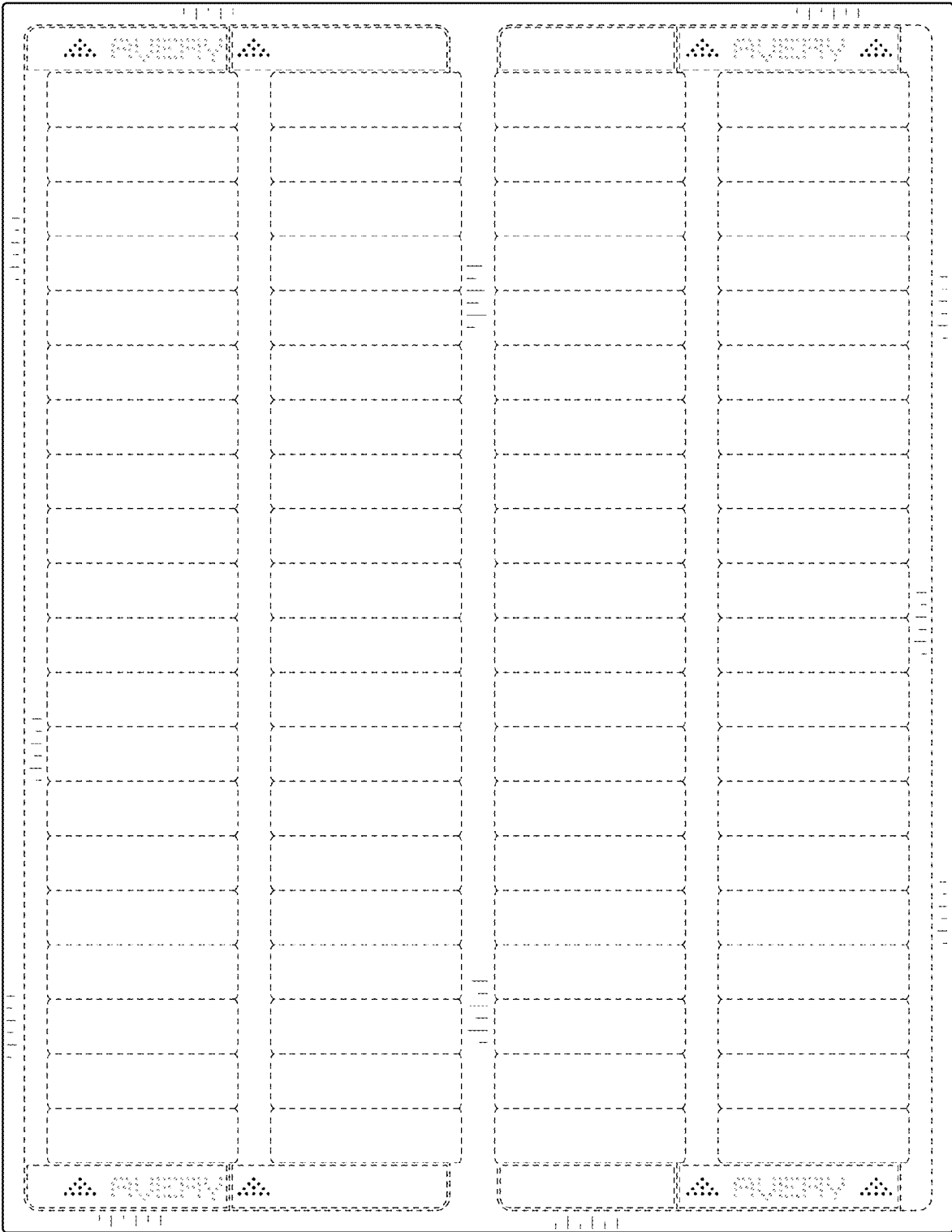

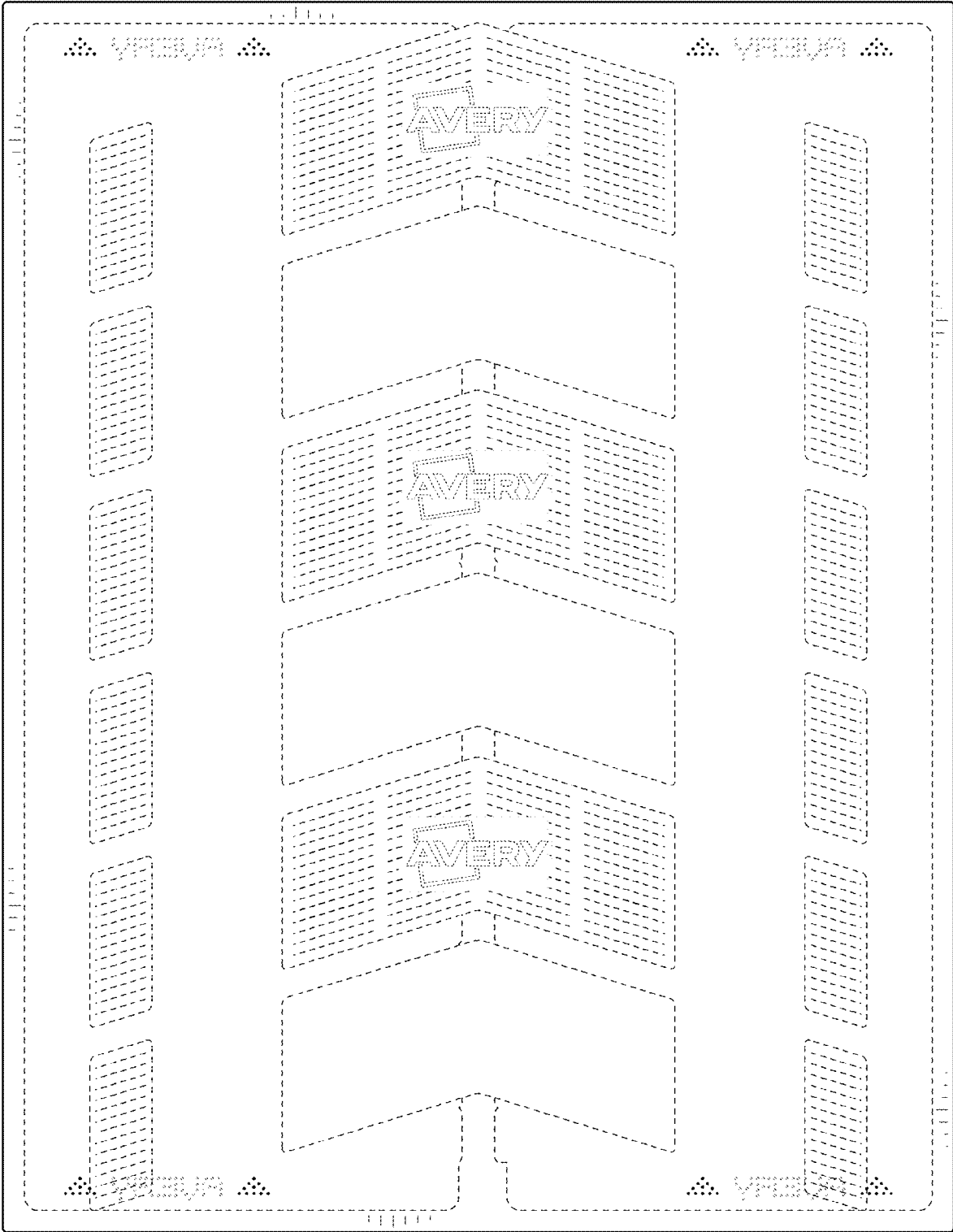
