The ornamental design for a display screen or portion thereof with transitional graphical user interface for auxiliary reading, as shown and described.

FIG. 6 is a detail of FIG. 3, shown enlarged for clarity of viewing;

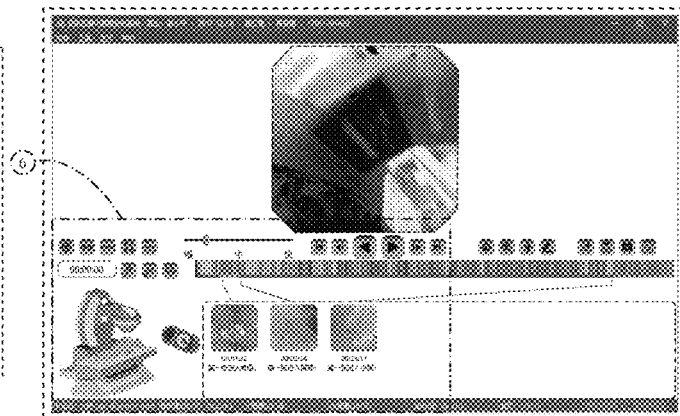
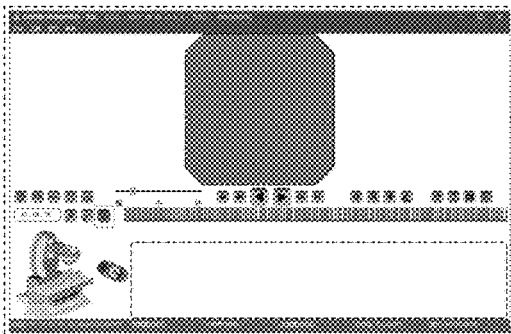
FIG. 7 is a detail of FIG. 4, shown enlarged for clarity of viewing;

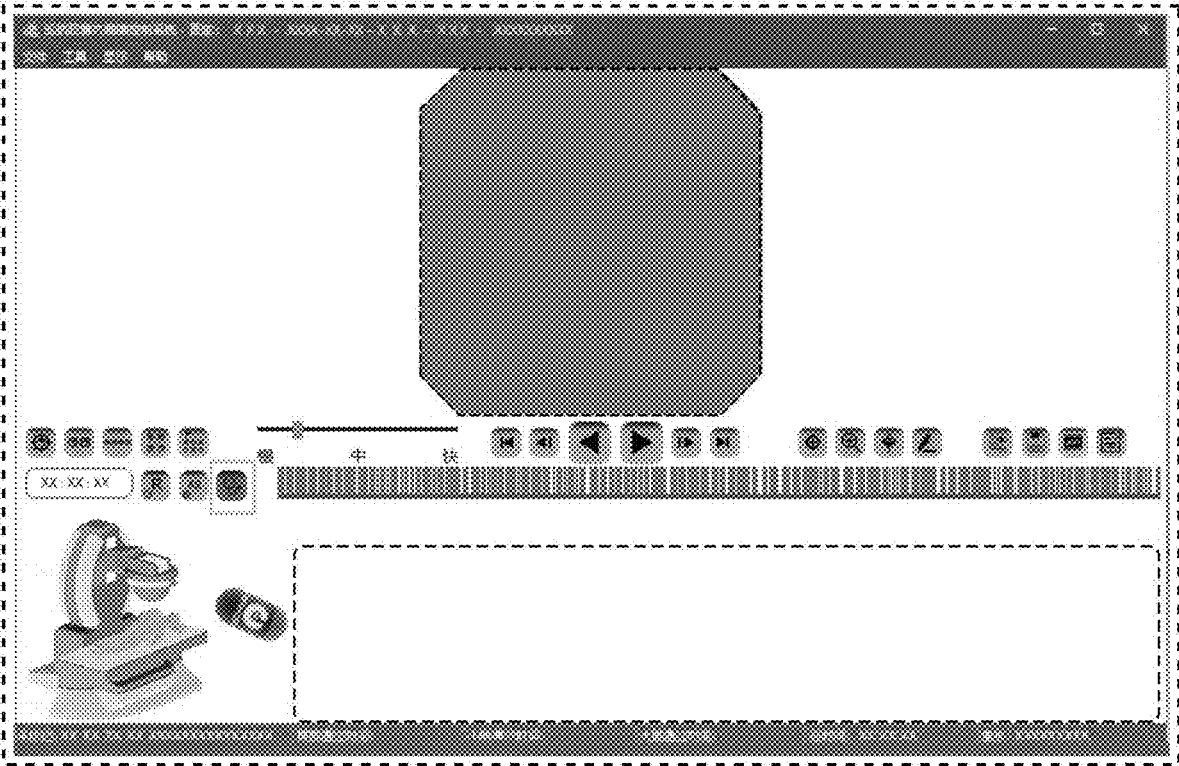

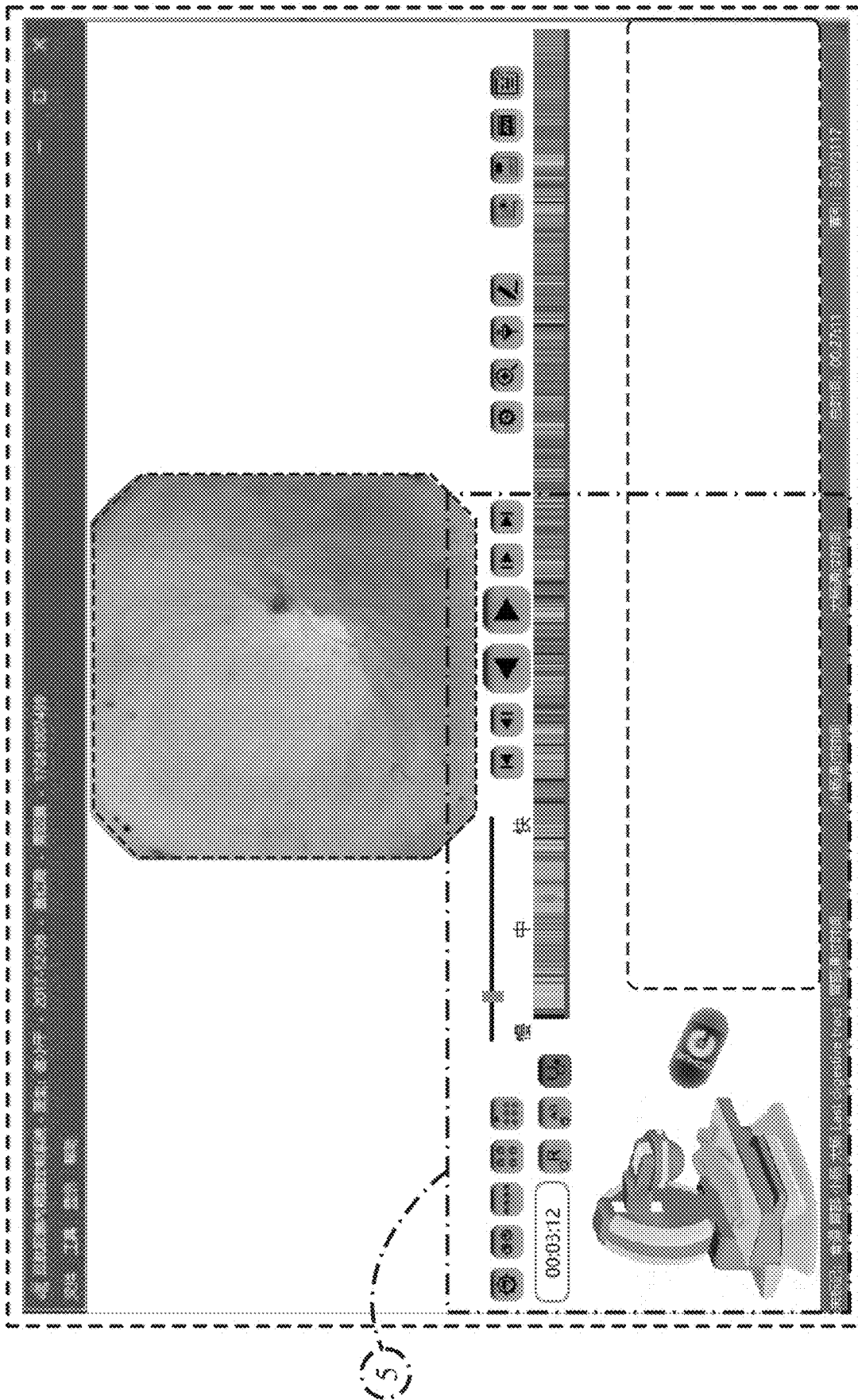

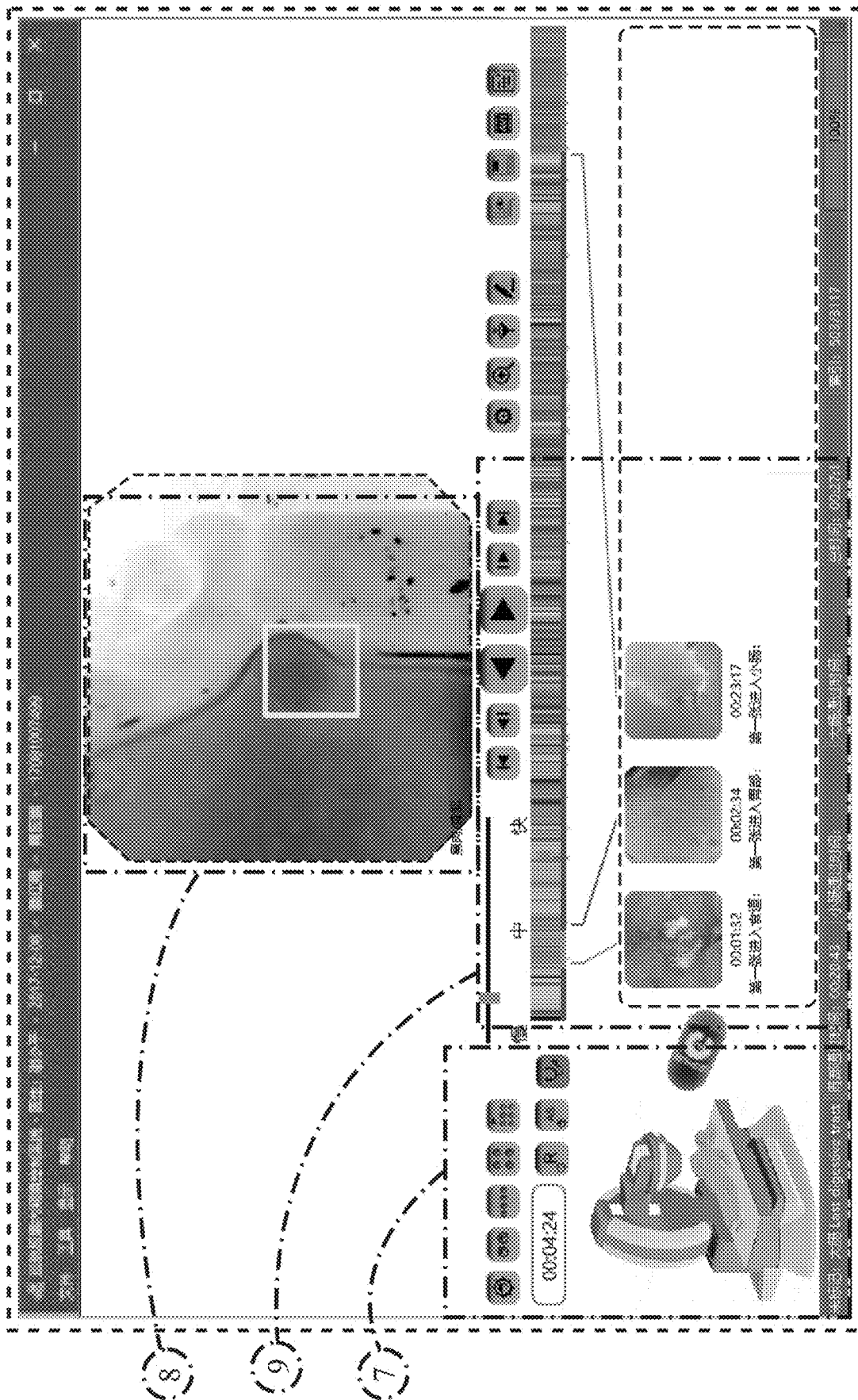

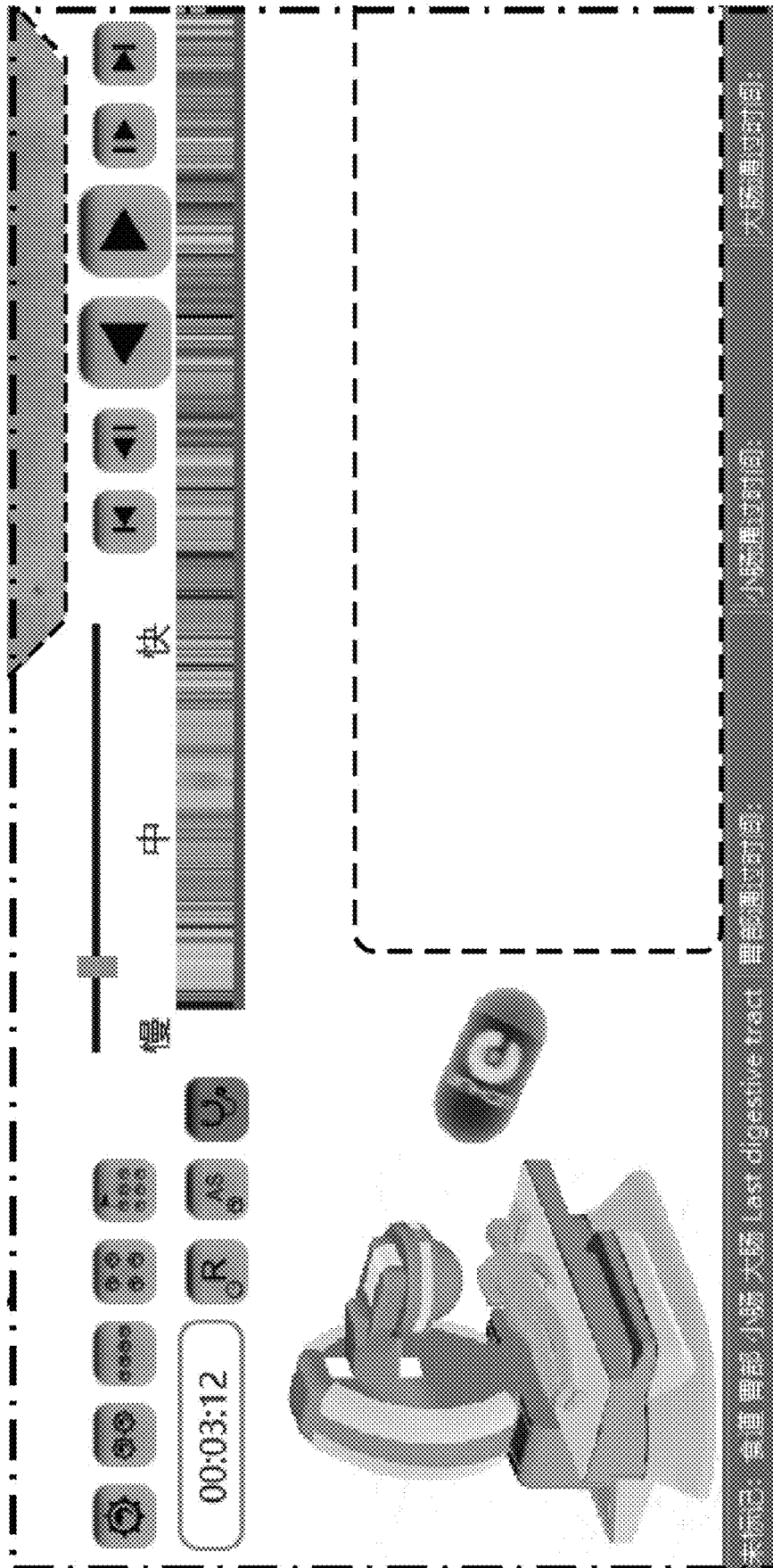

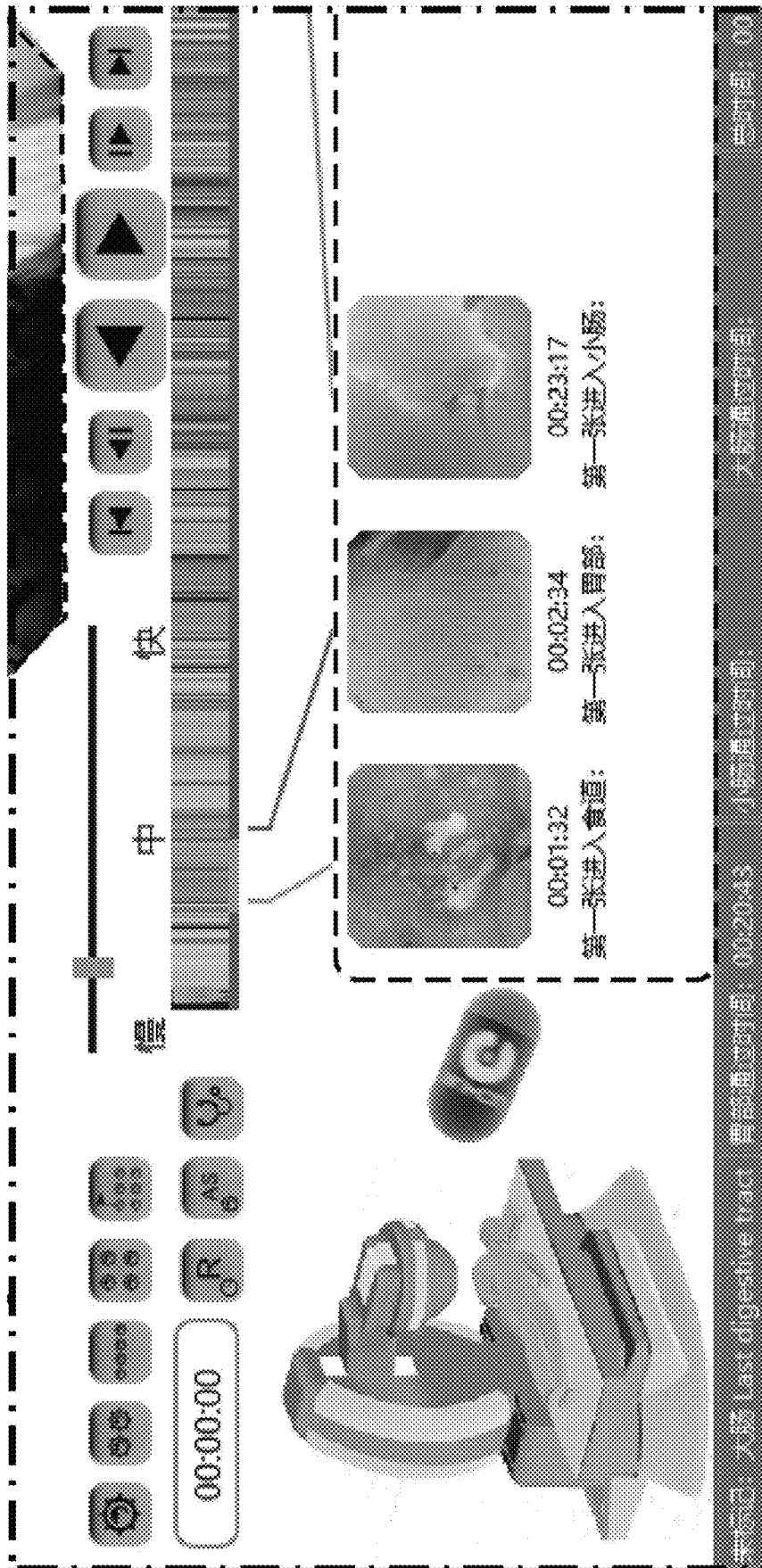

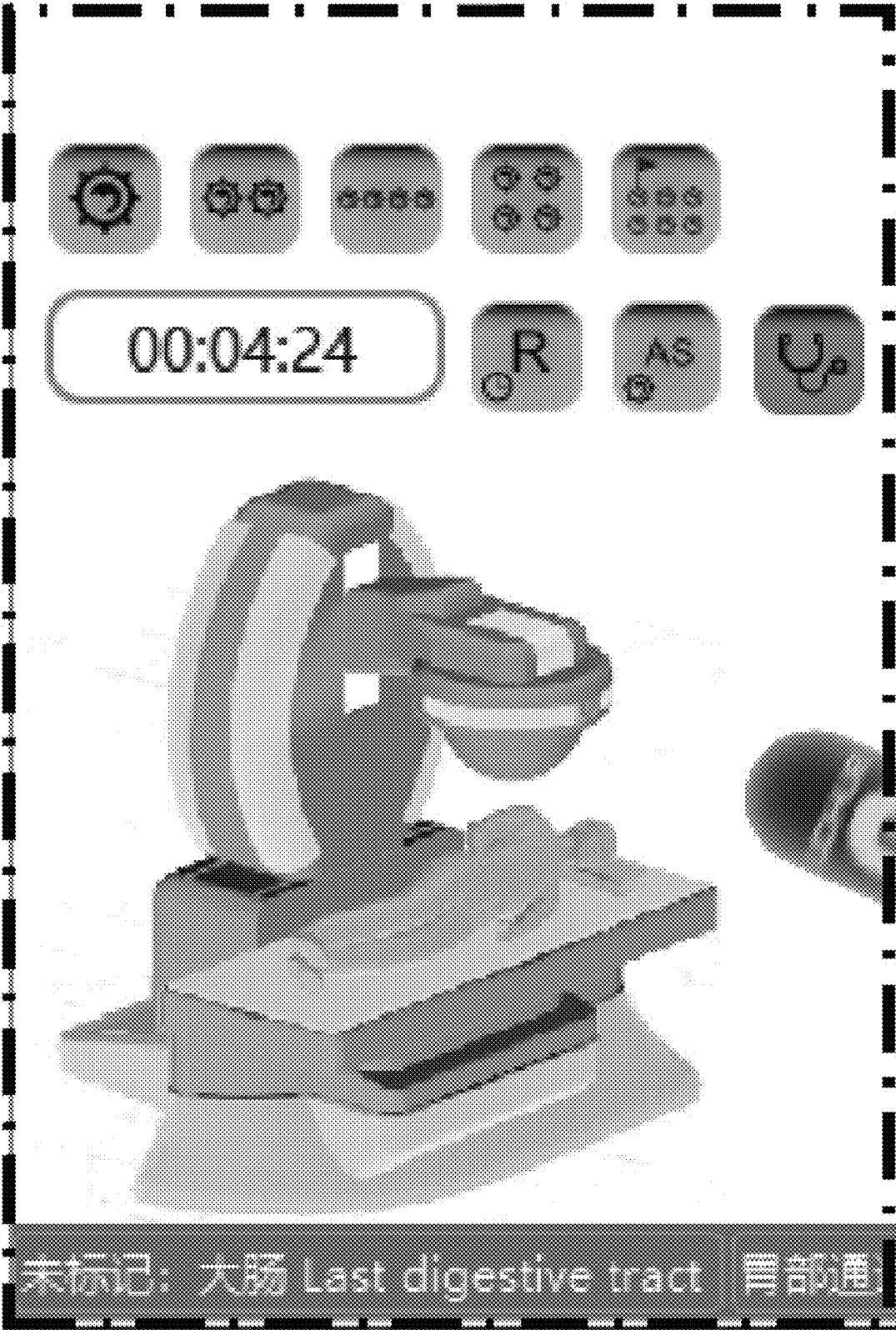

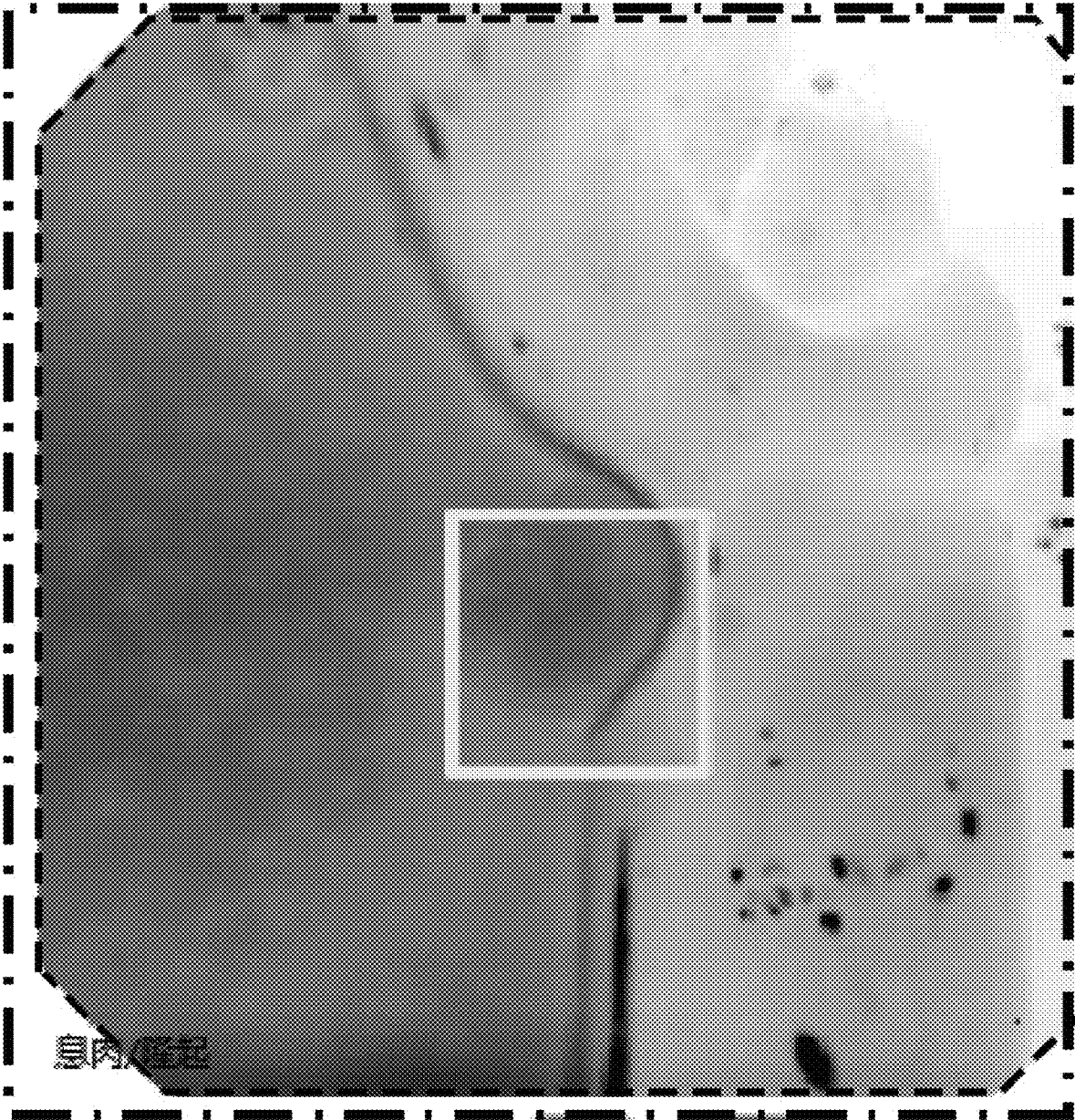

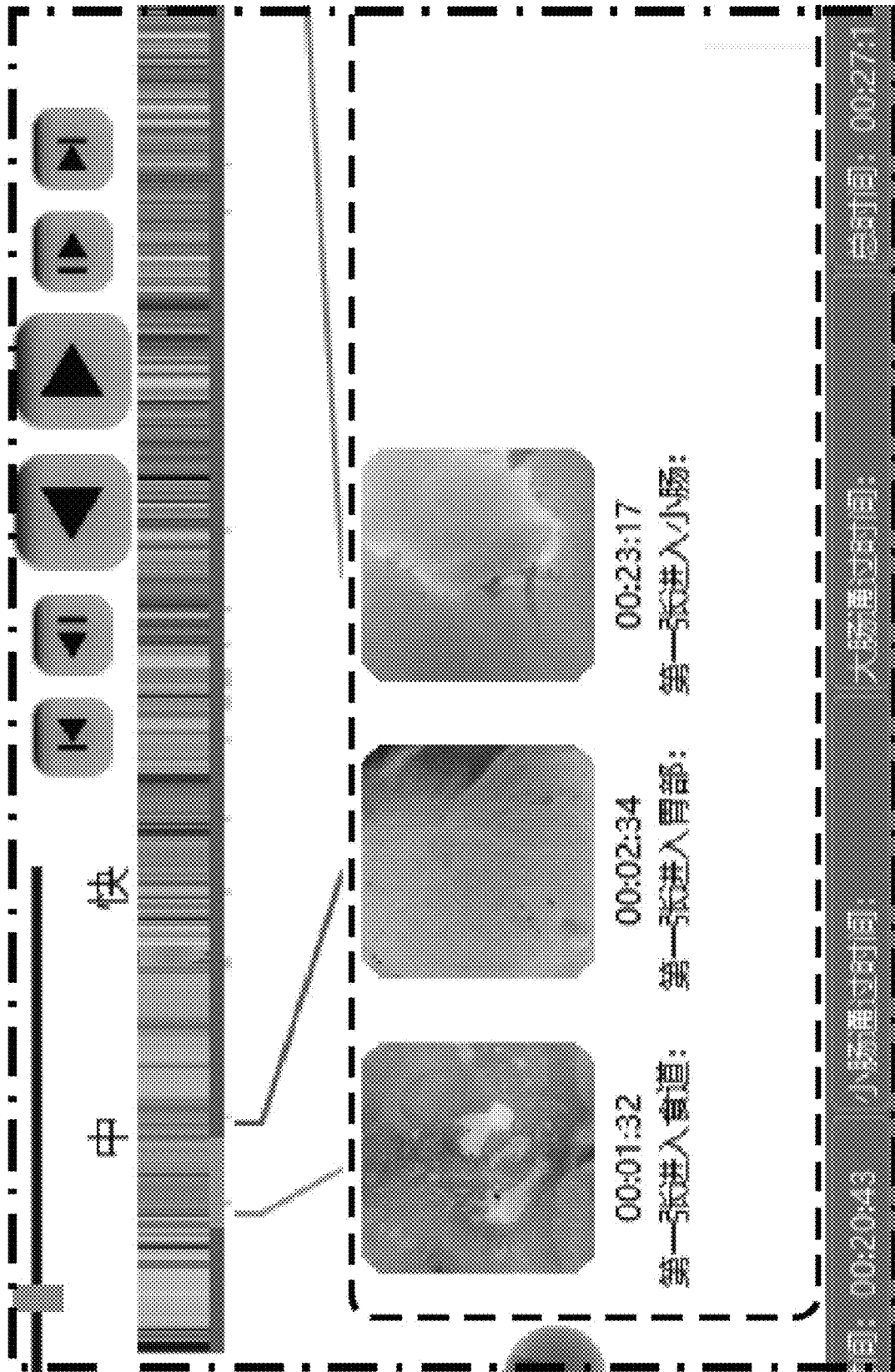
