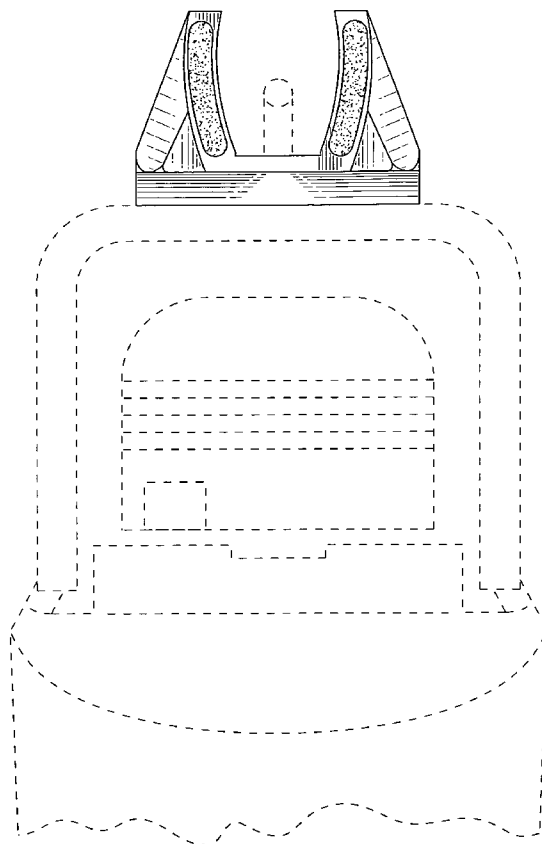
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear view of a low profile gun sight showing my new design, wherein a partial view of the rear portion of a hand gun is shown in broken lines for illustrative purposes only and forms no part of the claimed design;

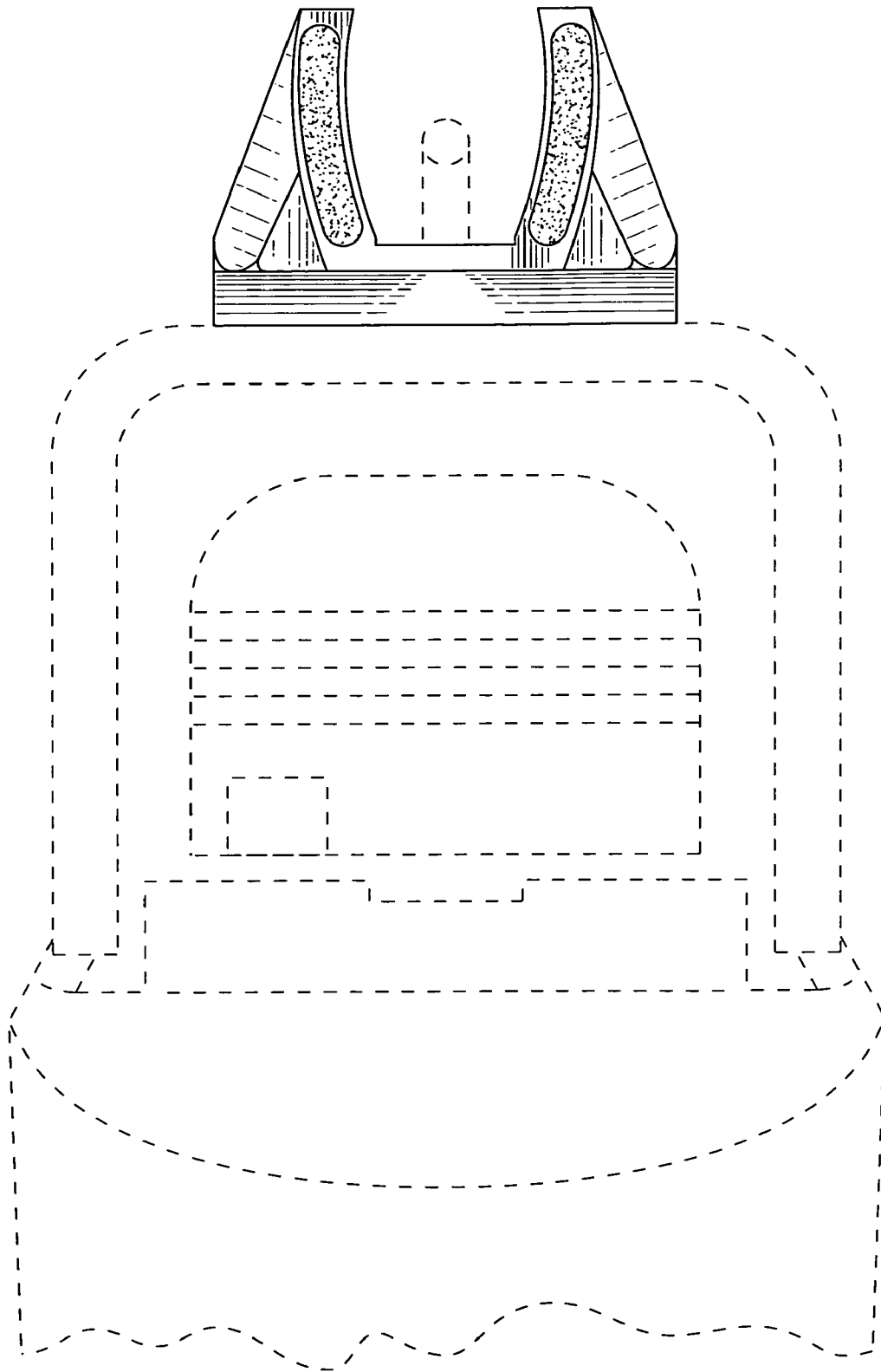

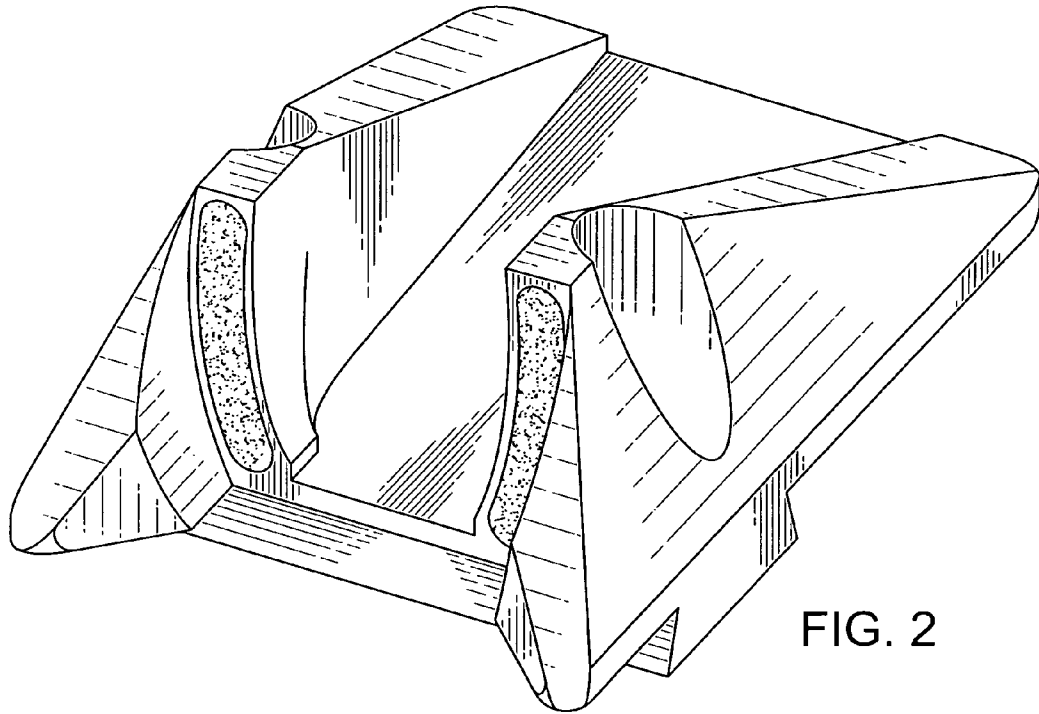

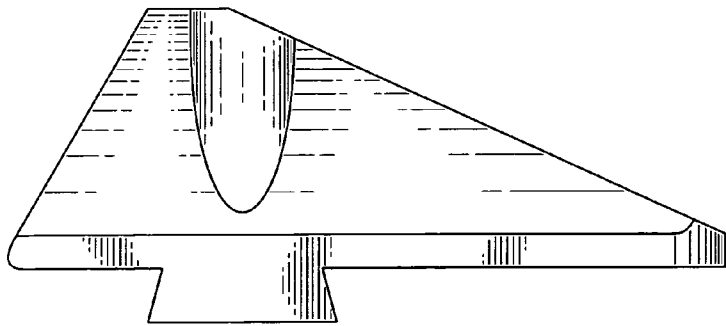

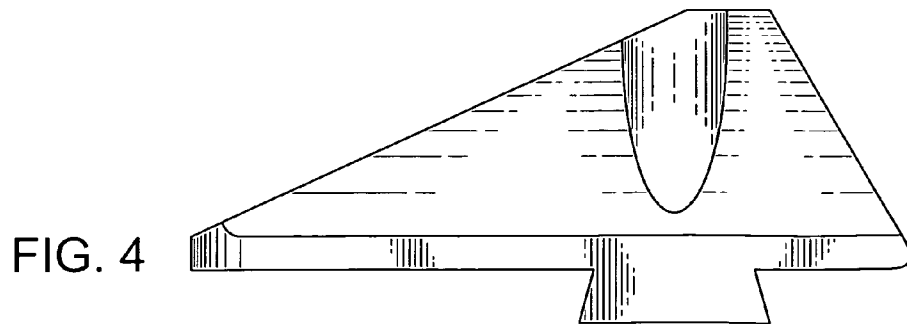

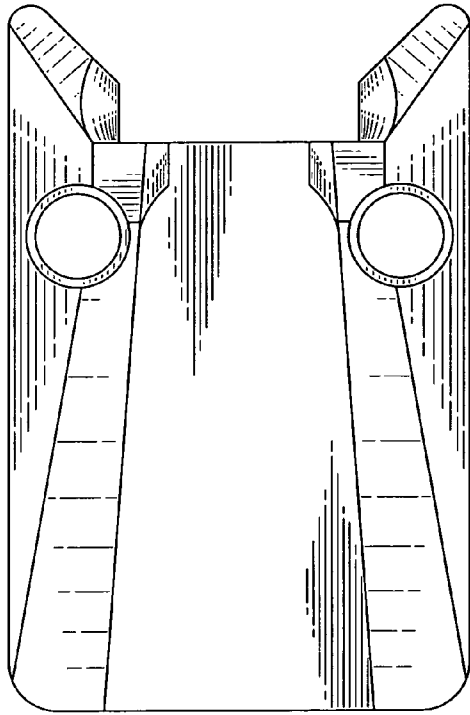

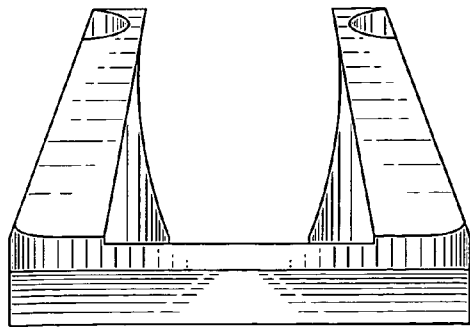
