- 2 SEEKING" and substitute "REGARDING".
- 3 Page 3, line 7, strike "Constitutes" and substitute "Must contain all
- 4 ELEMENTS NECESSARY TO CONSTITUTE".
- 5 Page 3, line 9, strike "Constitutes" and substitute "Must contain ALL
- 6 ELEMENTS NECESSARY TO CONSTITUTE".
- 7 Page 3, strike lines 17 through 20 and substitute:
- 8 "(II) CLEARLY STATES THAT THE RELEASE FORM PERMITS
- 9 DISCLOSURE OF AN INDIVIDUAL'S PROTECTED HEALTH INFORMATION BUT
- 10 DOES NOT REQUIRE DISCLOSURE;".
- 11 Page 3, line 22, strike "HAVE CONSENTED" and substitute "THE
- 12 INDIVIDUAL HAS AUTHORIZED".
- Page 4, line 4, strike "SIX" and substitute "TWELVE".
- Page 4, strike lines 11 through 14 and substitute:
- 15 "(3) NOTHING IN THIS SECTION REQUIRES A PERSON TO USE OR
- 16 RELY ON THE RELEASE FORM CREATED PURSUANT TO THIS SECTION WHEN
- 17 AUTHORIZATION FOR DISCLOSURE OF PROTECTED HEALTH INFORMATION
- 18 IS REQUIRED UNDER HIPAA OR 42 CFR 2.
- 19 (4) NOTHING IN THIS SECTION REQUIRES AUTHORIZATION WHEN
- 20 DISCLOSURE OF PROTECTED HEALTH INFORMATION IS PERMITTED WITHOUT
- 21 AUTHORIZATION UNDER HIPAA OR 42 CFR 2.
- 22 (5) If a release form conflicts or is inconsistent with
- 23 ANOTHER AUTHORIZATION OR CONSENT FORM FOR AN INDIVIDUAL, A
- 24 PROVIDER OR COVERED ENTITY MAY CHOOSE WHETHER TO RELY UPON THE
- 25 RELEASE FORM AND INCURS NO LIABILITY AS A CONSEQUENCE OF
- 26 CHOOSING TO RELY UPON THE RELEASE FORM OR TO NOT RELY UPON THE
- 27 RELEASE FORM. A PROVIDER OR COVERED ENTITY INCURS NO LIABILITY
- 28 FOR NOT DISCLOSING INFORMATION PROVIDED IN A RELEASE FORM IF THE
- 29 PROVIDER OR COVERED ENTITY HAS A GOOD FAITH, REASONABLE BELIEF
- 30 THAT THE INDIVIDUAL HAS REVOKED THE RELEASE FORM. A PROVIDER OR
- 31 COVERED ENTITY IS PRESUMED TO HAVE ACTED IN GOOD FAITH AND WITH
- 32 A REASONABLE BELIEF. THIS PRESUMPTION MAY BE REBUTTED BY CLEAR
- 33 AND CONVINCING EVIDENCE.".

- 3 "(g) DISCUSS THE ROLE OF THE CENTRALIZED DIGITAL CONSENT
- 4 REPOSITORY IN CRISIS SITUATIONS AND HOW TO ENSURE EMERGENT
- 5 INFORMATION IS COMMUNICATED IN A TIMELY MANNER BETWEEN A
- 6 PATIENT, A PROVIDER OR FACILITY, AND OTHER AUTHORIZED PERSONS;".
- 7 Reletter succeeding paragraphs accordingly.
- 8 Page 6, line 11, before "LICENSED" insert "A REPRESENTATIVE OF A
- 9 HEALTH INFORMATION ORGANIZATION NETWORK; A REPRESENTATIVE OF
- 10 A HOSPITAL;".
- 11 Page 6, line 12, strike "PROVIDERS INCLUDING," and substitute
- 12 "PROVIDERS, INCLUDING".
- Page 7, after line 16 insert:
- "(VII) FAMILY HISTORY, RELATIONSHIPS, OR SOCIAL CONTEXT;".
- 15 Renumber succeeding subparagraphs accordingly.
- Page 8, line 17, strike "ENTITY." and substitute "ENTITY, UNLESS A
- 17 PATIENT HAS AUTHORIZED THE DISCLOSURE OF THE PATIENT'S FORM OR OF
- 18 THE PATIENT'S FULL MENTAL HEALTH RECORD OR UNLESS A COURT OR
- 19 OTHER LEGAL AUTHORITY HAS ORDERED SUCH DISCLOSURE.".
- 20 Page 8, after line 25 insert:
- 21 "(e) If a patient explicitly objects to a covered entity
- 22 RECEIVING INFORMATION REGARDING THE PATIENT FROM A SPECIFIC
- 23 INDIVIDUAL, THE COVERED ENTITY SHALL NOT ACCEPT INFORMATION
- 24 FROM THE SPECIFIC INDIVIDUAL.".
