## SENATE COMMITTEE OF REFERENCE AMENDMENT Committee on Finance.

## SB24-024 be amended as follows:

- 1 Amend printed bill, page 5, line 18, strike "SALE," and substitute "SALE
- 2 IN".
- 3 Page 5, line 19, after "JURISDICTION" insert "THAT HAS PASSED AN
- 4 APPLICABLE MARKETPLACE FACILITATOR LAW, A LOCAL TAXING
- 5 JURISDICTION".
- 6 Page 5, line 20, strike "MARKETPLACE. A" and substitute "MARKETPLACE
- 7 WHEN THE MARKETPLACE FACILITATOR IS FILING TAX RETURNS WITH THE
- 8 LOCAL TAXING JURISDICTION. A LOCAL".
- 9 Page 5, line 23, strike "FACILITATOR." and substitute "FACILITATOR THAT
- 10 HAS PROVIDED THE MARKETPLACE SELLERS, MULTICHANNEL SELLERS, OR
- 11 LODGING SUPPLIERS CONFIRMATION THAT THE MARKETPLACE
- 12 FACILITATOR IS RESPONSIBLE FOR REMITTING TAX. NOTHING IN THIS
- 13 SECTION PROHIBITS A LOCAL TAXING JURISDICTION FROM AUDITING OR
- 14 OTHERWISE ASSESSING TAX AGAINST MARKETPLACE SELLERS,
- 15 MULTICHANNEL SELLERS, OR LODGING SUPPLIERS IF THE LOCAL TAXING
- 16 JURISDICTION HAS NOT PASSED AN APPLICABLE MARKETPLACE
- 17 FACILITATOR LAW OR THE MARKETPLACE FACILITATOR HAS FAILED TO
- 18 CONFIRM THAT IT REMITS THE TAX.".
- 19 Page 5, after line 25 insert:
- "(a) "ACCOMMODATIONS INTERMEDIARY" MEANS A MARKETPLACE
  FACILITATOR, AS DEFINED IN SECTION 39-26-102 (5.9), WHO FACILITATES
  THE SALES OF TRANSIENT LODGING CONSIDERED TO BE A SALE UNDER
  SECTION 39-26-102 (11) OR A SHORT-TERM RENTAL UNIT.
- 24 (b) "LODGING SUPPLIER" MEANS AN OPERATOR OF A FACILITY PROVIDING ROOMS OR ACCOMMODATIONS FOR OVERNIGHT USE FURNISHED
- 26 TO ANY PERSON WHO, FOR CONSIDERATION, USES, POSSESSES, OCCUPIES OR
- 27 HAS THE RIGHT TO USE, POSSESS, OR OCCUPY ANY SUCH ROOM OR
- 28 ACCOMMODATION IN A HOTEL, APARTMENT HOTEL, LODGING HOUSE,
- 29 MOTEL, MOTOR HOTEL, GUEST HOUSE, GUEST RANCH, RESORT, MOBILE
- 30 HOME, MOBILE HOME PARK, AUTO COURT, INN, TRAILER COURT, TRAILER
- 31 PARK, HOTEL, OR SHORT-TERM RENTAL UNDER ANY CONCESSION, PERMIT,
- 32 LEASE, CONTRACT, OR LICENSE TO USE OR ANY OTHER SIMILAR
- 33 ARRANGEMENT.".
- 34 Reletter succeeding paragraphs accordingly.
