TRAINING OVERVIEWS

ERU Capabilities

This presentation provides an overview of our team, our role as AZSERC staff, a high-level discussion of the ERF and HMEP grant and a summary of our response equipment and on-scene capabilities. (30 minutes including Q&A)

Local Emergency Planning Committee (LEPC) Member Training

New to an LEPC? This is an overview of your role as a Chair/Vice Chair, voting member, or coordinator. A folder of commonly used resources is also provided. (90 minutes)

Spill Reporting

We provide an overview of ADEQ's live-updating dashboard that reflects spill notifications we've received and discuss how LEPCs can best utilize it. (15 minutes)

Open Meeting Law

Covers the basics of Open Meeting Law and how you can ensure your compliance. We discuss topics like meeting quorum, agenda and notification requirements, minute taking, etc. (60 minutes)

Emergency Response Fund

This training breaks down the process for submission, timeline, who can apply, items that can be requested, the selection process, and award and delivery of items. (30 minutes including Q&A)

Hazardous Materials Emergency Preparedness (HMEP) Grant

Provides an overview of the grant application process, activities that meet program requirements, submitting a project narrative, notice of award and reporting requirements. (45 minutes)

Tier II Chemical Reporting

This is an in-depth and tailored training for fire departments, LEPCs, and facilities on how to use our current Tier II online reporting website. (30-60 minutes)
