Ally Invest Market Data Disclosure and Market Data Subscriber Agreements

Ally Invest Securities LLC (Ally Invest) provides customers with real-time or delayed quotes, last sale prices, volume, other current and historical pricing information, research, and other data (collectively, "Market Data") obtained from Securities Information Processors ("SIPs") (i.e., Consolidated Tape Association (CTA), Options Price Reporting Authority (OPRA)); other U.S. securities and commodities futures exchanges, including the New York Stock Exchange (NYSE), The Nasdaq Stock Market (Nasdaq), CME Group, Inc. (CME), and Cboe Futures Exchange, LLC (Cboe); and CUSIP Global Services; and research providers Morningstar Research Services LLC, Morningstar, Inc., or their content providers (collectively, "Market Data Providers"), through agreements between Ally Invest and Market Data Providers.

Ally Invest customers agree that use of the Market Data is subject to the terms and conditions of the relevant subscriber agreements. Ally Invest customers may receive Market Data on either a real-time or delayed (by at least 15 minutes) basis based on eligibility and fees paid. Based on the customer's market data eligibility, equities data is either real-time Cboe One or Consolidated Tape Association and Unlisted Trade Privileges data from the SIPs, depending on your market data status. OPRA provides options data as consolidated data. The OTC Markets Group provides OTCQX, OTCQB, and OTC Pink data. Market Data displayed on the Ally Invest trading platform is the exclusive property of the respective Market Data Providers. Market Data may not be copied or otherwise reproduced, repackaged, further transmitted, transferred, disseminated, redistributed, resold, or stored for subsequent use for any such purpose, in whole or in part, in any form or manner, or by any means whatsoever, without prior written consent by the appropriate Market Data Provider(s).

The Market Data Providers reserve all rights to the Market Data they distribute to Ally Invest.
