Introduction	Article 5 of the Staff Regulations (applicable to officials and, by analogy, to temporary staff) provides that the posts covered by the Staff Regulations shall be classified in 'administrators' function group (AD), 'assistants' function group (AST) and 'secretaries and clerks' function group (AST/SC). AD group shall comprise 12 grades, AST group shall comprise eleven grades and AST/SC group shall comprise six grades. Annex I to the Staff Regulations lists the types of posts with the corresponding grade ranges, while more duties and powers attached to each type of post can be defined by implementing rules.
Description	The present decision lays down rules establishing the equivalence between the types of post and the post titles which are used for EFSA officials and temporary staff. The rules are based on a model decision developed by the Commission for agencies to account for the different terminology to describe functions exercised, the range of grades of Head of Department post title of which the lower grade should respect the limitation referred to in Article 53 of the CEOS and the range of grades within other types of post.

DECISION OF THE EUROPEAN FOOD SAFETY AUTHORITY ON TYPES OF POST AND POST TITLES IN EFSA

THE MANAGEMENT BOARD

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the Staff Regulations of Officials ('Staff Regulations') and the Conditions of Employment of Other Servants of the European Union ('CEOS') laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68¹, and in particular Article 5 of the Staff Regulations and Annexes I and XIII thereto, and Article 10 of the CEOS,

Having regard to European Parliament and Council Regulation (EC) No 178/2002 of 28 January 2002 establishing the European Food Safety Authority ('EFSA') and laying down procedures in relation to food safety², and in particular Articles 25, 26 and 48,

Having regard to the rules of procedure of EFSA's Management Board³ and in particular Article 8 thereof,

Having regard to the agreement of the European Commission pursuant to Article 110(2) of the Staff Regulations C(2018) 8800 of 11 December 2018,

After consulting the Staff Committee,

Whereas:

- 1) On 17 December 2013, the Commission informed EFSA that it adopted Decision C(2013)8979 of 16 December 2013 on types of post and post titles.
- 2) On 26 September 2014 Communication C(2014) 6543 from Vice-President Šefčovič to the Commission on the guidelines on the implementation of Article 110(2) of the Staff Regulations with regard to the implementing rules applicable in the agencies was adopted, and in particular Point 2.B thereof, where the Commission ex ante agreement is referred to.
- 3) Pursuant to Article 110(2) of the Staff Regulations, implementing rules such as those referred to in Recital 1 are to apply by analogy to EFSA. By way of derogation, an agency may request the Commission's agreement to the non-application of certain implementing rules. The Commission may, instead of accepting or rejecting the request, require the agency to submit for its agreement implementing rules which are different from those adopted by the Commission.
- 4) Commission Decision C(2013)8979 is suitable to apply to EFSA provided that certain adjustments are made to take into account the peculiarities of EFSA. Those adjustments concern in particular

the terminology established in EFSA to describe functions exercised, the range of grades of Head of Department post title of which the lower grade should respect the limitation referred to in Article 53 of the CEOS and the range of grades within other types of post.

- 5) For each of the three function groups (AD, AST and AST/SC), the types of post with the corresponding grade ranges are laid down in Annex I to the Staff Regulations. In addition, transitional rules on types of post are set out in Annex XIII for officials and temporary staff in service on 31 December 2013.
- 6) It is necessary to establish the equivalence between these types of post and the post titles which are used for EFSA officials and temporary staff,

HAS DECIDED AS FOLLOWS:

Article 1

In accordance with Article 5(4) of the Staff Regulations, the tables establishing the equivalence between the types of post and the post titles used for EFSA officials and temporary staff, which are contained in the Annex to this Decision, are hereby approved.

Article 2

Commission Decision C(2013) 8979 of 16 December 2013 does not apply by analogy to EFSA.

Article 3

This Decision shall take effect on the day following that of its adoption.
