## **MC Minutes**

The secretariat confirms that the quorum is met (28 out of 38 appointed MC members were present at the meeting, All TSOs presence: 1st voting part 83.81%, 2nd voting part 95.56%).

The Chair opens the meeting, welcomes the participants, and asks if the agenda and the minutes are acceptable.

The new Statnett MC member Mrs. Martha Marie Øberg introduces herself. It is announced that Norway officially adopted the Network Codes.

### 5. Bidding Zones Technical Report

The Convener presents the first consolidated draft of the report to the Market Committee, highlighting that it is a work-in-progress document such that data-quality checks and result updates are required; the updates will be presented in September. The Convener shows that there is significant progress in the work drone by the Task Force. The Market Committee provides certain recommendations on how to represent the data consistently to provide a better understanding of the grid map as well as to conduct further analyses to improve the visualisation and consistency. These recommendations will be communicated to the Task Force and further actions will be taken.

**5.1** The MC is invited to provide comments to the TR TF on the draft until 30<sup>th</sup> July 2021.

#### 6. WG MIT - TP MoP Updates

The WG MIT convener presents the amendments implemented to the Manual of Procedures v3r3 of the Transparency Platform, which were done to better reflect the new and updated business requirements to the Transparency platform. He mentions that the amendments are primarily the updates to the existing Manual of Procedures (MoP) which consists of updates to the Business Requirement Specification (BRS), the Detailed Data Description (DDD) and the Implementation Guides (IG). Moreover, he points out that the Balancing Implementation Frameworks DDD, SOGL DDD, and related BRSs and IGs are also included in the TP MoP v3r3. The specificities of the amendments are also presented to the MC.

Moreover, the WG MIT convener presents the project plan and milestones of the finalisation process of the MoP update mentioning the establishment of the task force with the WG MIT and Balancing Platforms experts for assessing the comments from the public consultation, and the ENTSO-E Transparency Platform User Group workshop being planned to be held in early August. Finally, he notes that the updated MoP v3r3 is planned to be presented to the MC in September for final approval after the comments from the public consultation are incorporated. After the MC approval in September, the MoP will be submitted to ACER for its formal opinion.

6.1 The MC approves the Manual of Procedures v3r3 including Transparency Platform data extraction process IG v1.4, Transparency platform EB GL process IG v1r7, Balancing Transparency Process Implementation Guide v4.9, Central Transparency Platform – IG for European Platforms v1.2.



The MC approves the documents to be published on the ENTSO-E website and asks the Secretariat to proceed with the public consultation.

#### 7. 2020 ENTSO-E Initial Resource Plan

The Head of Market section reminds about the new process named "Resource Plan" which aims at identifying the required resources to perform the tasks foreseen in 2022 and beyond. He presents the identified needs for Market and the next steps of the process.

- the process related to the 2022 ENTSO-E Resource Plan and,
- the MC Chair in his task to recommend solutions to fulfill identified needs.
