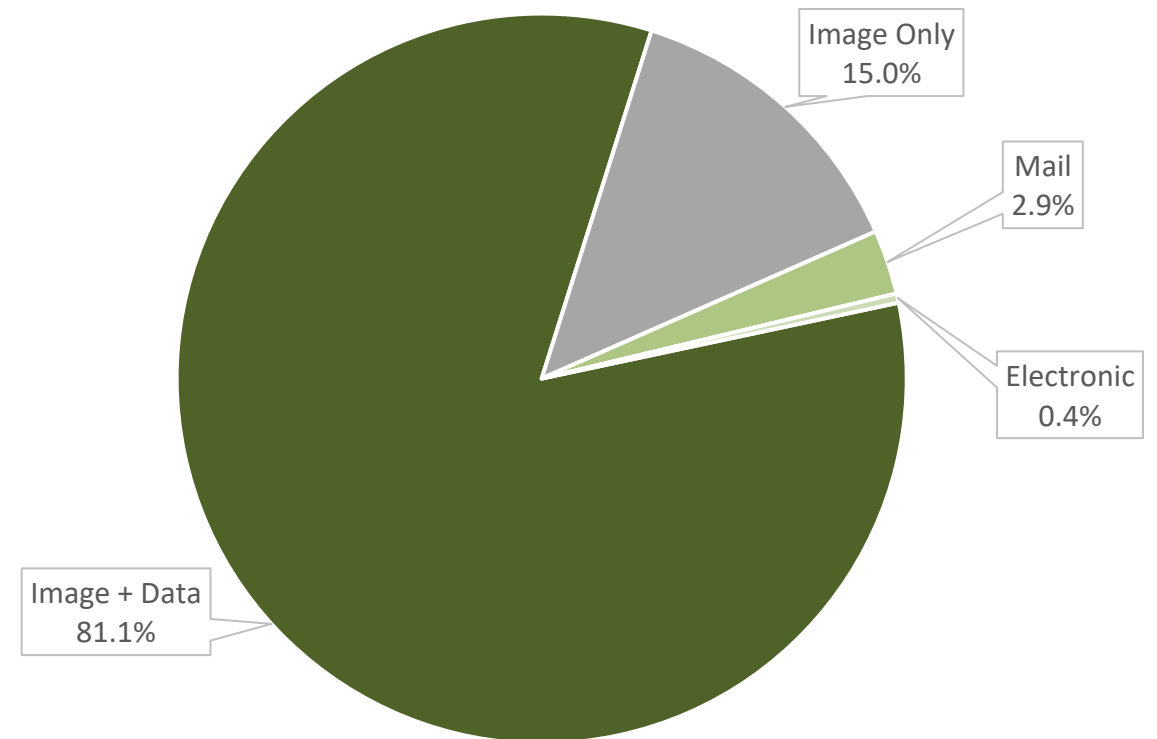

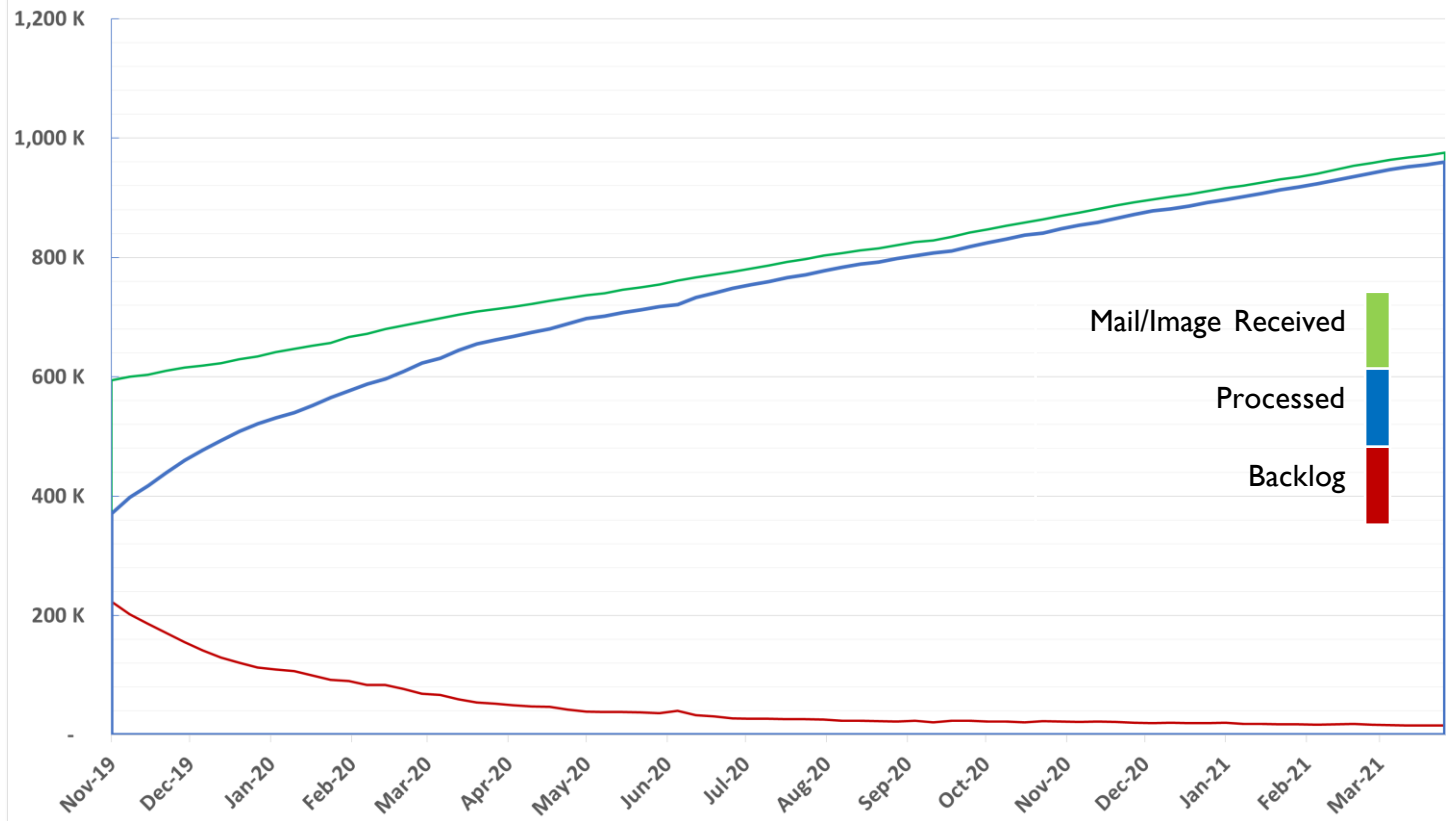

GENERATOR REGISTRATION

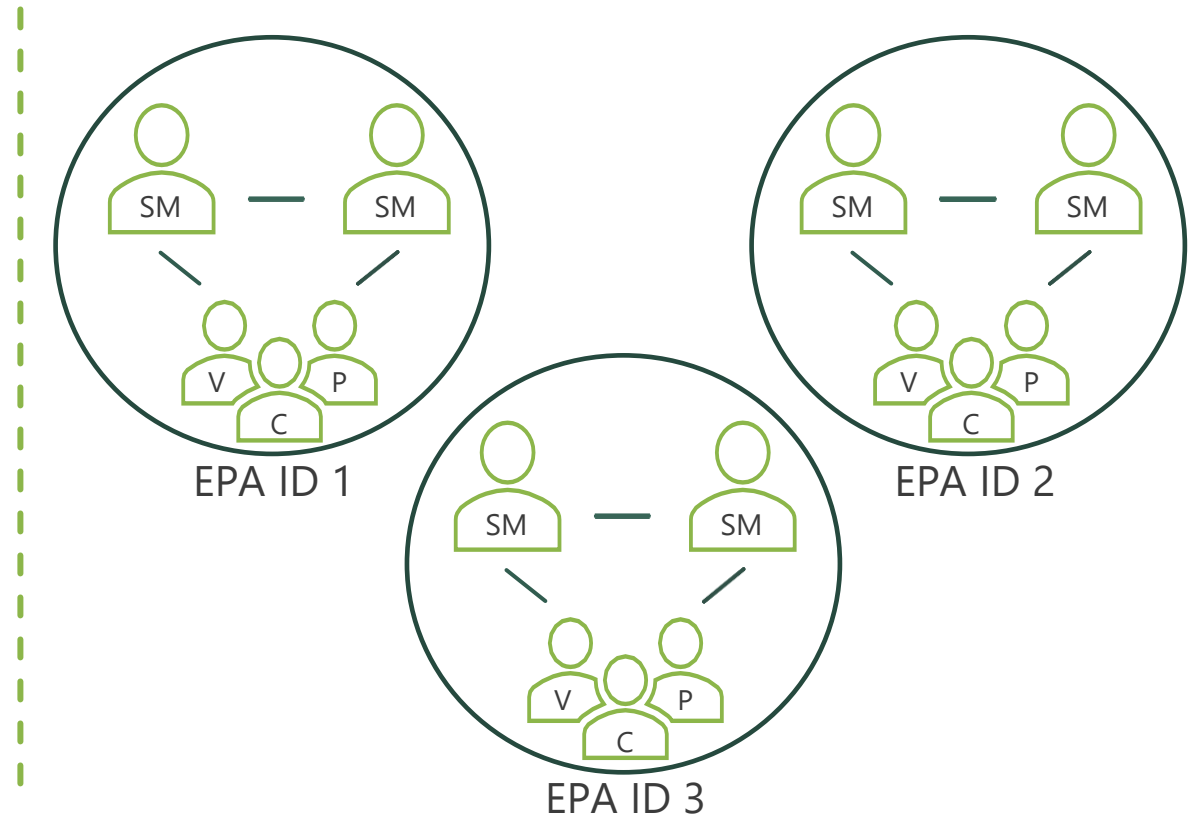
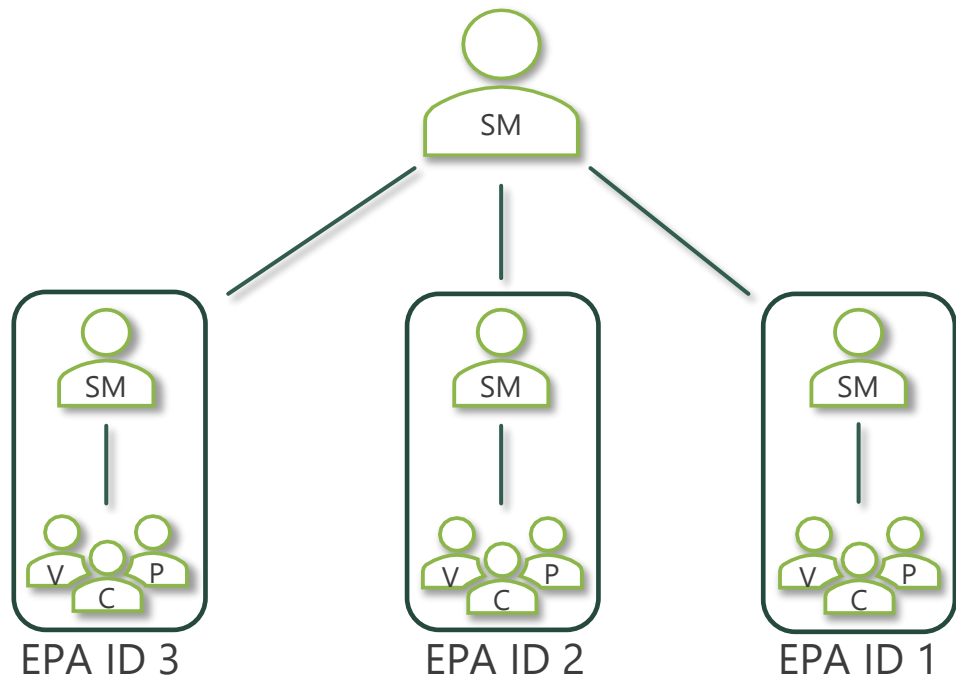
e-Manifest

- EPA is currently contacting generators and encouraging them to:
 1. Register in RCRAInfo
 2. Request site access
 3. View the data associated with their site ID and make any necessary corrections
- The focus is currently on large companies with multiple sites

e-Manifest

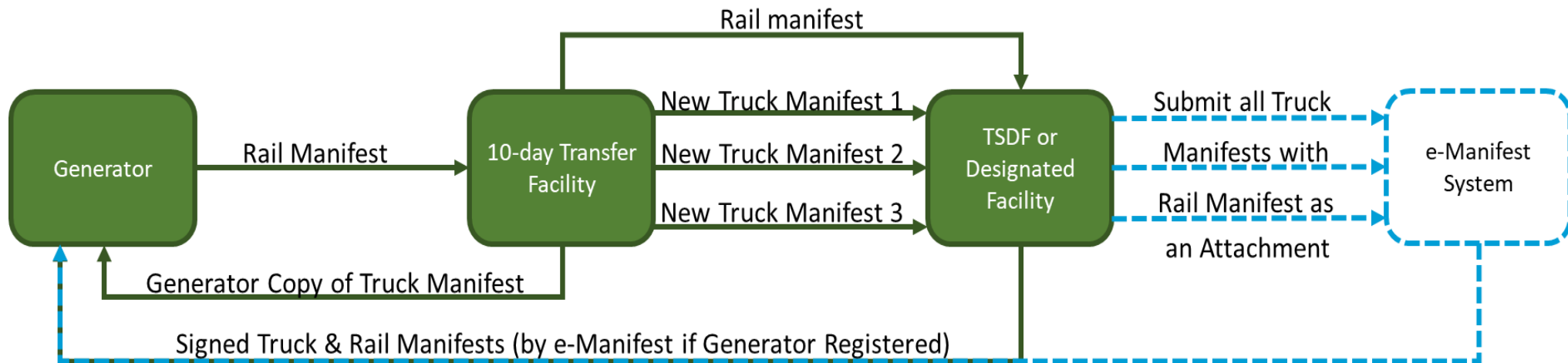
- There are multiple ways to organize site access permissions for generators that have multiple sites



SPLIT RAIL SHIPMENT GUIDANCE

e-Manifest

- The e-Manifest Program has also developed new e-Manifest guidance for instances where an initial rail shipment is split into multiple trucks to be delivered to the designated receiving facility

MAILED MANIFEST PHASEOUT

JUNE 30, 2021

e-Manifest

- Beginning June 30, 2021, EPA will no longer accept mailed paper manifests from facilities for processing in e-Manifest
- At that time, manifest and continuation sheet submissions will **only** be accepted in electronic, hybrid, data plus image, and image format
- **After June 30**, EPA will return to the sender any manifests and continuation sheets that are mailed to the e-Manifest PPC



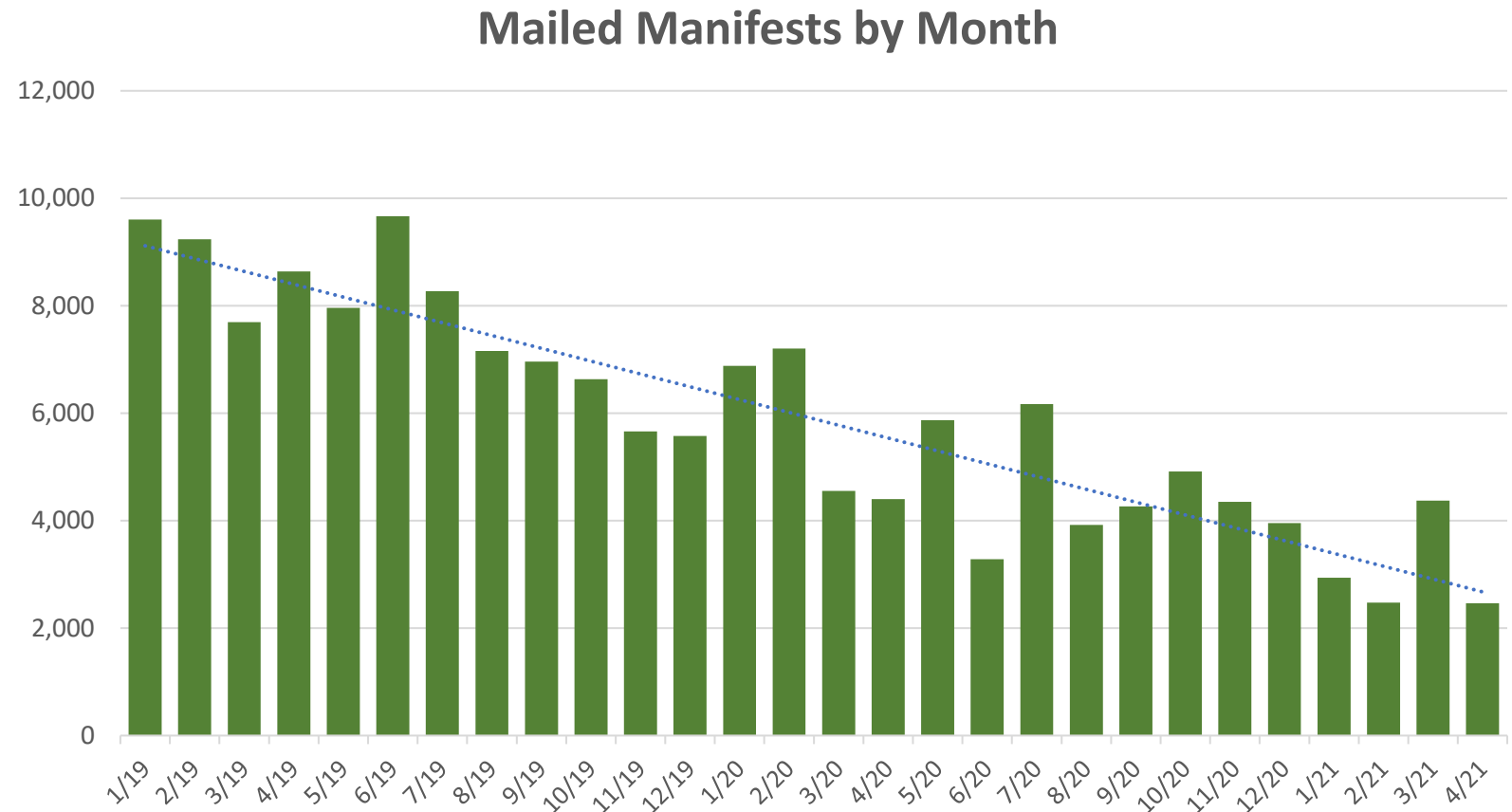

MAILED MANIFEST SUBMISSIONS PER MONTH

e-Manifest

- The number of mailed manifests have been decreasing
 - Currently only a few facilities continue to mail, and we are working with them to transition



- Registered user flag demo
 - How to tell if a site has a registered user and whether that user can sign e-Manifests or not
- Security questions
 - How to reset your e-Signature security questions
- Copy manifest
- Site Search API (Coming May 28th)
 - API to Search for Sites based on address information to help sites ensure they are using the correct handler ID
