WORK HANDLED BY UNITED STATES ATTORNEYS' OFFICES
DURING FISCAL YEAR 1965

CRIMINAL CASES

FILED - Criminal filings amounting to 33,667 showed an increase of 666 or 2.0 per cent from the number filed in the previous fiscal year. About 79 per cent of the total was in 15 offenses having 500 or more cases; ten showed increases while five showed decreases. The largest increases occurred in Narcotics (1,970 to 2,369), Immigration (2,751 to 3,302) and National Motor Vehicle Theft Act (4,788 to 4,994). Counterfeiting and Forgery dropped from 2,285 to 2,017 and National Stolen Property Act (1,157 to 1,106), Liquor dropped from 3,659 to 3,190. Embezzlement (1,141 to 1,199) and Crimes on Federal Reservations (532 to 541) showed slight changes. Increases took place in 44 districts ranging from 784 in Northern California to 3 in Montana and Southern Alabama while decreases ranging in 172 in Eastern Michigan to 3 occurred in 48 districts.

TERMINATED - Cases terminated decreased 145 or .4 of one per cent under the previous years' total. Of the total of 32,529 closed, 23,250 involving 25,757 defendants were by plea of guilty, 2,449 (involving 3,221 defendants) were found guilty after trial and 833 (involving 1,319 defendants) not guilty.

PENDING - With 11,234 cases, the pending caseload showed an increase of 11.3 per cent over 10,096* cases pending at the close of fiscal year

1964. 9,538 were in a triable status while 1,696 were in a fugitive or other status beyond the control of the United States Attorneys.

GRAND JURY PROCEEDINGS

Grand Jury Proceedings comprised of 16,950 indictments and 561 No True Bills amounted to 17,511 an increase of 6.3 per cent over the previous fiscal year for the highest total since fiscal year 1954.

CRIMINAL COMPLAINTS

RECEIVED - Complaints received reached 122,401 for the highest total in the history of the Department. This is 1.3 per cent more than the 120,860 received in fiscal year 1964. Southern California with 10,591 had the most complaints and Western Texas with 4,973 and Northern California with 4,527 were the next highest. 84,228 of the complaints were in eleven offenses as shown below:

CLOSED - 88,790 complaints were closed during 1965 without reaching court dockets. Of this number, 77,315 or 87.1 per cent of the total were closed by declination of prosecution.

PENDING - Criminal complaints pending as of June 30, 1965 rose to 13,809, an increase of 238 or 1.8 per cent over the 13,571 pending as of June 30, 1964.

CIVIL CASES

FILED - Civil cases filed amounting to 28,839 exceeded the previous all time high of 28,361 filed in fiscal year 1964 by 1.7 per cent or 478. 51 districts had increases, two had the same and 39 districts showed decreases from the previous year. 13,284 or 46.1 per cent of the total was in sixteen districts having filings ranging from 532 to 1,477. Tax Lien cases with 4,974 and Tort cases with 2,045 had 17.2 and 7.1 per cent respectively of the cases filed.

TERMINATED - With 51 districts showing increases, civil cases terminated rose to an all time high of 28,093. This total exceeded fiscal year 1964's total by 765 or 2.8 per cent. Increases ranged from 224 in Eastern New York to 1 in Canal Zone while decreases ranged from 3 in Western Kentucky to 175 in Northern Ohio.

1,110 were cases in which the government as defendant was sued for \$119,458,004. 650 of them involving \$75,630,466 were closed by compromises amounting to \$9,317,287 and 201 involving \$12,809,311 resulted in judgments against the government amounting to \$4,036,335. The remaining 259 cases involving \$31,018,227 were won by the government thus bringing the savings to \$106,104,382, a decrease of \$11,070,599 or 9.4

per cent from the \$117,174,981 saved in fiscal year 1964.

PENDING - Civil cases pending as of the close of the fiscal year increased by 746 or 3.2 per cent to 24,082. 11,049 or 45.9 per cent of the caseload was in fourteen districts with caseloads ranging from 1,428 in Eastern New York to 441 in Kansas. Tax Lien cases with 4,134 dropped to 17.1 per cent of the total as compared to 4,509 or 19.2 per cent of the total pending as of June 30, 1964. Land cases with 2,118 or 8.8 per cent decreased from 2,952 or 12.5 per cent of the total.

CIVIL MATTERS

RECEIVED - 36,516 civil matters, an all time high were received during the fiscal year. This is an increase of 1.6 per cent over the 35,948 matters received in fiscal year 1964. Tax Lien matters with 5,024 and Tort matters with 2,118 comprised 13.8 per cent and 5.8 per cent respectively of the total. 1,085 or 30.4 per cent of the total were in nine districts having totals ranging from 1,029 in Middle Florida and New Jersey to 1,812 in Eastern New York.

TERMINATED - Civil matters terminated without reaching court dockets amounted to 7,393, a decrease of 17.4 or 1,552 from the fiscal year 1964 total of 8,945.

PENDING - 13,008 civil matters were pending as of June 30, 1965 as compared to 12,383 as of June 30, 1964. This is an increase of 625 or 5.0 per cent.

MAN-HOURS

A total of 174,342 man-hours were spent in court during fiscal year 1965. Following is a breakdown of those hours.

Based on an average employment of 668.5 each Assistant United States Attorney averaged 21.7 hours per month in courtroom work during the fiscal year.

COLLECTIONS

Collections for fiscal year 1965 reached \$65,065,005, an increase of \$8,674,201 or 15.3 per cent over the \$56,390,804 collected in fiscal year 1964. This year's amount represents a return of \$3.40 for each dollar of the \$19,115,000 appropriated for United States Attorneys' Offices for the year ending June 30, 1965.

PERSONNEL

During the year United States Attorneys' employment averaged 1,741

employees, 336 employees were appointed and 297 were separated a net increase of 39 and 1,758 were on the rolls as of June 30, 1965. Cases handled per Assistant United States Attorney increased from 140.4 in fiscal year 1964 to 143.5 in the current year while cases terminated increased from 90.0 to 90.7

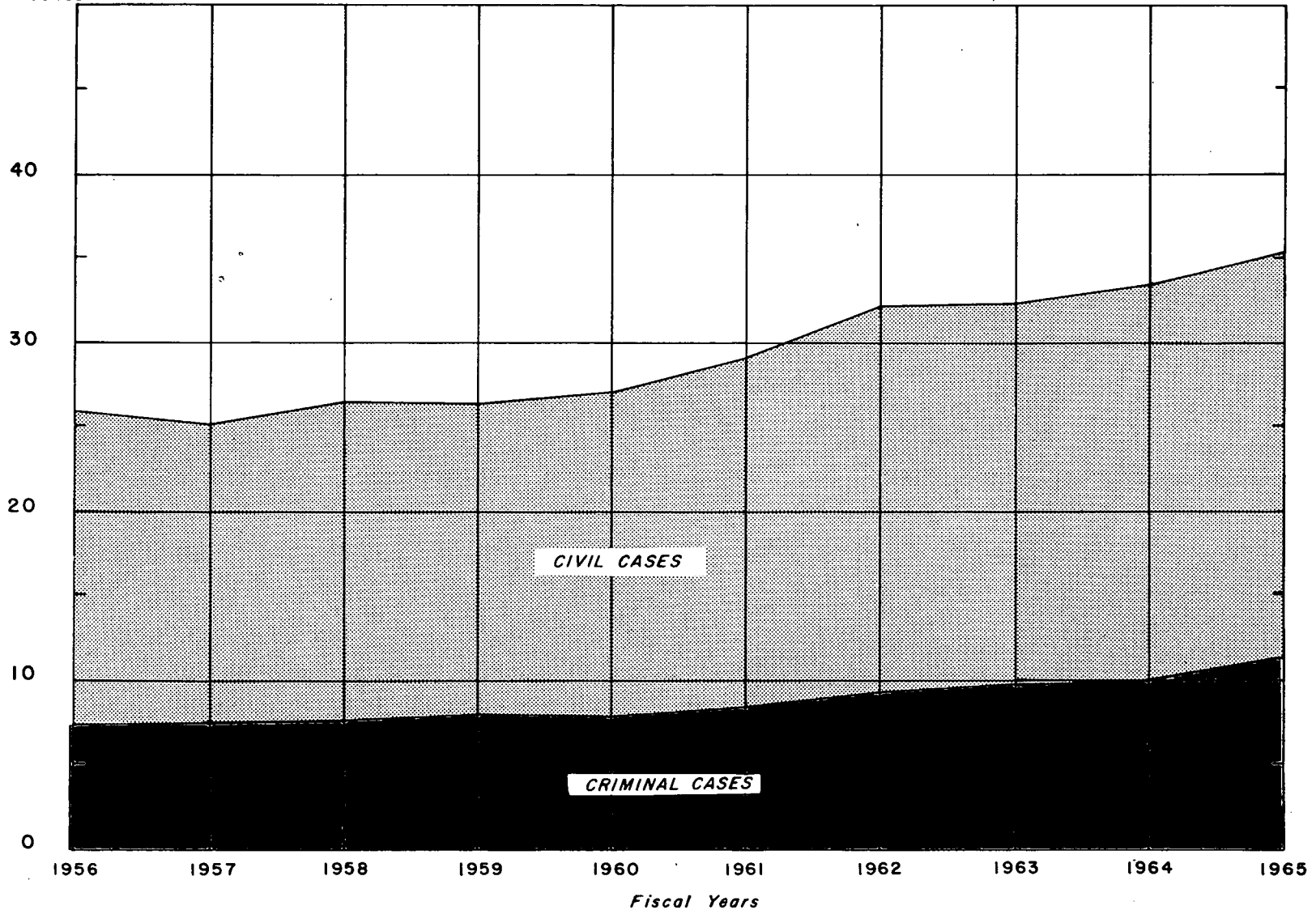

IN UNITED STATES ATTORNEYS' OFFICES

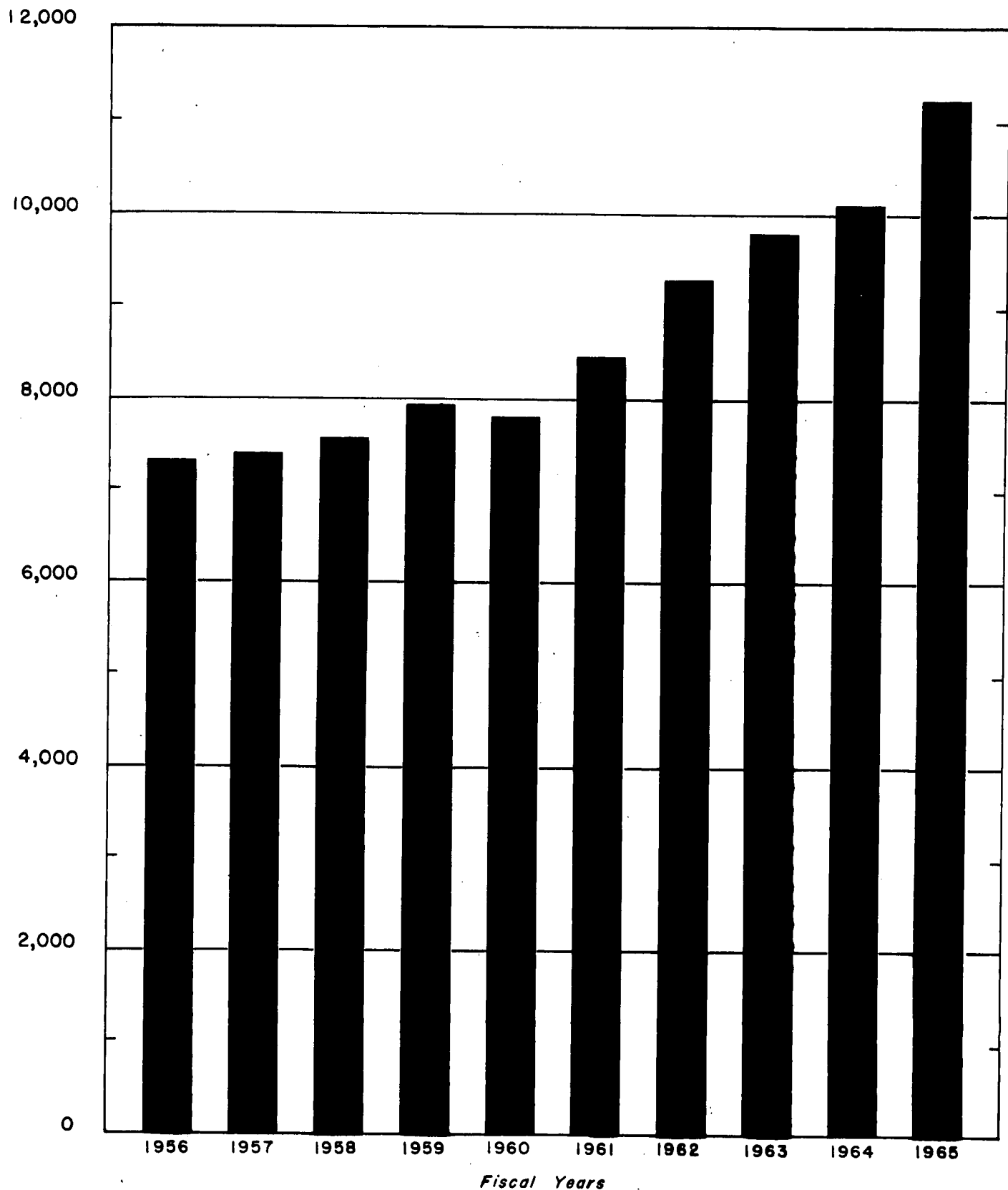

TOTAL 11,234 CASES

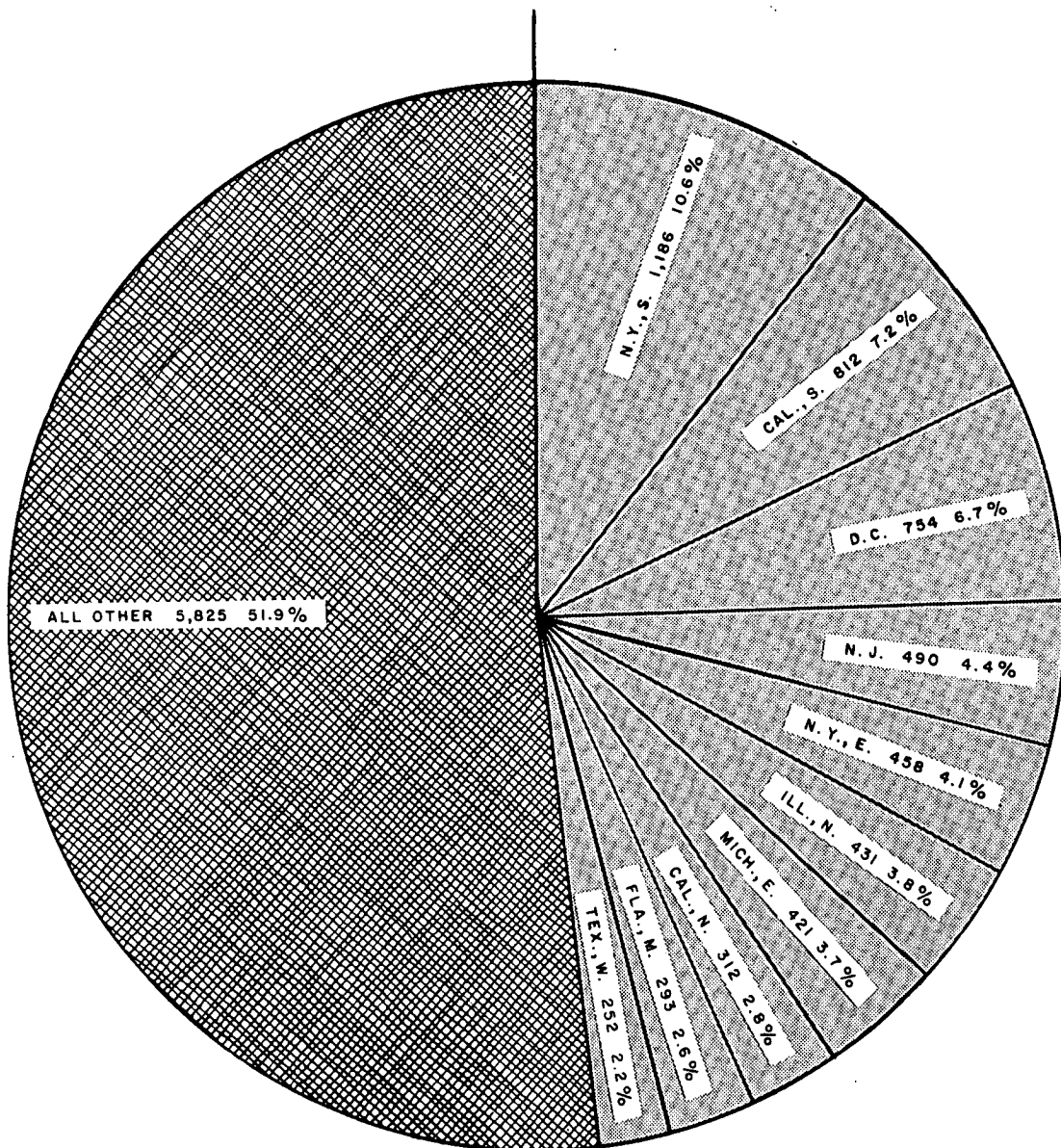

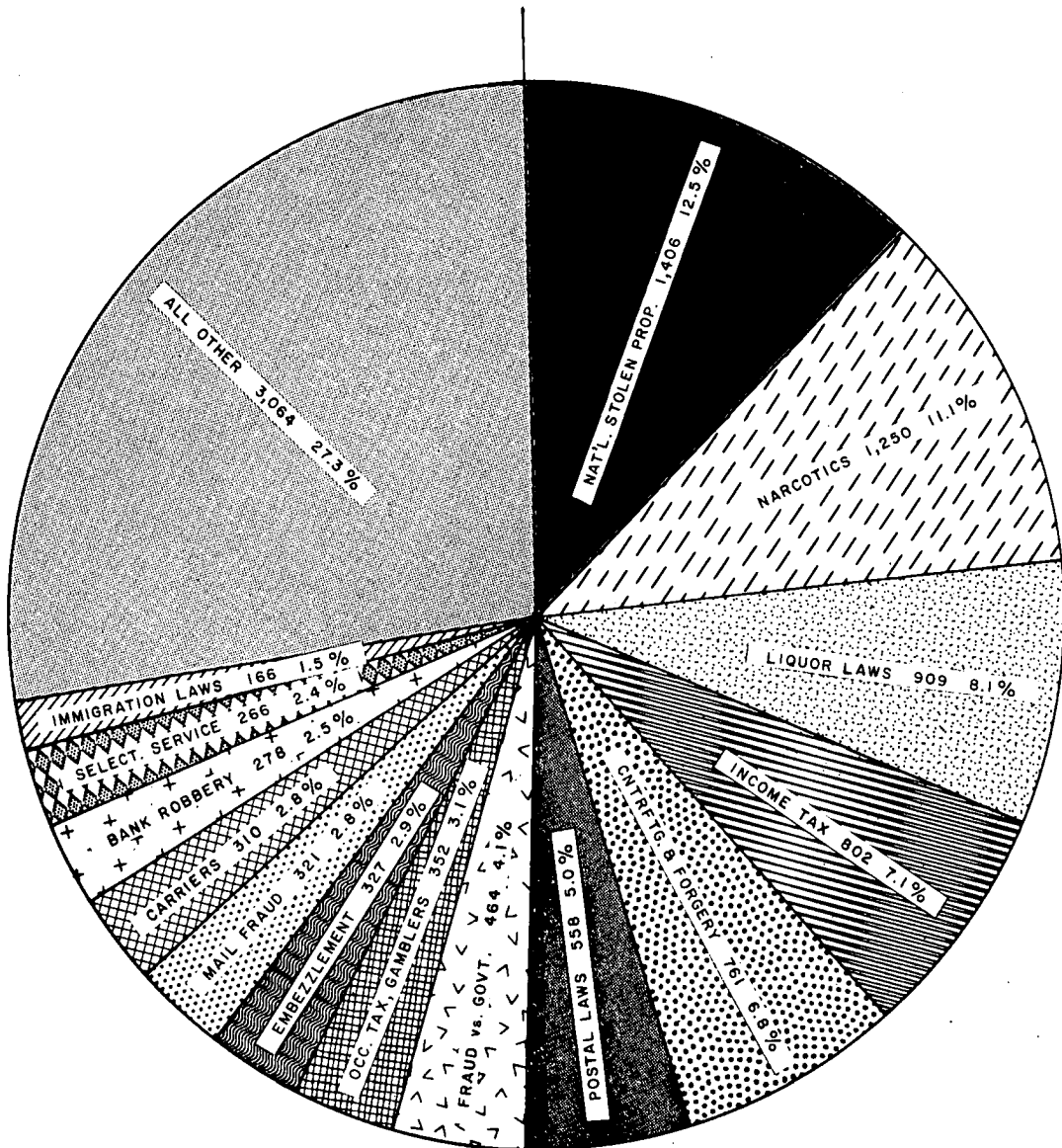

TOTAL 11,234 CASES

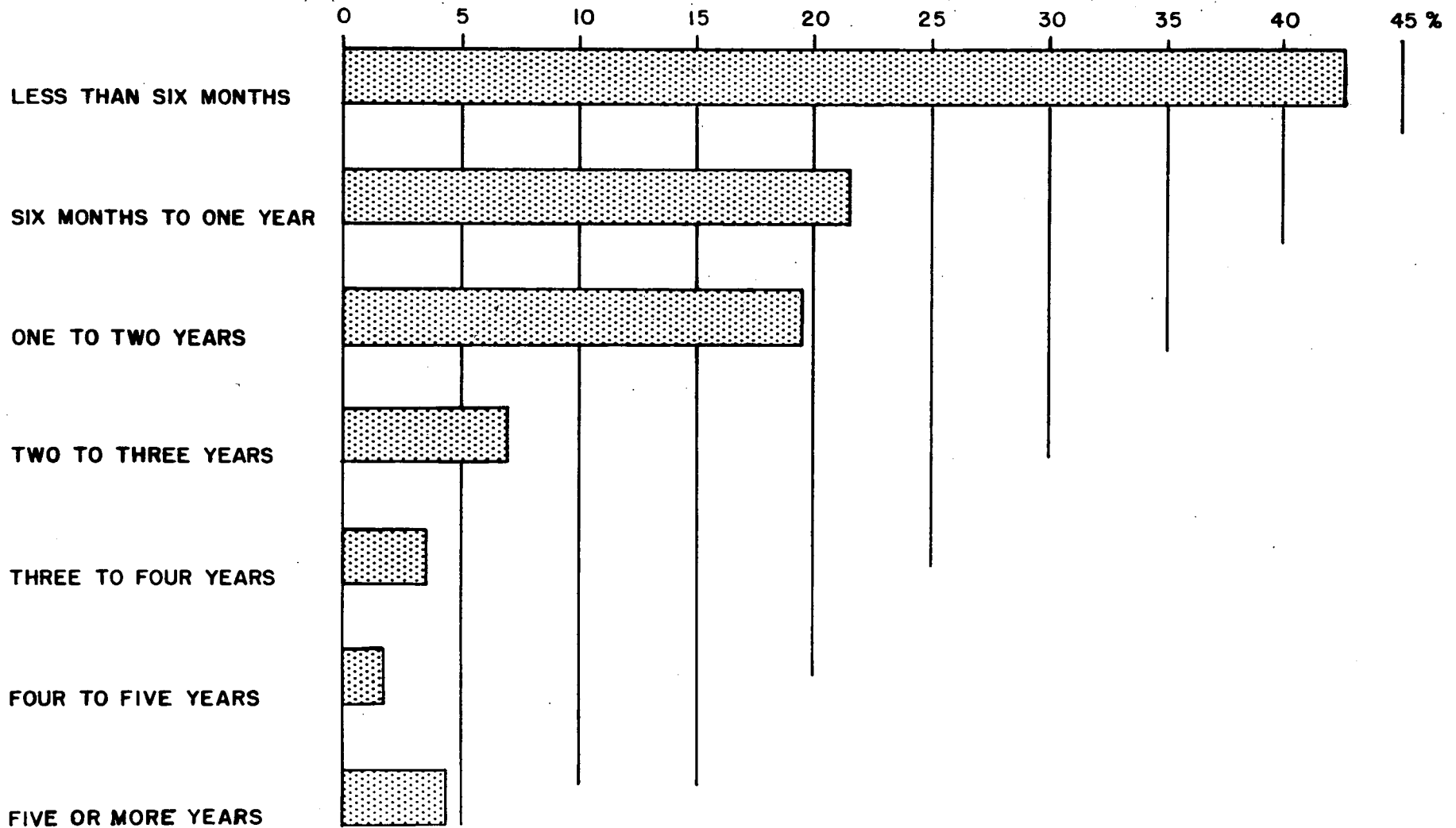


CHART NO. 6

IN UNITED STATES ATTORNEYS' OFFICES

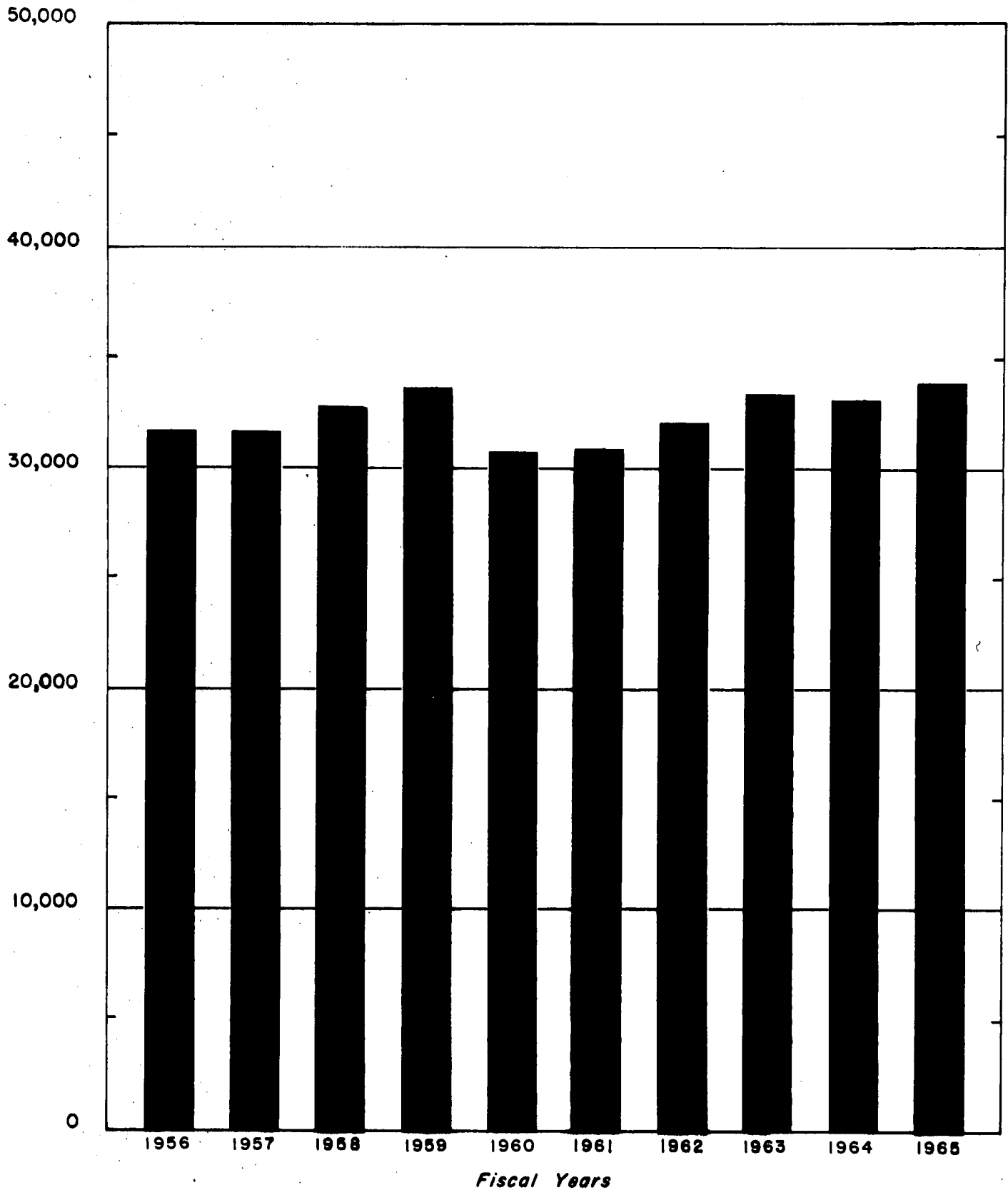

CRIMINAL CASES FILED IN UNITED STATES ATTORNEYS' OFFICES

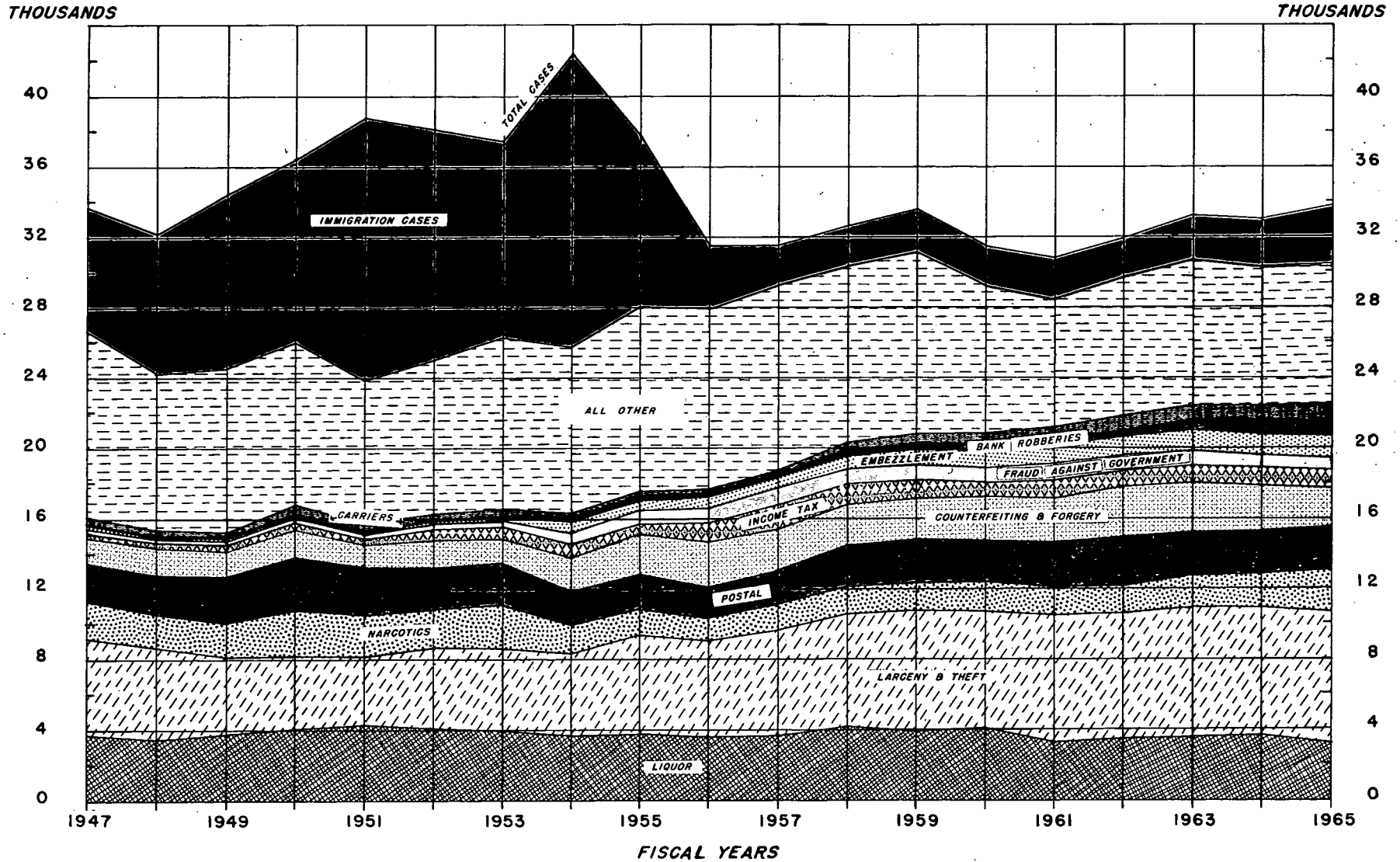

PROCEEDINGS BEFORE GRAND JURY IN UNITED STATES ATTORNEYS' OFFICES

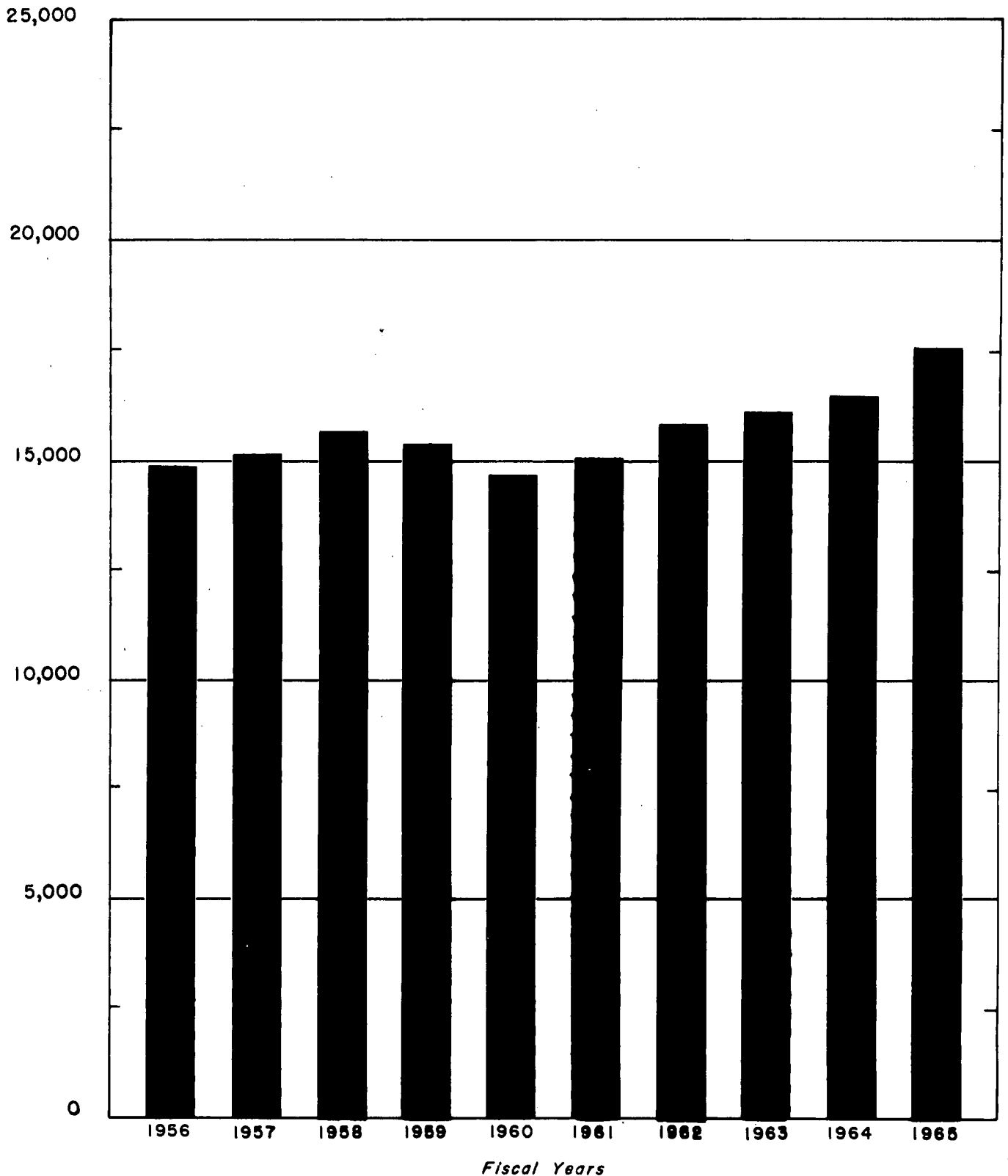

CRIMINAL CASES TERMINATED IN UNITED STATES ATTORNEYS' OFFICES

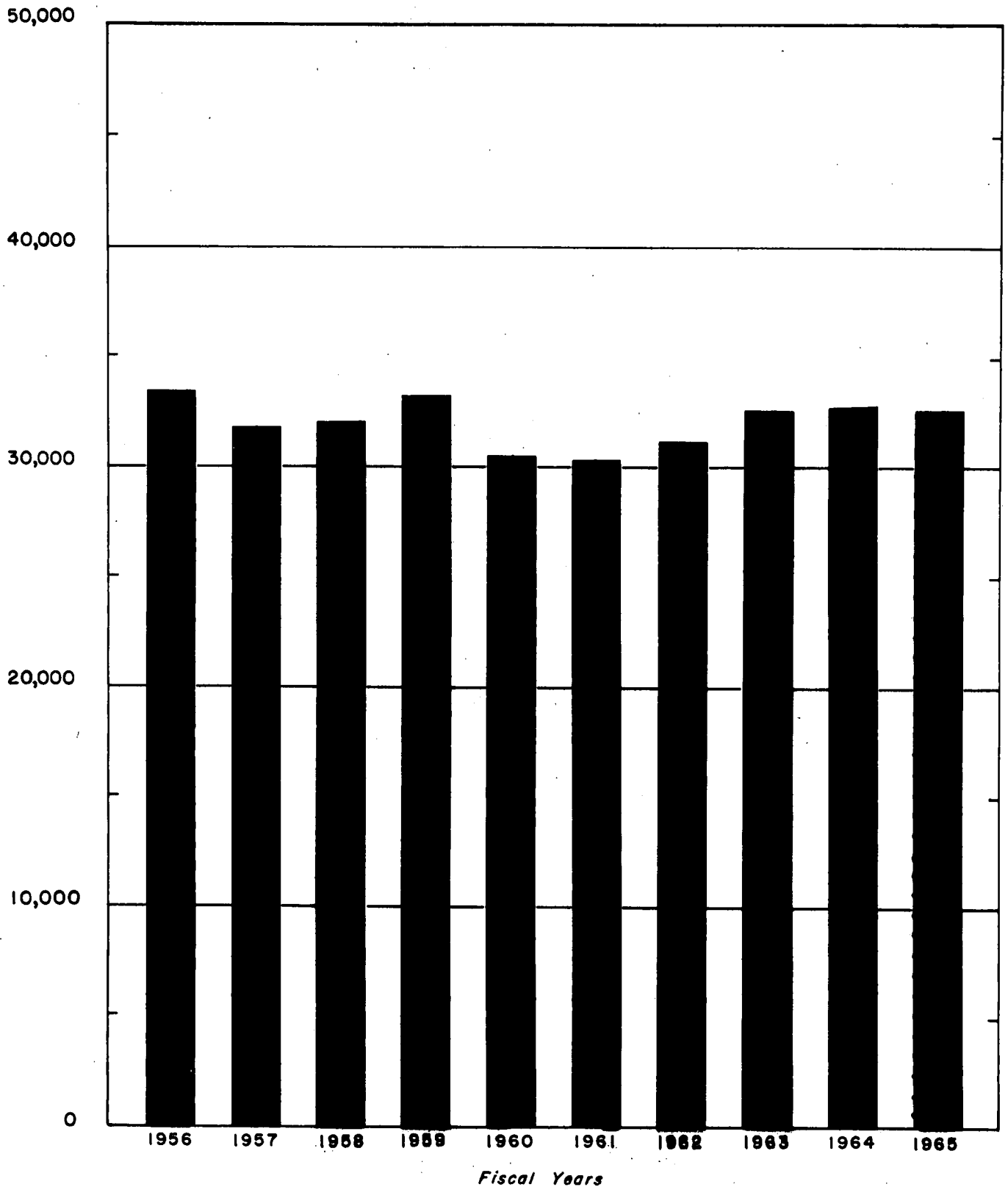

TRIALS IN CRIMINAL CASES IN UNITED STATES ATTORNEYS' OFFICES

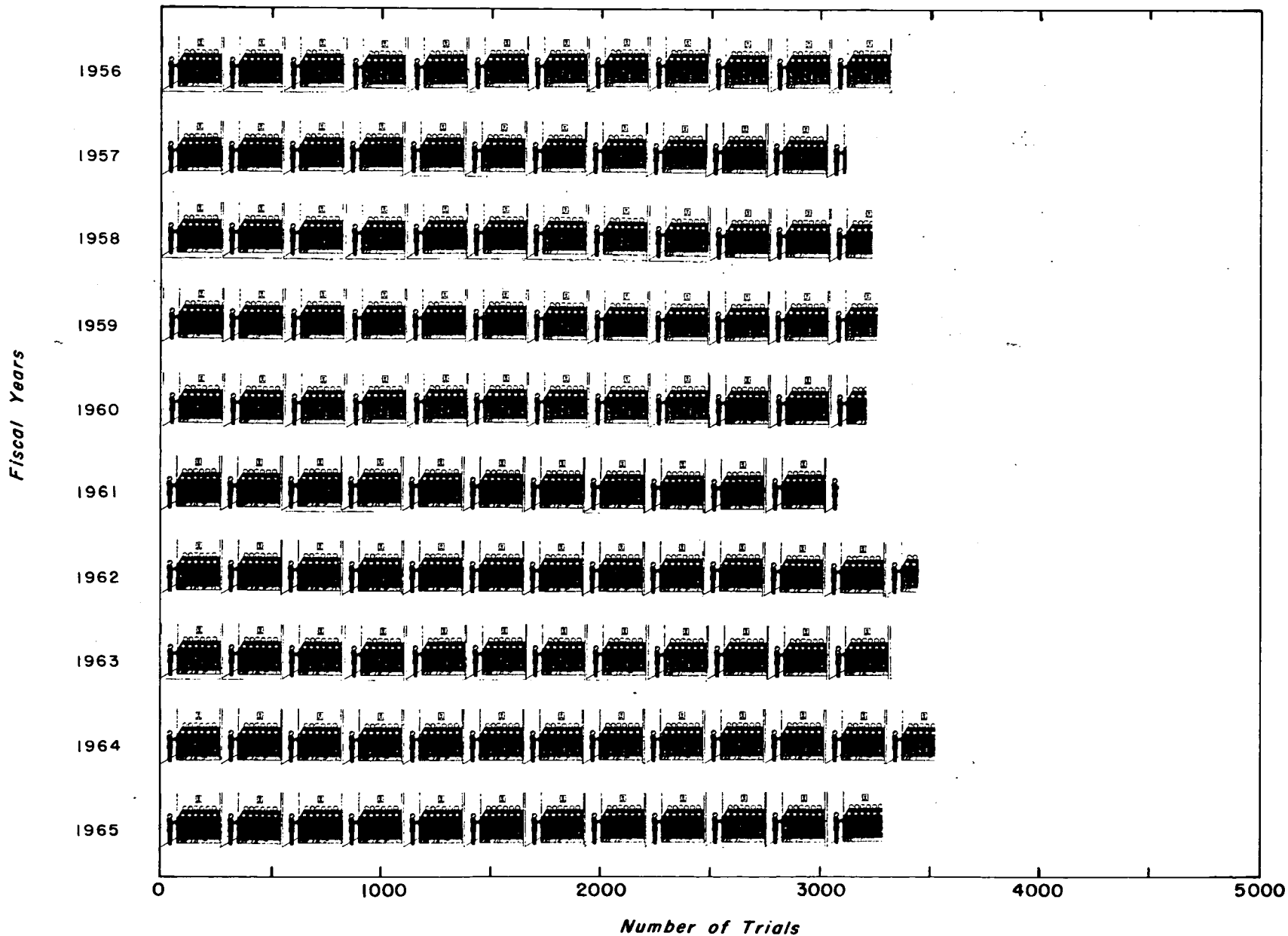

IN UNITED STATES ATTORNEYS' OFFICES

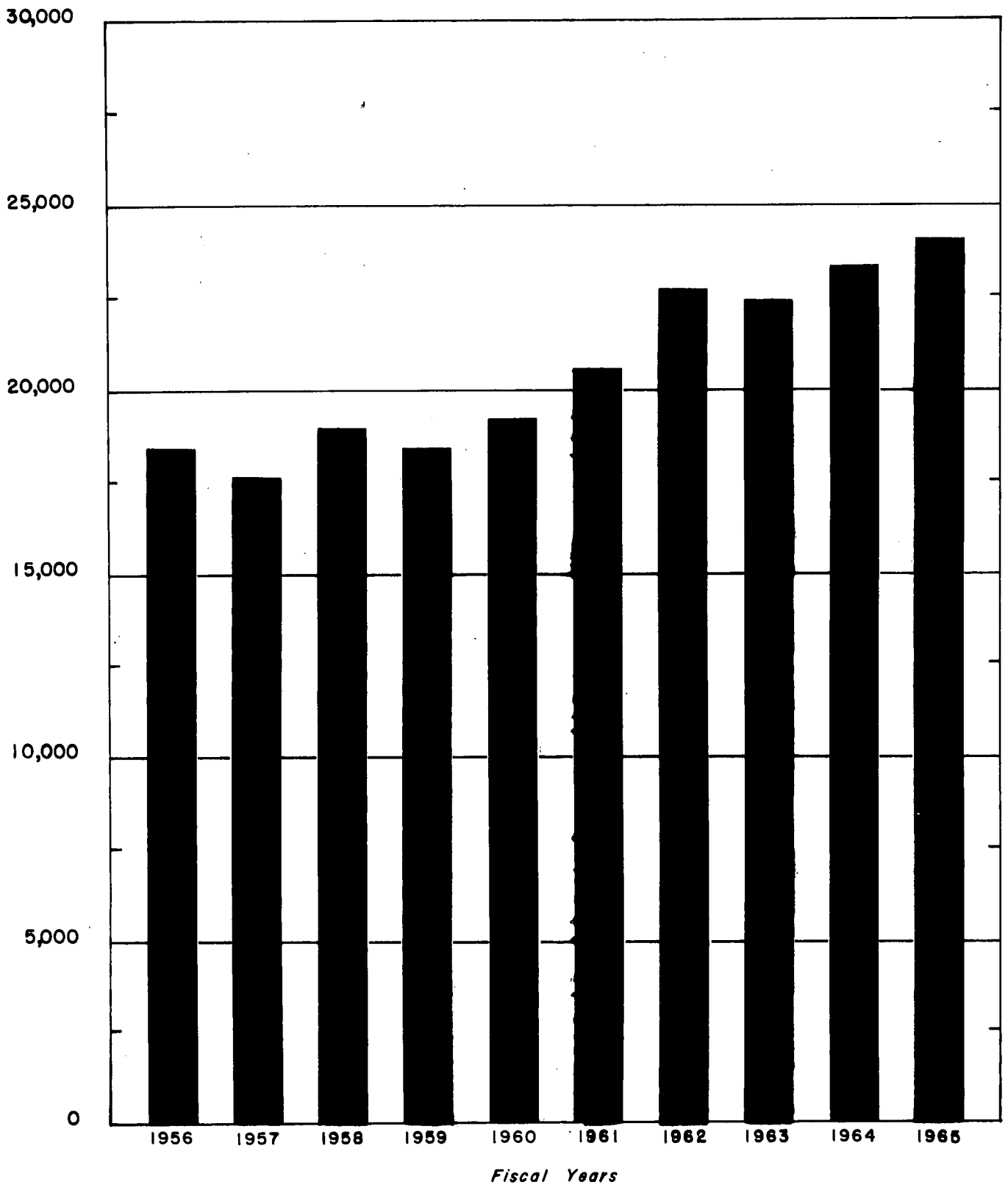

TOTAL 24,082 CASES

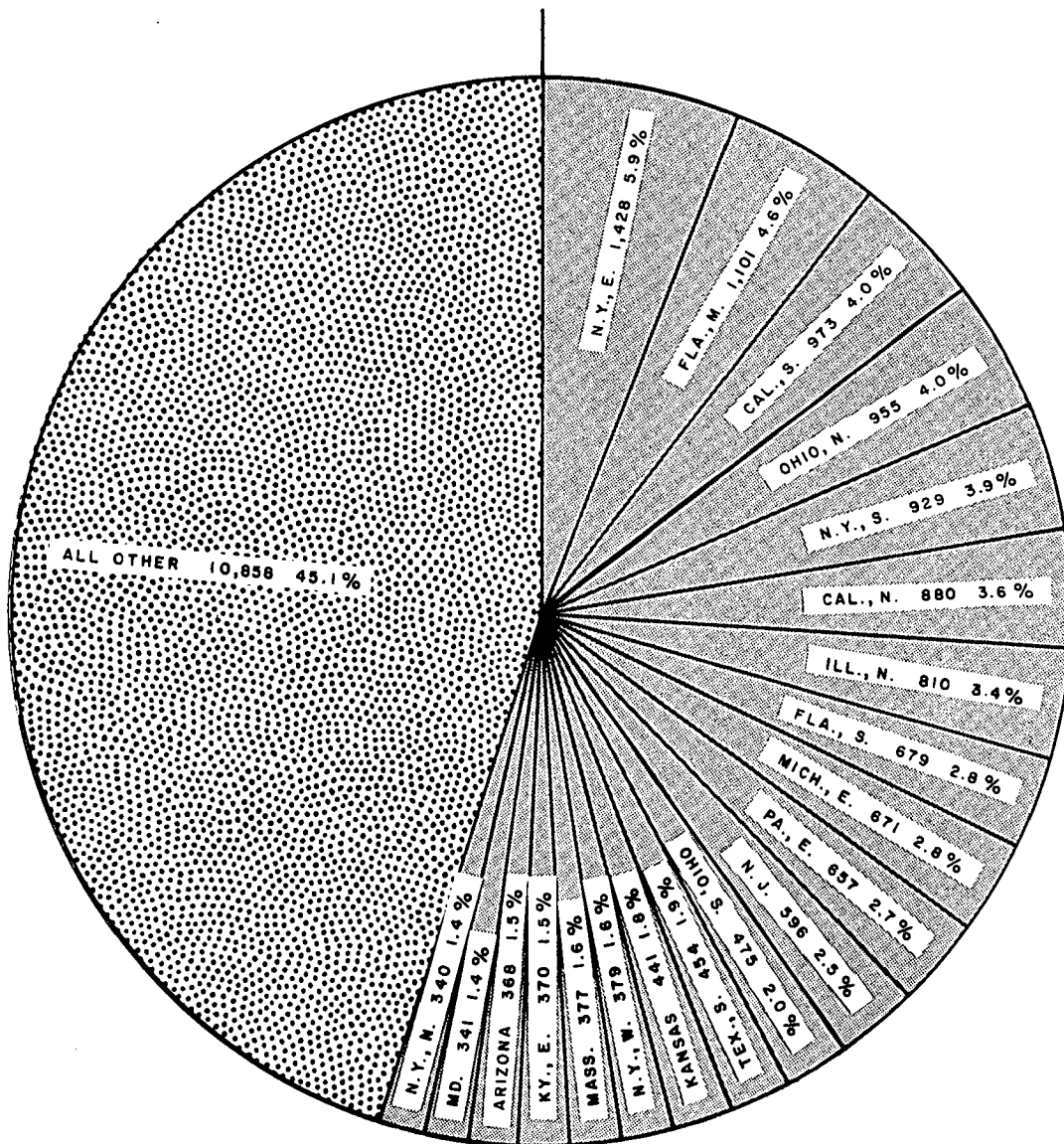
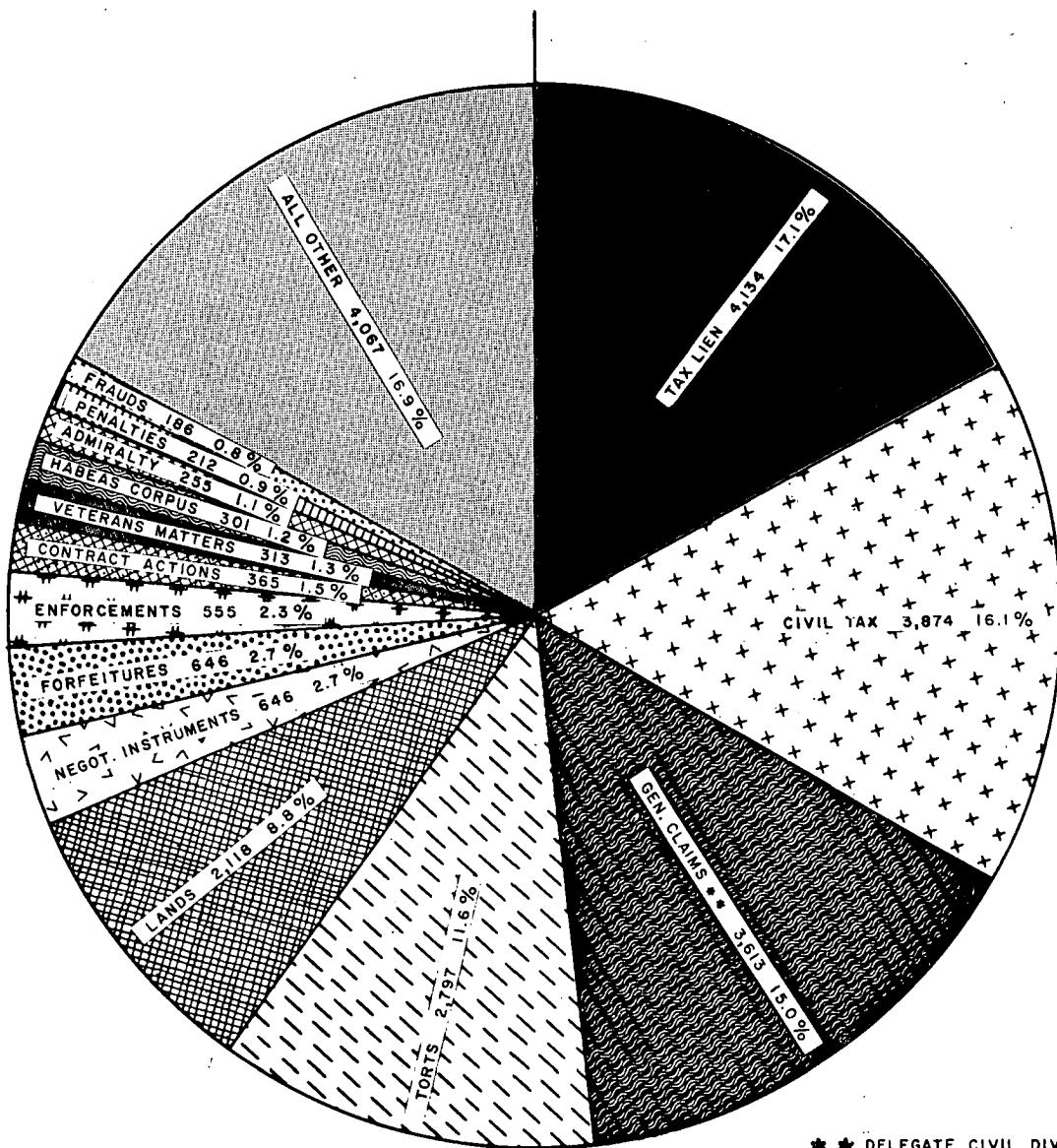

TOTAL 21,964 CASES

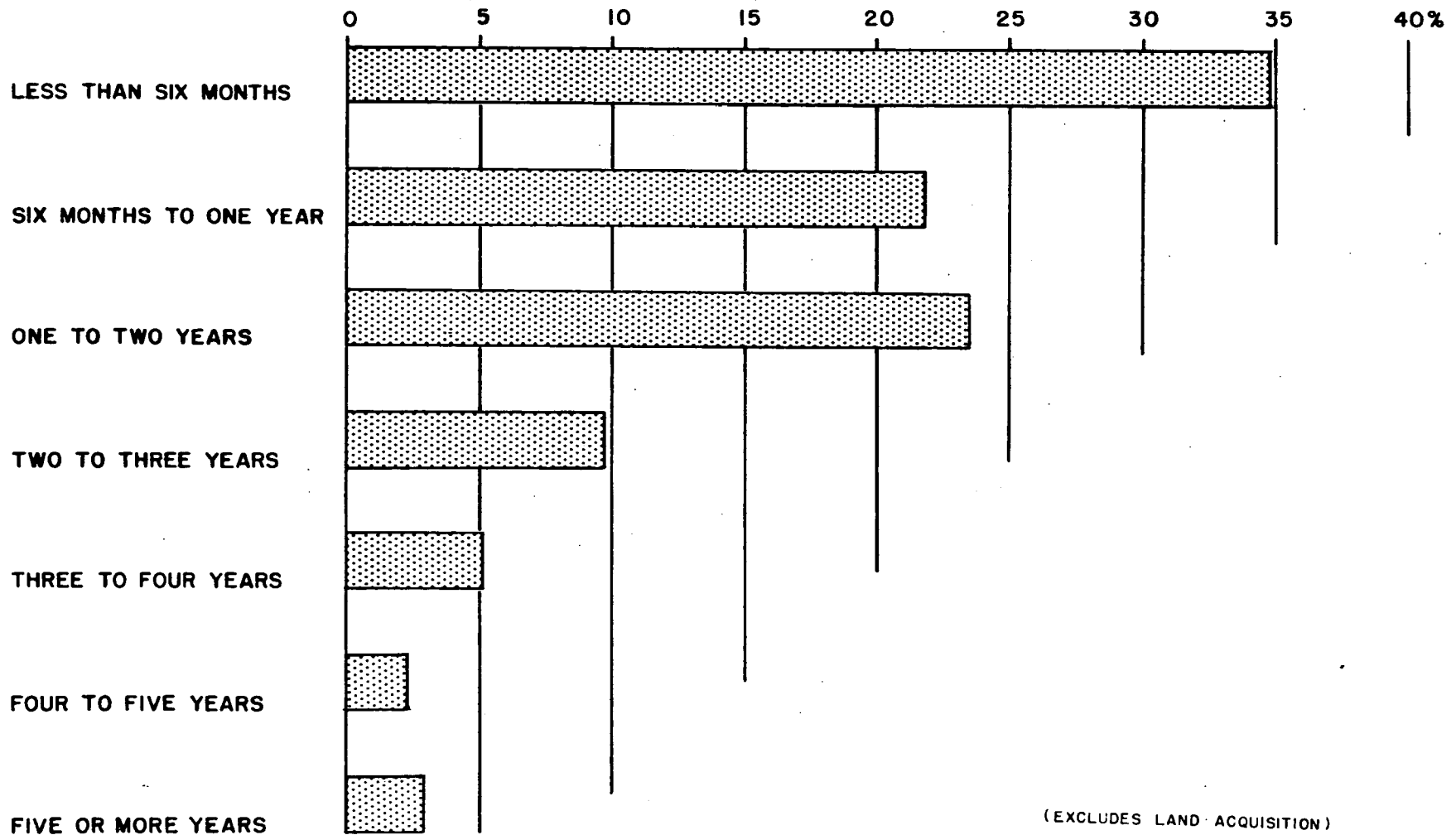

IN UNITED STATES ATTORNEYS' OFFICES

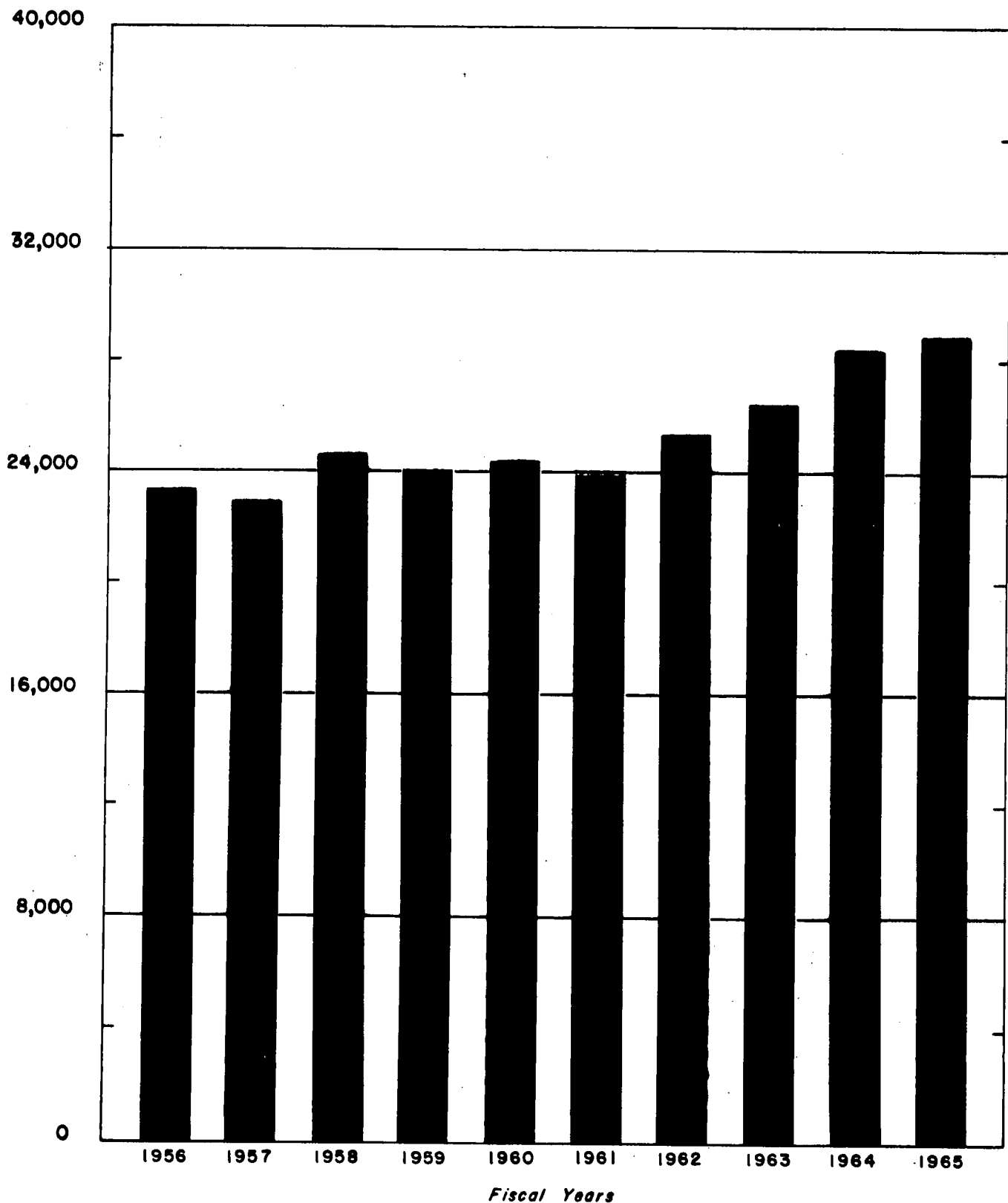

CIVIL MATTERS RECEIVED IN UNITED STATES ATTORNEYS' OFFICES

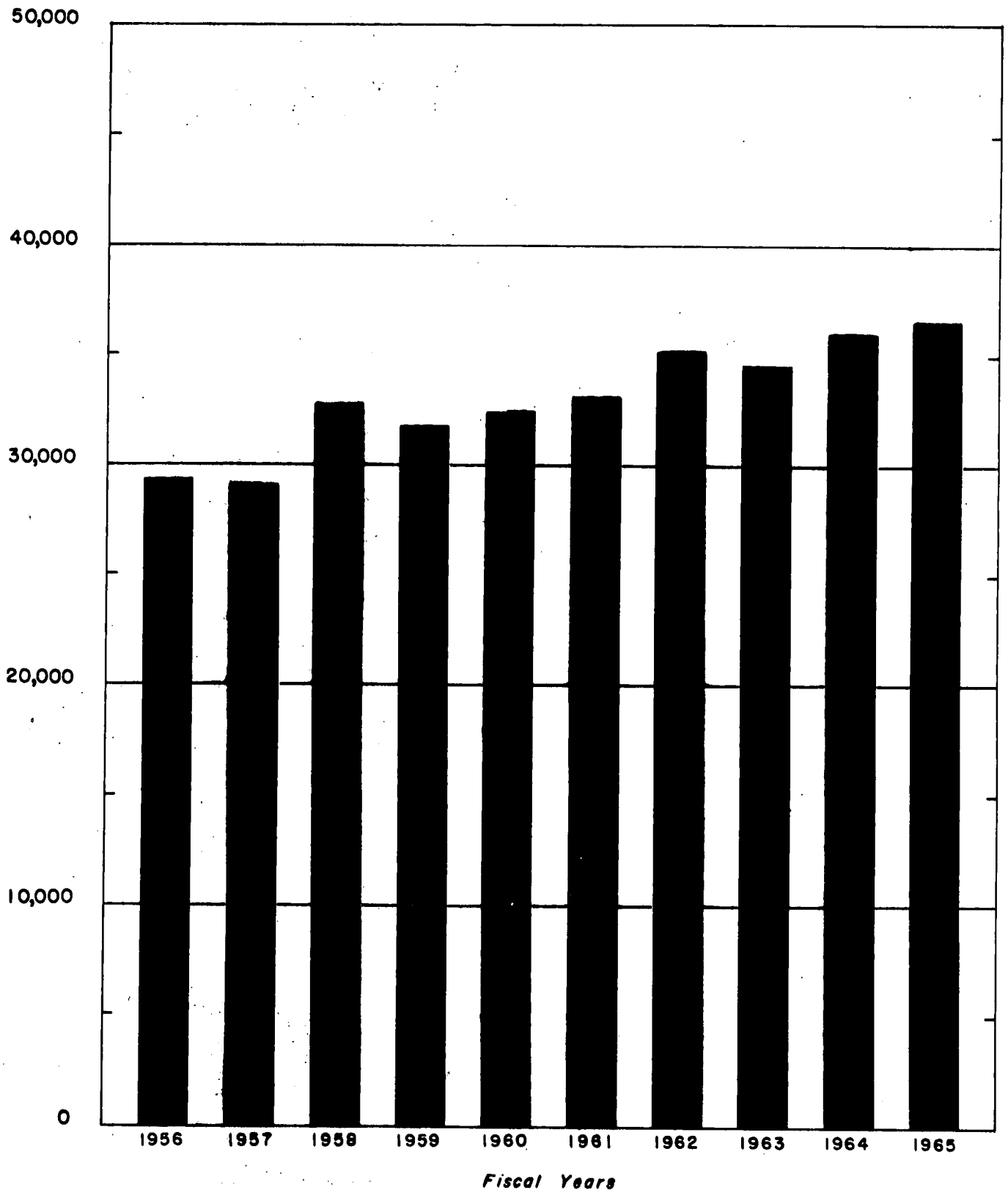

IN UNITED STATES ATTORNEYS' OFFICES

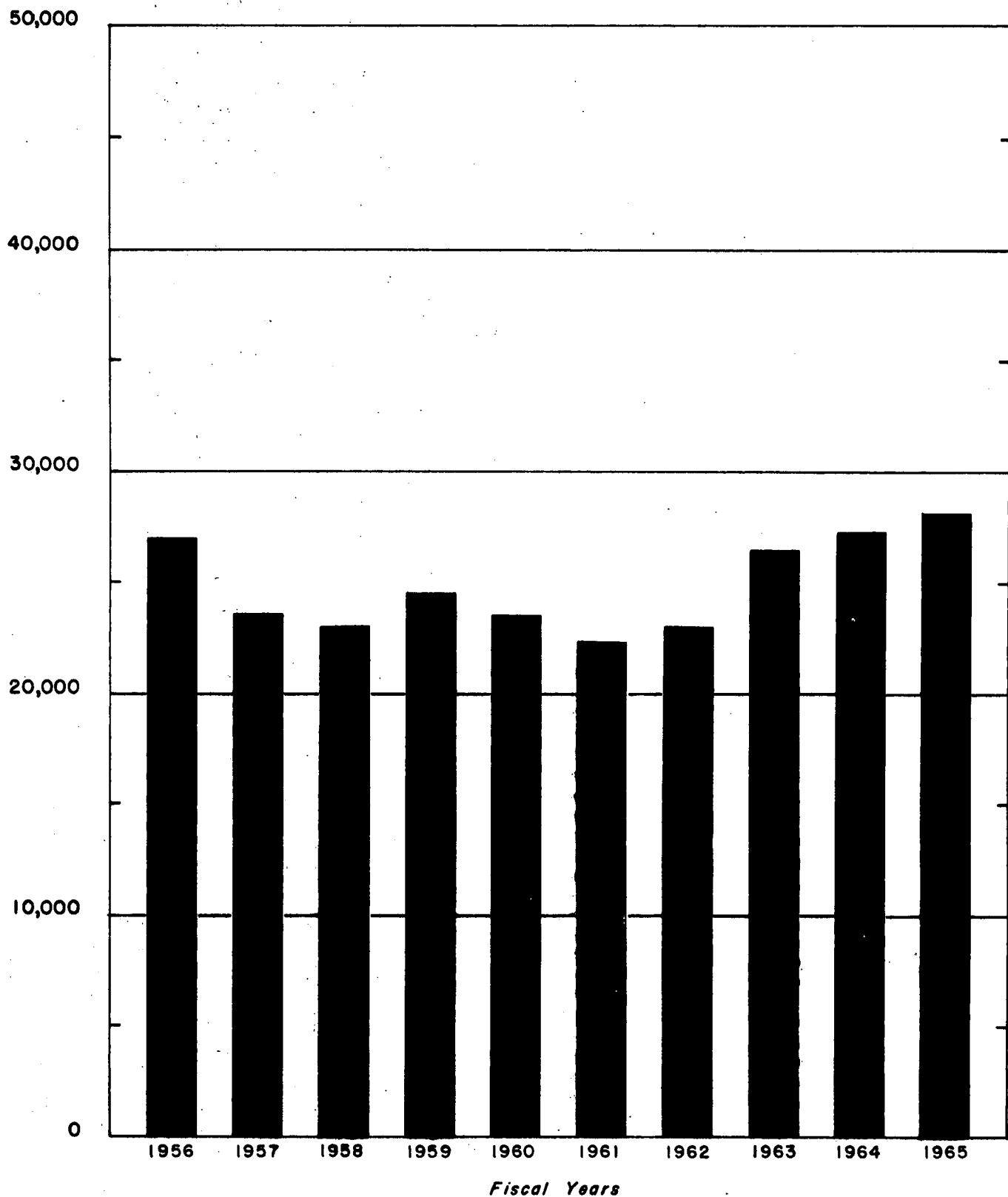

Millions of Dollars

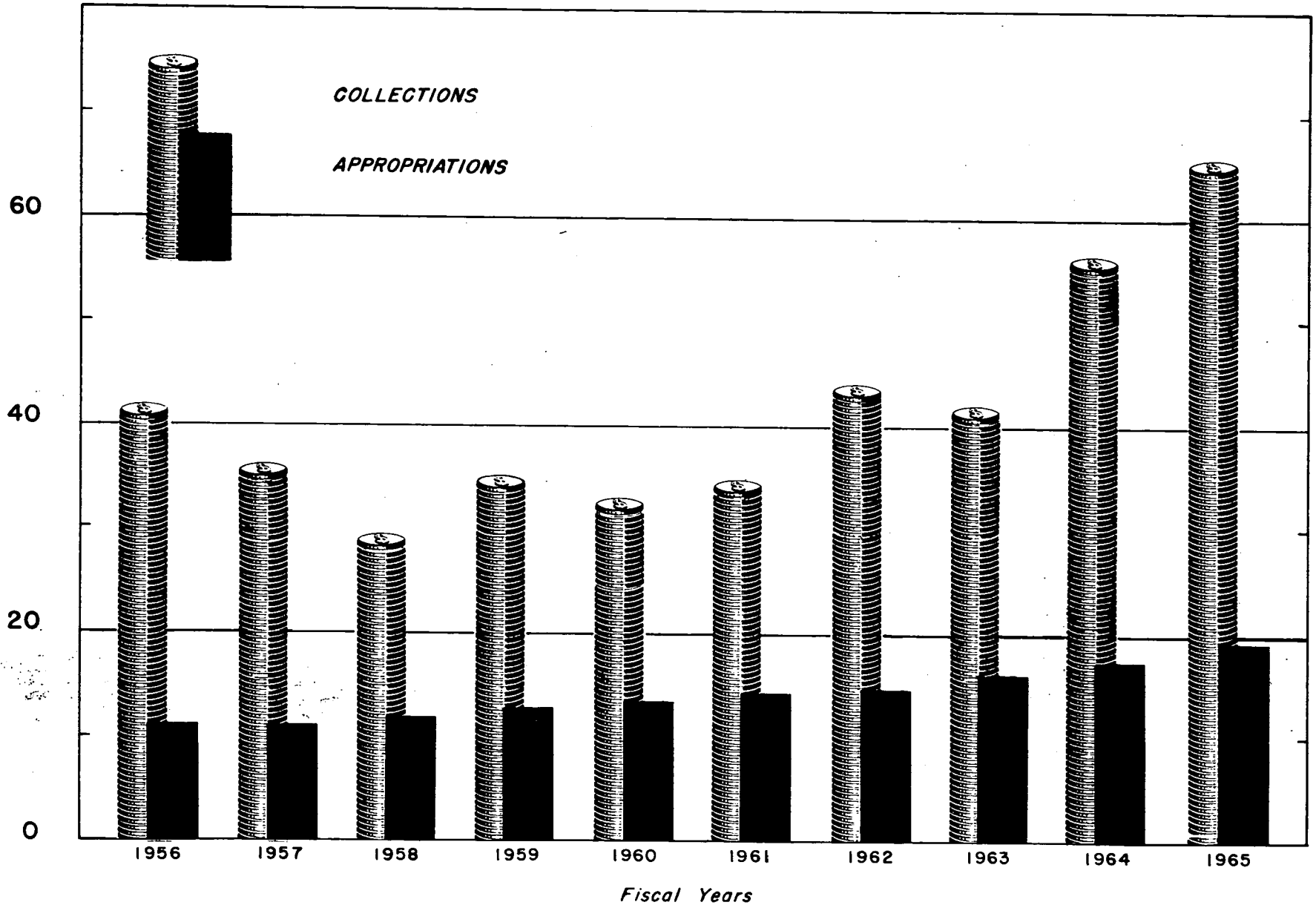

IN UNITED STATES ATTORNEYS' OFFICES

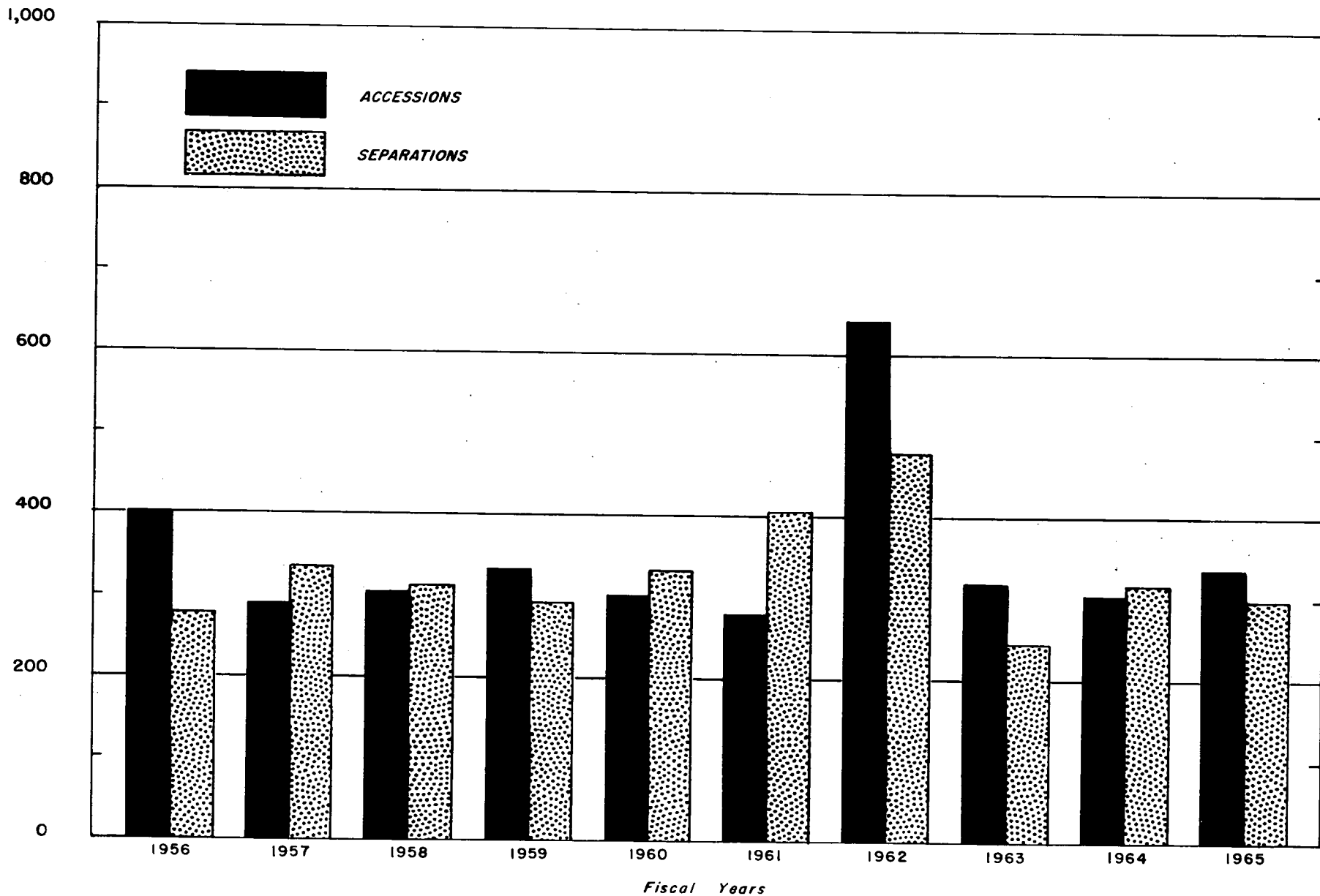
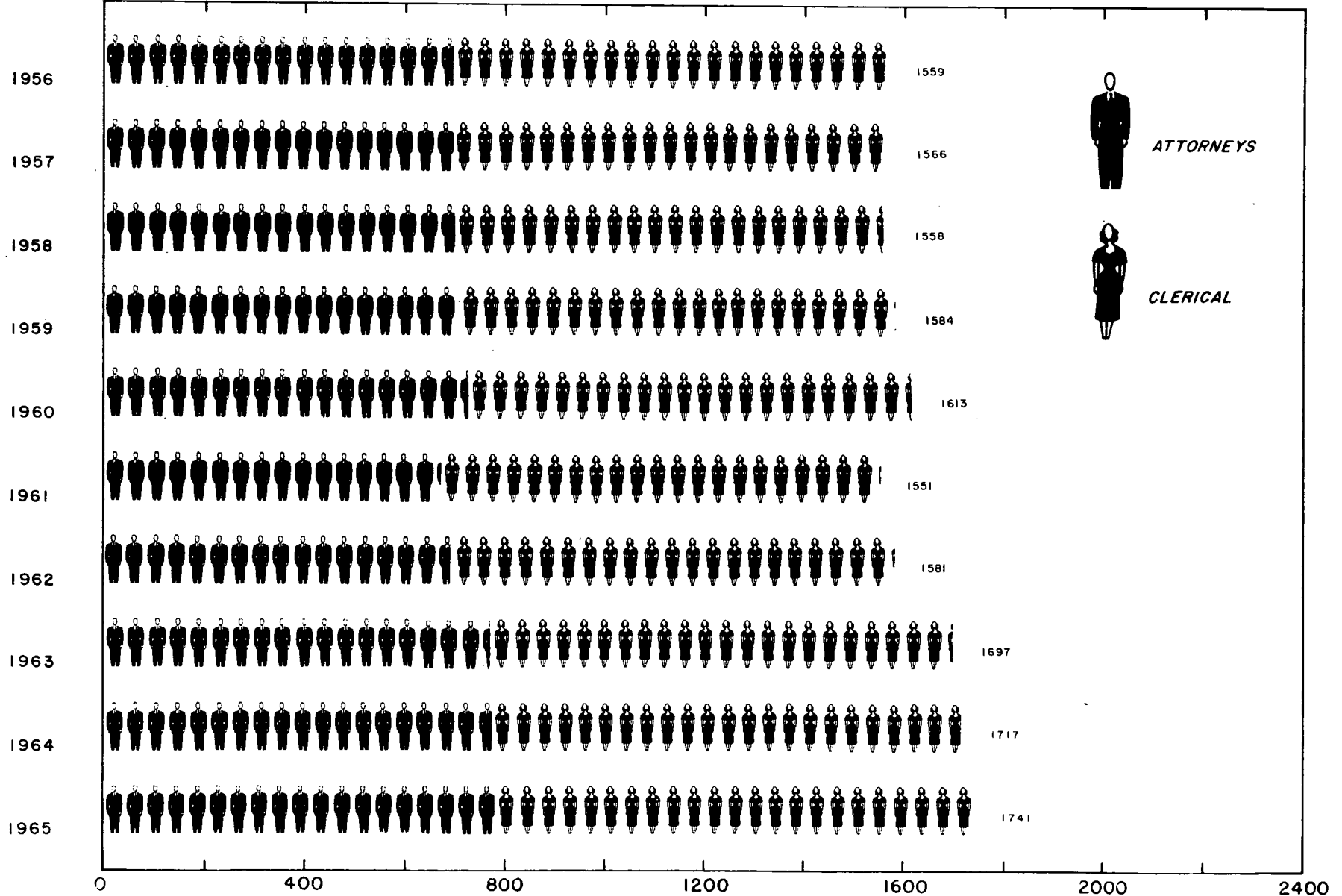
