COVERED PROJECTS: means one or more of the following:

A. Residential

500 ft² or greater

Renovation of a kitchen and/ or bath facility regardless of ft² or value.

Renovation, remodel, or addition to an existing structure that is equal to or greater than 500 ft² and/ or exceed \$20,000.

Development and any new structure that is equal to or greater than 1,000 ft² and/ or exceed \$20,000.

Multi-family structure new or existing that is equal to or greater than 1,000 ft² and/ or exceed \$20,000.

B. Commercial

Renovation, remodel, or addition to an existing structure that is equal to or greater than 1,000 ft² and/ or exceed \$20,000.

Development and any new structure that is equal to or greater than 1,000 ft² and/ or exceed \$20,000.
