Message from Vice President, Sales & Marketing

The uncertainties of the COVID-19 pandemic continue in 2022. It has taken its toll on American industry, with hundreds of thousands of businesses (mostly small) being forced to close, and millions of workers being furloughed or let go permanently. It continues to offer challenges in every economic sector.

As the new book, *Prepare for Crisis—Plan to Thrive*, by our President & CEO, Tom Raffio, and the theme of our 2021 Annual Report, remind us, laying a sound foundation before crises occur can make it possible to thrive, not just survive, a crisis when it occurs. Our foundational business principles, largely those of the Baldrige Performance Excellence Program and those embodied in servant leadership, have helped us be resilient and innovative throughout another year of pandemic trials.

We ended 2021 with strong results and with promising leads for many new customers in 2022. Last year we accomplished a net gain of 17,866 new primary dental subscribers and a net gain of 4,944 DeltaVision® subscribers. Group subscriber retention was a remarkable 98.8% (industry average is 87%), and our individual and family retention rate (always lower) was 88%. Our network of participating

dentists is the region's largest, with 87% (1,807) of all dentists in the tri-state region participating in our PPO, Premier, or both networks. In 2021, we processed more than 1.9 million claims for payment, with an average adjudication speed of just 1.4 days.

I am very pleased to report that as of January 31, 2022, Northeast Delta Dental eclipsed the **1,000,000** covered lives mark! This accomplishment was a five-year goal that we achieved a full year ahead of schedule, despite the pandemic. Collectively, the Delta Dental system covers more than 83,000,000 people nationwide, making us by far the largest provider of dental coverage in the country.

A New Report on Oral Health in America

The National Institute of Dental and Craniofacial Research recently released *Oral Health in America: Advances and Challenges*, a comprehensive report on oral health in America, more than two decades after the release of *Oral Health in America: A Report of the Surgeon General*, the first national report on oral health and its links to overall health and wellness. This new report concludes that while we have made progress over the last 20 years, there is a lot more work to be done to make oral health care more widely available.

Section 4 of the document, Oral Health Workforce, Education, Practice, and Integration, includes many statistics on the makeup of the dental workforce in the United States and dental profession trends. Roughly 200,000 dentists are actively practicing in the U.S., 158,000 as general dentists and the remainder as specialists. Women dentists made up 33% of active dentists in 2020, and, in general, their male counterparts are older. Female students make up 50% of dental school classes, and a shift to more female dentists actively practicing in the next generation is expected.

Dentists typically have the highest total cost of education of the major health professions (in 2020 ~\$350,000). This impacts where young dentists choose to practice (urban, suburban, or rural, and average household income of community).

Dental hygienists and assistants are 95% female. The average total costs of tuition and fees in accredited dental hygiene programs for the 2018-2019 academic year ranged from \$29,018 to \$42,839.

Their study found that "dental insurance provides important financial support for patients in seeking regular dental care and often identifies specific dental offices for the patient to consider. Thus, dental insurance is critical to the financial success of America's dental practice (p. 4-42)." During a three-year period, 56% of people with private dental insurance had dental visits in the past 12 months and only 26% of uninsured people had dental visits during the same period, the report said. And dental benefits increase preventive care use by 19% and restorative services by about 16%.

The report challenges its readers to make dental care more accessible. Through direct corporate giving and by grants awarded through the Northeast Delta Dental Foundation, we increase access to dental services by supporting oral health programs in all three states. We also support dental loan repayment and scholarship programs for dentists and support dental auxiliary scholarship and training programs.

Oral Health Challenge 2022

Since 2011, Northeast Delta Dental and the New Hampshire Fisher Cats have jointly encouraged the early development of good oral hygiene habits in children aged 12 and younger through the Oral Health Challenge. This is important to us, because daily brushing and flossing improve oral health, benefitting overall health and wellness.

Children who complete a form showing they've brushed and flossed seven consecutive days earn two free tickets to one of four NH Fisher Cats games. Before the game, the team mascot, Fungo, guides a parade of children onto the field, where they are presented with a gift bag and a certificate honoring their consistent oral health efforts. This year, tickets may be earned to the games played on Friday, June 24, against the Altoona Curve; on Sunday, July 24, against the Portland Sea Dogs; on Friday, August 12, against the Erie SeaWolves; and Saturday, September 3, against the Portland Sea Dogs. All games are played at the Delta Dental Stadium in Manchester, New Hampshire.

Additional CDT 2022 Code and Policy Changes

As of March 22, 2022, the American Dental Association (ADA) approved additions to the CDT 2022 procedure codes, for which there are associated National and Northeast Delta Dental policies that also are effective March 22, 2022. There are seven new additional codes for procedures related to COVID-19, for which we recommend that dentists submit claims to the patient's medical carrier.

As was the case with the original eight COVID-19 vaccination procedure codes added on March 11, 2021, the ADA has incorporated these seven new COVID-19 vaccination procedure codes into the published ADA Guide to CDT's "COVID-19" Vaccination Procedure Codes. As indicated, "this guide is published to educate dentists and others in the dental community on the available CDT codes for documenting and reporting delivery of a COVID-19 vaccine within a dental practice. Please note that this guidance is evolving and the content herein was last reviewed on March 22, 2022."

The following are definitions of terms used. Denied/Deny: The procedure or service is not covered, and the approved amount is collectable from the patient. Not Billable to the Patient (NBTP): The procedure is not benefited by Delta Dental nor is it billable to the patient.

New March 22, 2022, Standardly Non-covered Codes and Standard Delta Dental Processing Policy

Non-covered codes which are denied and billable to the patient. We recommend billing these procedures to the patient's medical carrier.

- D1708 Pfizer-BioNTech COVID-19 vaccine administration third dose
- D1709 Pfizer-BioNTech COVID-19 vaccine administration booster dose
- D1710 Moderna COVID-19 vaccine administration third dose
- D1711 Moderna COVID-19 vaccine administration booster dose
- D1712 Janssen COVID-19 vaccine administration booster dose
- D1713 Pfizer-BioNTech COVID-19 vaccine administration tris-sucrose pediatric first dose
- D1714 Pfizer-BioNTech COVID-19 vaccine administration tris-sucrose pediatric second dose

Change in processing policy on existing COVID-19 vaccination procedures added in 2021.

When the American Dental Association approved the addition of the seven new COVID-19 vaccination procedure codes noted below to the CDT 2021, the standard Delta Dental processing policy for these codes was that they would be non-covered and not billable to the patient. Effective immediately, the standard Delta Dental processing policy for all non-covered COVID-19 vaccination procedure codes will be to deny.

Non-covered codes which are denied and billable to the patient. We recommend billing these procedures to the patient's medical carrier.

- D1702 Pfizer-BioNTech COVID-19 vaccine administration second dos

- D1706 AstraZeneca COVID-19 vaccine administration second dose
- D1707 Janssen COVID-19 vaccine administration

MBVS Receives Award for Maine Veterans' Dental Network

The Maine Bureau of Veterans' Services (MBVS) was recently notified by the U.S. Secretary of Veterans Affairs that it had been awarded an Abraham Lincoln Pillars of Excellence award. It's being recognized for the Maine Veterans' Dental Network (MVDN), the veterans' referral system it created in 2021. A network of participating dental clinics statewide provide dental services to veterans who cannot afford to pay for them out of pocket. Northeast Delta Dental provided funding, in 2022, with a grant of \$100,000. Receiving this award gives MBVS opportunities to share the details of how they established the network and how it functions with other state bureaus of veterans' affairs, with the hope that they will establish similar programs.
