MATERNAL AND INFANT CARE SUPPLIES

1. STATEMENT OF PURPOSE:

The State of Tennessee, Department of Health (TDH) issues this Request for Information ("RFI") for the purpose of identifying a vendor to supply maternal and infant care supplies. We appreciate your input and participation in this process.

2. BACKGROUND:

The Community Health Access and Navigation in Tennessee (CHANT) Program is a care coordination program operated out of local health departments, that provides assistance with social and health needs to pregnant women, families with children ages 0-21, and children/youth ages 0-21 with special healthcare needs. Many new and expectant parents participating in the CHANT program are in need of basic items that align with TDH objectives and messaging, such as car seats and safe sleep spaces such as a crib or pack and play.

Each year, there are approximately 80,000 live births to Tennessee resident women, and approximately half of those women are low income, utilizing TennCare insurance coverage or receiving WIC benefits during pregnancy. TDH would like to ensure CHANT program staff are able to provide new car seats (infant, toddler, and booster seats), strollers, and portable cribs with sheets (e.g., Pack n' Plays or similar) to all families in need of them. All car seats (infant, toddler, and booster seats) will adhere to the National Highway Traffic Safety Administration (NHTSA) Car Seat and Booster Seat Safety Ratings and can be found using the following link: https://www.nhtsa.gov/vehicle-safety/car-seats-and-booster-seats. Car seat safety standards are provided by the Center for Disease Control (CDC) at the following link: https://www.consumerreports.org/cro/news/2012/06/new-federal-safety-requirements-for-play-yards/index.htm. All strollers considered will adhere to the US federal standards described in: http://www.cpsc.gov/BusinessEducation. Items should be new, free of defects, and not expired or under a product recall.

Preferred vendors are:

- Based in Tennessee
- Able to provide approximately 40,000 each of car seats, strollers and portable cribs on an annual basis

- Have the ability to host regional distribution events for health department staff to obtain items two to four times per year, as well as make items available for community baby shower events. Example cities for TDH distribution events would include Jackson, Nashville, Chattanooga, Knoxville, or Memphis. Other locations may be possible based on need.
- Provide items for Community events, with locations that would be determined based on planned events.
- Have a warehouse or other storage facility located in Tennessee, where items may be picked up by health department staff as needed, outside of the regional distribution events.
