### **Executive Summary: A Blueprint for Global Progress**

In this comprehensive roadmap, we propose a strategic agenda spanning five pivotal chapters to propel global development and cooperation.

#### **Chapter I: Sustainable Development and Financing for Development**

Forge a Global Sustainable Development Fund, uniting all UN member nations, to propel sustainable initiatives across public, private, and civil sectors. Tailor contributions to economic capacity, with a focal point on schools and communities, emphasizing environmental and resource management projects.

#### **Chapter II: International Peace and Security**

Institute an early-warning system for conflict prevention, leveraging advanced technology and regional organizations. Bolster UN Peacekeeping capabilities through training and technology, while addressing root causes of instability through inclusive dialogue and reconciliation.

#### **Chapter III: Science, Technology, and Innovation and Digital Cooperation**

Establish a Global Technology Transfer Platform for sustainable knowledge exchange. Strengthen cyber security cooperation, promote ethical AI, and foster international collaboration in

emerging technologies.

#### **Chapter IV: Youth and Future Generations**

Empower youth in decision-making through platforms and councils, investing in education and skill development. Ensure youth inclusivity in Sustainable Development Goals, promoting initiatives for environmental conservation and community development.

#### **Chapter V: Transforming Global Governance**

Revitalize the United Nations Security Council, introducing diversity and transparency. Strengthen multilateralism, ensuring inclusive global governance by incorporating voices from civil society, indigenous communities, and marginalized groups.

**These recommendations** form a robust and actionable framework, heralding a new era of collaboration among Political, Private, and Civil Society entities. Success demands collective effort, steadfast commitment, and a shared vision for a sustainable and inclusive future. The proposed PACT sets the stage for transformative change at the 2024 Summit of the Future UN Conference.

### **Chapter I: Sustainable Development and Financing for Development**

#### **Establish a Global Sustainable Development Fund with the support of all the UN nations'**

**members**: Create a dedicated fund to support sustainable development initiatives led by the engagement of the public sectors, the private sectors and civil society sectors like universities, schools, foundations, and NGOs, that can present viable and effective project audit by the cooperation's among the 3 sectors. Contributions should be proportional to each country's economic capacity. Focus and investment in schools and communities should be the priority, especially focusing on educational projects for the environmental management and resources management.

**Incrementing of the carbon credit investment and developments**, from the private sector and governments by good and fast pricing for carbon, and by re investing part of the profit towards the local communities and realities via setting infrastructures like hospitals, schools, roads and in case of indigenous community identify solution that are integrating the local cultures and traditions.

**Incentivize Private Sector Engagement**: Stimulate the political establishments (1 sector) to develop tax incentives and partnerships to encourage private sector investment in sustainable projects for the communities. Establish a transparent mechanism for tracking and reporting on corporate sustainability efforts.

**Strengthen Domestic Resource Mobilization:** Encourage countries to enhance domestic revenue generation through fair taxation and anti-corruption measures. Support capacity-building programs for effective fiscal management, where taxpayers can notice and monitor that their taxes are actually being invested in real programs with social impact.

**Promotion of forums to share sustainable ideas** with the participation of the 3 sectors, an event where private companies and public authorities can think of innovative solutions to boost the sectors in a sustainable way.

**Encouraging sustainable solutions to solve problems related to lack of drinking water and sewage treatment.** Creation of intelligent and cheap mechanisms that can help the poorest countries solve simple problems such as supplying drinking water to the most vulnerable population. Promote debates about sewage treatment, so that basic sanitation problems and diseases can be avoided.

**Promote the encouragement of government laws** that prioritize the purchase of products or services that adopt sustainable and environmental practices. Establish incentive policies, such as preferential parking for electric vehicles, less taxes for bicycles, electric cars and other sustainable means of transport.

**Mapping drug cultivation areas and offering sustainable and economic alternatives for local communities,** in addition to bringing security and reducing addictions, it also brings financial support.

## **Chapter II: International Peace and Security**

**Promote Conflict Prevention and Resolution:** Establish an early-warning system (preventions) for potential conflicts, utilizing advanced technology and intelligence networks. Strengthen the role of regional organizations in conflict resolution, prioritizing prevention programs, and initiative to action plan involving the 3 sectors of society, in unstable regions and area of conflicts. Promote cultural exchange among different ethnic groups, especially involving women, teenagers, and children. Promote permanent spaces for different groups to lecture about their cultural backgrounds at schools. Promote spaces for intercultural dialogue at public places, considering that peace starts at home, at schools and at the neighbors.

**Enhance UN Peacekeeping Capabilities:** Invest in training and technology for peacekeeping forces. Establish a rapid-response mechanism to address emerging crises promptly in order to build UN credibility and efforts.

**Address the Root Causes of Instability:** Implement comprehensive strategies to address poverty, inequality, and human rights abuses as root causes of conflict. Foster inclusive dialogue and reconciliation processes in post-conflict societies by capacity building and with hands-one projects engaging the local needs and reality.

**Improve or strengthen UN bases in areas of conflict:** UN bases that are well located and with good physical and human structure enable faster responses to avoid conflicts or at least mitigate the results of a conflict. The UN bases also allow people to be close to the location of the conflict, so they can better understand the source of this conflict, resulting in better dialogue for an agreement between the conflicting parties.

**Encourage countries to create internal laws to control the entry and exit of weapons,** also create a system for the government to regulate the weapons that its citizens possess, being able to avoid small local attackers or a group with the purpose of terrorism.

### **Chapter III: Science, Technology, and Innovation and Digital Cooperation.**

**Create a Global Technology Transfer Platform:** Facilitate the exchange of sustainable technologies and expertise between developed and developing nations. Establish a mechanism for intellectual property sharing in critical areas like healthcare and climate adaptation. Establish partnerships among teachers and other experts from different countries. Create an international network to promote local-impact projects involving youth.

**Enhance Cyber security Cooperation:** Develop a global framework for cyber security standards and information-sharing. Strengthen international cooperation in combating cyber threats and attacks.

**Promote Ethical AI and Emerging Technologies:** Establish international guidelines for the ethical development and use of artificial intelligence. Encourage collaboration between governments, industries, and academia to ensure responsible innovation.

**Encourage technologies with a focus on the environment:** Promote technology programs to protect the environment. Technology tools that can locate deforestation, forest fires and illegal mining.

**Regulation and protection of personal data:** Encourage countries to create internal laws aimed at protecting citizens' data, preventing hacker attacks, data sales and misuse by people in bad

faith.

**The use of block chain for humanitarian aid** that makes donations and distribution of resources more transparent.

## **Chapter IV: Youth and Future Generations**

**Integrate Youth in Decision-Making:** Create and promote platforms for meaningful youth participation in policy development and decision-making processes. Engage teachers and students to respond to pivotal challenges in their local, national, and international realities by establishing youth councils at local, national and international levels with real powers for actions and intervention faraway from ideological standings or ism's.

**Invest in Education and Skill Development:** Increase investment in quality education and professional qualification to prepare youth and teachers for the rapidly evolving social reality. Promote digital literacy and STEAM (Science, Technology, Engineering, Arts, and Mathematics) education and emphasize the needs for education transformation focused on character building, cooperation, leadership, social agency, duties and rights achievements. Clear needs to transform education, from the curriculum parameters of the last 300 years social settings, to the reality of the modern world and dynamics, by changing the focus from knowledge applications to character developments.

**Ensure Youth Inclusivity in Sustainable Development Goals:** Develop youth-centric indicators for monitoring and evaluating progress on Sustainable Development Goals. Encourage youth-led initiatives for environmental conservation and community development coordinated by educational institutions, NGO's, and local government. Promote youth-led public debates over environmental and social topics in order to address how to overcome local challenges.

**Promote the psychological health of young people in the workplace** with the aim of avoiding emotional exhaustion resulting from work, which can lead to illnesses such as depression, stress or even suicide, thus helping the health of civil society.

**Promote and encourage programs aimed at environmental protection mechanisms or risk mitigation in nature,** so that the young population does not suffer so many consequences in the future.

**Inclusion in young people's curriculum of social skills** such as empathy, education, respect, responsibility, collaboration, teamwork and protection of the weakest.

**Planning sustainable and technological cities:** Promoting the creation of futuristic cities that are self-sustainable for future generations, with public transport and sustainable energy, and also green spaces.

## **Chapter V: Transforming Global Governance**

**Reform the United Nations Security Council:** Expand the Security Council to include more diverse and representative members based upon today geopolitical, economical and continental's reality and not based upon the WW2 references. Introduce mechanisms for greater accountability and transparency in decision-making.

**Strengthen Multilateralism:** Reinforce the importance of multilateralism in addressing global challenges. Enhance coordination between UN agencies, regional organizations, and other stakeholders.

**Promote Inclusive Global Governance:** Ensure the inclusion of voices from civil society, indigenous communities, and marginalized groups in global governance structures. Establish mechanisms for regular public consultations on major global decisions. These recommendations form a comprehensive and actionable framework to advance the objectives outlined in the 2024 Summit of the Future UN Conference, by setting a real PACT between Political, Private and Civil Society cooperation's (3 powers). Implementation will require collaborative efforts, unwavering commitment, and a shared vision for a sustainable and inclusive future.

### **Creation of a punitive council for UN members who encourage and promote wars.**

The punitive council will be responsible for establishing severe sanctions on member countries found guilty of war crimes at the International Criminal Court.

**Creation of a transparency portal** for resources received by the UN, where members, civil society and the private sector can see where and for what purpose the money is being used.

### **Creation of a reporting portal against international trafficking in women, children and organs.**
